### Washington Letter

Special Correspondence from the Capital of the Nation.

WASHINGTON, D. C., Nov. 24, 1902.

There is probably no more perplexed man in Washington today than President Roosevelt. After yielding his own convictions, that the tariff ought to be revised, and accepting the dictum of Senator Hanna and his school of politicians, that the winning policy for the republican party was to "stand pat," after being assured that if he wanted to be elected in 1904 he must not countenance revision, the President is now receiving the assurances of the western members and senators that the only hope of the party in their section of the country, lies in making good the pledges of the last campaign, that the tariff would be "revised by its friends." In hope of gaining a clearer insight into the situation the President has appealed to the members of his Cabinet and to the republican leaders. There is no doubt amongst the eastern members who all say "stand pat," but Secretary Wilson, for instance, says his state wants revision. Representative Babcock insists on an extra session called for that purpose exclusively and the Minnesota delegation say that they were elected on a tariff reform platform. The same is true of Idaho and other western states which were carried for the republican party only by the personal popularity of the President and the assurance that he would insist on a revision of the tariff which would curtail the inordinate profits of the trusts.

The argument advanced by the "stand paters" is that the present prosperity cannot last, that tariff

revision will precipitate the reversal of present conditions and that if the republican party is caught in the midst of an attempt to revise the tariff, which will be inevitably attended by endless personal bickering and strife, the country will administer a prompt rebuke by voting for their opponents. As a sample of the kind of advice proffered the President by his friends was recently afforded by Senators Lodge and Burrows. The former signified his willingness to ratify the Cuban treaty because it would not injure his constituents who raise neither tobacco nor beet sugar, but be protested vigorously against the New Foundland treaty because it might hurt some of the fishermen of his section. On the other hand, Senator Burrows expressed his willingness to vote for the new New Foundland treaty but protested against the Cuban treaty. The fact that the tariff is a local issue is again being demonstrated together with the fact that no republican is willing to sacrifice one cent of protection to the interests of his own section for the benefit of the country at large. The President has held open his message, hoping to be able to judge which will be the more politic course for him to pursue, after he has conferred with the senators and representatives who have been invited to call on him this week.

There will hereafter be many independent voters in this state, yet if the democrats would resort to argument instead of appealing to prejudice there is no reason why this vote should be lost entirely to the party. To put it straight, many of these people have nothing against the party but have become tired listening to the stuff dished up as democratic doctrine.—Durham Herald.

### THE TEACHER IN THE SCHOOL ROOM

[Essay read by Miss Annie Perkins before the Pitt County Teachers' Association.]

There is probably no profession in the world whose duties are so manifold as those of the teacher. There is an end to most others—to his there is none. In enumerating the many duties of the teacher, we find first the duties to himself—and all through this paper when we use himself we mean herself as well. Among the many duties the teacher owes to himself are thorough preparation, culture, dignity, and yet ease. He must also possess tact, talent, firmness, and at the same time moderation. He must be endowed with aptness to please and work always bearing in mind his own preservation.

Then the teacher has duties to his pupils, not only in the school room and on the play ground, but in the world at large. As "education is the development of the whole man" these duties must necessarily include the social, moral and religious duties also. Then comes the duties which the teacher owes to his own state, embracing loyalty, patriotism and obedience to law. He must be, as well as teach, these. The school is an institution as well as the state. The school to the child is really what the state is to the man. It is often in the school the child obtains his first duty, loyalty and reverence he owes his own state and country.

Not only has the teacher social, moral and religious duties to the parents, but there are certain other relations and duties due the parents, as those to whom the children are committed for five-sevenths of the time during school sessions. For it is every teacher's duty not only to be teacher, but example, guide and even parent for the time being.

And last, by no means least, he has duties to parents in what is nominally in our subject, "The Teacher in the Home." It is this special feature of the many duties of the teacher we are concerned with today, and which we are to discuss. Time forbids a fuller discussion of the subject than under the following heads:

1st. His duty to know the home.

2nd. His duty in the home under ordinary circumstances.

3rd. His duty in the home under extraordinary circumstances.

1st. His duty to know the home. Many teachers have not the faintest conception of the homes whose children they are teaching. Under these conditions their work must be a complete failure. The one foundation object of the teacher should be to lead the child out of ignorance into knowledge, and this cannot be done if one be ignorant of the home life of the child. Total ignorance of the home life is total ignorance of the child itself. A thorough knowledge of the home is necessary for the proper management of the child. A thorough acquaintance with the child's previous training, his temperaments and peculiarities, will enable one to understand and explain many questionable acts, and motives of school life which we could not interpret or understand without this knowledge—how shall we know the home?

1. By going into them, thereby coming in personal contact with each and every member of the family. It is quite true their homes may not be like yours, but your duty is to go no matter how humble the home or how burdensome the duty—and these duties are

sometimes burdensome. Many children come to us from homes in which the ruling principles are very low. Perhaps the teacher is the first and only person, with whom the child comes in contact, who possesses characteristics and qualities that lead him to realize there are higher ideals than those of his home. (2) By confidential relations to father and mother. It takes much time and much more tact to learn the ruling principles of the home, but it must be done. The teacher who succeeds in this undertaking will undoubtedly succeed in most others.

Secondly, "duties in the home under ordinary circumstances." (1.) Be socially clever in the home. A frank confidence is needed for the sake of the child. Explain your school room work and let the parent know you are interested in the child. Be frank, be honest, if unpleasant facts have to be stated do so in a pleasant manner. (2.) Be exemplar in character, word, and manner, thereby inspiring respect and even love. (3.) Never fail to be ready with a kind word and to give praise when it can be honestly done. (3.) Embrace every opportunity to inspire ambition in the home for the success of the child, and thus incite the parent to help correct and commend their children for proper conduct and study, or criticise the contrary. Let the parents know you need and want their hearty co-operation. Also impress upon them the fact that it will be a great help to both you and the child.

Thirdly, there comes also extraordinary conditions in families, such as sickness of children or parent. What are the duties of the teacher then? (1.) Always enquire after the sick ones. (2.) Offer assistance in every way possible, and in such a manner they will not hesitate to call on you if assistance is needed. (3.) Increase your visits. Be sympathetic. Do not hesitate to express this sympathy; people need more than for you to feel sympathetic, they need you to talk and act thus. Make your visits to the afflicted ones so cheerful and bright that they will look forward to your coming with an expectant pleasure.

These duties may seem to be many and some of them onerous, but to succeed in the fullest sense the teacher needs to thus be and act. The farther you are removed from culture and good social conditions the more you need to exercise yourself in these things, without which a teacher never reaches the possibilities which lie out before him in his profession.

Let me not only ask but urge all teachers present, that they cultivate these graces and qualities more fully in the future than they have in the past. In making our daily programs let us include sometime to be used in visiting the homes, even if the amount of time be very short each day, we may accomplish a great deal if this amount be rightly used. Only those who have tried this plan can estimate its worth. Not only will it prove a help to the teacher and child, but the world demands and is looking for the teacher whose power is shown in sympathy and love. This sympathy must include the parents as well as the child. Let us each not be wanting in any of the qualities and duties that are for the furtherance and betterment of our profession. For in the advancement of our professions has the advancement of state, county and all man kind.

That Fayetteville murderer is not out of it but it is easy to guess how it will terminate, as it is impossible down here to hang anybody that is anybody, says the Durham Herald. Doesn't the Herald believe in the "survival of the fittest?"

The attitude of the parties before the strike commission is full of suggestion to the sympathizer on either side, and at least amusing to the indifferent observer. That somebody has been staking heavily on a bluff may not be surprising to knowing ones, but that the matter should have been allowed to proceed so far with the present situation in sight the ordinary player would hardly have expected. It was a big game and interesting; and not the least instructive feature of it is the prominence of "the heathen Chinese." The public would like to see the cards.

It has been decided to hold the next trial of Wilcox at Hertford. The Judge is reported to have said that he had found the people of Perquimans opposed to capital punishment, and that he regarded the fact as a favorable circumstance for the defendant. But the prisoner's family, the report continues, regret the removal of the trial to that county, "knowing the bitter anti-Wilcox feeling that exists there." One is inclined to wonder what county the Judge could have selected where the public sentiment was against capital punishment and in other respects of such a nature as to assure the acquittal of the defendant, under any circumstances. ### THE BIRTH OF THANKSGIVING DAY.

To properly appreciate the spirit of the American institution known as Thanksgiving day, it were well that we go back to its origin among the granite hills of New England, in the dark days of colonial settlement.

Thanksgiving day was literally born of man's recognition of the necessity of divine protection and mercy. Who can imagine the prosperous, golden American of today originating such a ceremony as thanksgiving to God?

Surrounded by treacherous, savage foes, exiled in the primeval wilderness of a foreign land, the New Englander of the colonial period was made to feel his dependence upon divine Providence in a way that we of civilization cannot know except in special instances. The pilgrim saw himself "cut off from the land that bore him, betrayed by the land he found." He slept in the fear of death, and prayed devoutly while he expected to feel the sting of the savage arrow. He went to church with his Bible in one hand and his gun in the other, and generally found it healthy to shoot, first and preach afterwards. Amid such hardships as we can scarcely conceive, his dependence upon the mercy of God was borne upon him in a way that for such mercies as we would consider misfortunes he gave thanks to God.

The first Thanksgiving day which was observed in America was after the first harvest in the colony of Plymouth, in November, 1621. Governor Bradford issued the first Thanksgiving proclamation, after having sent men out to hunt wild fowls for the feast. From this time until shortly after the revolution there was annual observance of the day in the colonies. At the close of the war the custom seems to have fallen into disuse, probably owing to the wave of skepticism which swept over the country about this time. The custom was revived, however, in 1789, when President Washington recommended a day of thanksgiving for the adoption of the federal constitution. Since then the annual observance of the last Thursday in November as a National Thanksgiving day has become an established custom, and will probably last as long as the nation itself—certainly until we forget the God who made us great.

#### Beggars in Trouble.

For several days a woman and a little girl have been soliciting alms on the street here. They are members of the family of Frank Lewis, and have been occupying a house on Washington street, between second and third. A lively rumpus in that quarter, Monday night attracted the attention of Capt Smith and policeman Dudley who found Lewis and wife drunk Mrs. Lewis being down and her husband beating her. Lewis was arrested for being drunk and disorderly. He is not known to have any occupation. The man and the woman are said to be able to work. It would be an act of charity to get their little girl into better company, if that can be done.


The old holly trees which are so abundant on the woodlands in this section, and for which there is no use except for Christmas trees during the holidays, have turned out to be valuable property that furnishes employment to a number of people. The branches of the trees, loaded with red berries and green leaves, are cut off and shipped by the car load to Northern cities and sold at a good price for decoration purposes, for which they are splendidly adapted. Numbers of people are now engaged in cutting these branches from the trees while others find employment in making boxes in which to pack the branches. Several car loads have already been shipped from this section and new recruits are being added to the number already in the business. No one will suffer from the slaughter of holly trees except the robbers, which bird depends mostly upon holly berries for winter food.—Goldboro Argus.
