It was soon after the Eagle Hotel was opened that a mysterious-looking stranger entered the office one day and paid for two days entertainment in advance, ordered his meals sent him, and at his request was shown to a room immediately. ### THE LEGISLATURE.

SIXTH DAY—SENATE

Having to unite with the house in counting the state votes, the senate again held a short session. No new bills were introduced, but some matters already up were given second and third readings.

Senator Blow's bill for indexing executors, administrators and guardians brought out some discussion and was carried over to another day for final reading.

HOUSE

In the house several new bills were introduced, but all of them were of a local nature and of not much importance. The speaker announced the committees of the house. Representative Little, of Pitt, was appointed on the committee on Agriculture and on Engrossed Bills, while Representative King was appointed on committee on Health and on Marcolled Bills.

In the Smith township, Duplin county, public school, two boys became engaged in a fight in school hours and the teacher, Miss Lucy Smith, as a means of correction, ordered them to continue until they were satisfied, and one of the boys had stripes left on his body as a result. Suit was brought against Miss Smith, the teacher, and has created more or less of a sensation in the neighborhood. There has been four trial before justices of the peace without resulting in a decision. There will be another trial with legal counsel for both sides.—Kinston Free Press.

**An Awful Earthquake.**

**Sing on the Wing.**  
Besides the skylark, a number of other birds sing as they fly. Among these are the titlark, wood lark, water pipit, sedge warbler, willow warbler and whinchat.

**Beetle Strength.**  
A beetle one-third the size of a horse would be able to pull against more than a dozen horses.

**Plucking Fowls.**  
If you are hurried in the plucking of a fowl, place the bird in a bucket of boiling water and let it remain there a couple of minutes. Then you will find that the feathers will come off quite easily.

**Forest Fires.**  
Fires caused by lightning are frequent in the immense forest belt stretching across northern Canada from the Atlantic to Alaska. The abundant pitch feeds the flames, and these fires have been known to travel at the rate of fifteen miles an hour.

**Ancestors.**  
Ten generations back the ancestors of each person now alive numbered 1,024; twenty generations back, or 600 years, they numbered 1,048,576.

**Torchlights in China.**  
When Chinese boys have a torch light procession, they carry fishskins for lanterns. The skins are dried and beautifully painted. Inside of them there is placed a candle or a small oil lamp. These lanterns are prettier than ours.

**Spanish Field Laborers.**  
Field laborers in Spain rarely get more than 10 cents a day. Their sole food is a soup made of oil, water, garlic and bread. Many cannot endure twelve to fourteen hours of hard work in the broiling sun on such fare and faint in the fields. About 5 per cent of them die annually.
