## TO AMEND TOWN CHARTER

Text of Bill to go to  
Legislature this  
Week.

The General Assembly of North Carolina do enact:

Section 1. That Chapter 115 of the Private Laws of 1899, it being an act entitled, "An Act to amend and consolidate the Charter of the Town of Greenville," be, and the same is hereby amended in the following sections and particulars to wit: Strike out section two of said act and insert in lieu thereof the following as section two:

That from and after the passage of this act the corporate limits of said town shall be as follows:

Beginning on the Tar river where the branch on the east side of the town as located at the passage of this act empties into Tar river, and thence running up said branch to the point where it crosses the old road leading from Greenville to Green's mill pond; thence southwardly along the west side of said road to L. C. Arthur's (Patrick) line; thence with L. C. Arthur's line and the south side of Twelfth street a westerly direction to a point fifty feet from L. C. Arthur's and F. M. Hodges' corner; then due south one hundred feet to a stake; then due west to L. C. Arthur's and F. M. Hodges' line, then with L. C. Arthur's line the various courses thereof to Town branch, then up said Town branch to the eastern line of the Atlantic Coast Line Railroad company's right of way; then a northerly di-

rection with the eastern line of the said right of way to the southwest corner of the lot now owned by the Greenville Manufacturing company; thence an easterly direction with the line of said lot to the southeast corner thereof; then a northerly direction with the line of said lot to the southern line of Twelfth street; then a westwardly direction with the southern line of Twelfth street to the eastern boundary line of the Atlantic Coast Line Railroad company's right of way; then a straight line to the south-east corner of R. M. Moye's lot (the lot upon which said R. M. Moye now resides); then with his line westwardly to the south-west corner of his said lot; then with the line of his said lot in a northerly direction to the old plank road; then a straight line across the old plank road to the south-west corner of the colored public school building; thence with the line of said lot (so as to include said colored public school building) to the north-west corner of said lot; then due north to the northern line of the river road; then with the northern line of said river road an eastwardly direction to Josiah Dixon and J. B. Cherry's corner; then with said J. B. Cherry's, Josiah Dixon's B. H. Allen's and S. W. Andrews' line to Tar River; then down Tar river to the beginning.

Section 2. That section four of said act be amended by striking out all after the word proportion in lines three and four of said section and inserting in lieu thereof the following: "That is to say that each ward shall be entitled to two Aldermen, who shall hold office for two years, but that only one Alderman shall be elected each year for each ward. That in order to put this provision in operation Alderman D. S. Spain, of the first ward, Alderman E. B. Ficklen, of the second ward, Alderman B. F. Tyson, of the third ward, and Alderman W. B. Parker, of the fourth ward, shall continue to hold over under their present tenure

till the first day of July, 1904. That beginning with the election of Aldermen in 1903 only one Alderman shall be elected in each ward and only one Alderman each year thereafter in each of said wards.

Section 3. That the whole of section five of said act be stricken out and the following inserted in lieu thereof, to wit: That the said town is hereby divided into four wards, whose limits and boundaries shall be as follows:

The first ward shall be composed of all that part of the territory of said town which lies north of the centre of Third street, extending from the eastern to the western boundaries of the said town.

The second ward shall be composed of all that part of the territory of said town which lies between Third and Fifth streets, extended from the eastern to the western boundaries of said town.

The third ward shall consist of all that part of the territory of the said town which lies between Fifth street and Dickinson avenue, extended from their junction to the western boundary of said town.

The fourth ward shall consist of all that part of the territory of said town which lies south of the second and third ward, and which is not embraced in either.

Section 4. Amend section ten of said act by adding to the end thereof the following words: And if in the election of said officers the Board of Aldermen shall be equally divided, then in that case the Mayor shall give the deciding vote and the person so chosen shall be declared duly elected and entitled to hold such office.

Section 5. Amend section seven, sub-section two, of said act by inserting between the words "subjects," in line thirty-four of said sub-section, and the word "taxed" in line thirty-five, the words, "not forbidden to be."

Section 6. Amend section twenty-two of said act by striking out the word "one" in line nine of said section and inserting in lieu there-

of the word "three."

Section 7. That this act shall be in force from and after its ratification.

### REFORM NEEDED AT DEPOT

No Waiting-Room Fit for a Lady to Enter

Anyone who frequently goes to the depot and waits around there indefinitely for belated trains, will be impressed with the inadequacy of the accommodations there for the public. The depot has two waiting rooms, one for white people and one for colored. It is of the room for white people that we want to speak. In this one room all classes of people have to gather—men and women, high and low, the respectable and the disreputable, sober and drunk, all in this one little place. Ladies having to wait for the train are often forced to endure the most disagreeable surroundings. It is no uncommon thing to see a class of men in this waiting room who are smoking, spitting on the floor, cursing, and sometimes so drunk as to be vomiting. This is not a nice picture to draw, but it is nevertheless true, and ladies should not be subjected to such indecency. By all means there should be a waiting room exclusively for ladies where they can be protected from such surroundings. This suggestion ought to be sufficient to cause the railroad to provide the necessary accommodations as early as possible.

By Spence, of Moore: To facilitate the taking of depositions in the state in aid of a suit with out the state.

By Norris, of Wake: To amend chapter 750, Laws of 1901, To give permission to police officers to serve notices appointing registrars for city and town elections.

By Welburn, of Ashe: To allow bastard children to represent their ancestors on their mother's side.

By Spence, of Moore: A bill for the employment of stenographers for the courts. This gives a judge the right to engage one when necessary.

By Henderson, of Rowan. To provide a proper system of heating and ventilating the state Capitol.

#### HOUSE-FRIDAY.

Carlton, of Duplin: To extend time for allotting homestead.

Fuller, of Durham: To protect water supplies.

Abell, of Johnston: To punish seduction and abduction of married women.

Lucas, of Hyde: To promote and protect fish industry in North Carolina waters.

General Carr and Colonel Bryan have something in common at last.

Of course the Durham depot argument wouldn't be complete without a newspaper wrangle.

There may be such a thing as a glorious failure, but the glory probably comes in beyond the skies.

One thing about a senatorial primary is that it would not furnish so many patriotic withdrawals for the good of the party.

As a proselyter Governor Aycock is not at all bashful. He is now trying to induce Governor Terrell, of Georgia to "go thou and do likewise."

It doesn't make any difference to us if Congress seizes the coal mines, as we can get along without coal. But there are lots of other democrats who would freeze to death if a republican majority controlled the coal mines.

The petitions that are being circulated asking the legislature to pass the bill introduced by Senator H. A. London, ought to be signed by every person who wants to see the whiskey saloons in North Carolina closed. There are four important features in this bill that commend it strongly to those opposed to the great evil of intemperance. One provision is that no liquors shall be sold except in incorporated towns of 500 or more population. Another provision is that no liquors shall be manufactured except in incorporated towns of 1000 or more population.

Another section provides that any county or section wanting to vote on the question of having prohibition or a dispensary can do so by one-third of the voters of such county or section petitioning the county commissioners for such election, but such elections cannot be held oftener than once in two years.

The other important provision of the bill is that in all towns where liquors are permitted to be sold after the 1st of July, 1903, all applicants for license must file their application with the Board of Aldermen thirty days in advance, such application must have the signatures of a majority of the qualified voters of the town, and is subject to public inspection.

Under this bill liquors can be sold only in incorporated towns of 500 or more and only in such towns where a majority of the voters want it sold. Such strong petitions should go to the Legislature as will secure the passage of the bill.

Pecan Hunts in Kentucky.

In the Kentucky bottom lands along the lower Ohio and its tributaries the apple orchards and "sugar bush" are things of tradition, says the Indianapolis News. Their places have been taken by the pecan, which yields a much greater revenue. The pecan orchard is usually distributed throughout one of those immense cornfields of several hundred acres that formed the antebellum plantations. Here they are enriched by constant cultivation as well as by the fertilizer from the overflow of the Ohio that occurs always once and frequently oftener a season. The pecan season opens special festivities. Society in the neighboring towns and cities takes it up most enthusiastically with pecan "tours," picnics, dinners—in truth, all varieties of fetes that such ingenuity can originate. The right to gather the nuts is purchased and a professional climber hired. A woods dinner is the most pleasing feature of the occasion—bacon, chicken, broiled on a spit before a fragrant fire; Irish potatoes and the real, old fashioned red sweets, onions baked in a crater of hot coals, kimmel rye bread, roasted cheese, gingerbread and crabapple cider from the farmhouse.

Three Curious Words.

Filibuster, freebooter and buccaneer are words curiously interrelated. The French and the English sea adventurers once made common cause against Spanish settlements in the new world, and all three of these words came in time to describe the rude sea soldiers who despoiled the Spanish main and the towns upon the coasts of the Spanish possessions. Filibuster is said to be the result of an attempt to make a French word of freebooter, and the English borrowed it back from the French because it sounded less frankly brutal than the English word.

Buccaneer was originally French in form, and it meant at first one who hunted the boucan or wild cattle and hogs of the West Indies; then one who made jerked meat of their flesh, and finally, because this meat was used to provision the ships of the sea rovers, a filibuster or freebooter.

Hunting the Wild Boar.

In Germany the boar hunt occurs annually. Trained hounds are held in leash until the lair of the boars is sniffed, and then they are let go. Off rush the bristling beasts. They run fast, and the faster they skip along the wilder and "madder" they get. Sometimes they are shot, but the correct style of killing is to use a long spear or a short swordlike knife. The hunter spies his boarship speeding along in an almost straight line, blinded with rage and ferocity. Bending over sideways to the earth, the sportsman thrusts his spear dull end downward in the soil and the sharp point slanting upward and turned directly to the boar's path. Straight on the wild hog rushes, and with all the impetus of his long fight he plunges upon the spear point and there, impaled, dies a bloody death.

"Ich Dien" or "Eich Dyn."

"Ich dien," the motto which belongs to the Prince of Wales, is usually translated "I serve," and tradition has it that it was taken by the Black Prince from the royal helmet of the blind king of Bohemia, who was killed on the field of Creecy. It is a notable fact, however, that the late Dr. William Ihne, professor of English literature at Heidelberg, rejected this theory. He held that the motto was of Welsh origin and took its rise at the time when Edward I. presented his newborn eldest son to the Welsh chieftains at Carnarban castle as their future sovereign. He held the child up in his arms and exclaimed in Welsh, "Ich dyn," meaning "this is your man." The explanation is accepted by many antiquarians.

Hats in London.

No stranger can do business in London without a silk hat. It is the style from Monday to Saturday to wear this kind of head covering, with a frock coat, and on Sunday to appear in a "boulder" (the conventional derby) and a sack. Cutaways are much worn with silk hats, and not infrequently dressy men are seen in the outlandish combination of silk hat and sack.—New York Press.

How Ships are Named.

French ships are usually named after French provinces or towns, victories, ideas or sentiments, but no French names, excepting those of great men in their history, are made use of. German ships bear the names of German rivers, ports, poets, states and characters in German literature. Spanish ships are almost invariably named after their cities or great commanders.
