## TO VOTE ON BOND QUESTION.

Greenville Will Again Try to Get in the Procession.

The General Assembly of North Carolina do enact:

Section 1. That the Town of Greenville is hereby authorized and empowered to issue, in its name, sixty-five thousand dollars of interest bearing Coupon Bonds for the purposes and in the manner hereinafter set out, if a majority of the qualified voters of said Town shall vote in favor of issuing such Bonds at an election to be held as hereinafter provided.

Section 2. That the question of issuing said Bonds shall first be submitted to the qualified voters of said Town at a special election to be held for that purpose on the First Tuesday in April, 1903, which election shall be conducted under the general election laws of this State for Aldermen of said Town, except as modified by this Act. The Board of Aldermen of said Town shall at a meeting held on or before the First Thursday in March, 1903, appoint a registrar and two judges of election for each of the wards of said Town as the same may be then constituted. And the Board of Aldermen shall cause to be procured or prepared proper registration and Poll Book for the registration of voters and the proper conduct of said election, which registration and Poll Books shall be kept and used as the election records of said Board. And as

there has been no registration for a Town election since the new suffrage laws went into operation, and for the purpose of ascertaining the true sense of the legal voters of said Town on the question of issuing Bonds as provided for in this act, it is ordered that the Aldermen of said Town provide for an entirely new registration of the qualified voters thereof. The Mayor shall, at least twenty days before the election, issue his proclamation giving notice of said election and designating thereon the persons chosen to conduct the same and the exact place in each ward where it is to be held. It shall be the duty of the registrar in each ward to register all persons entitled by law to be registered as a voter in said ward, and this he may do for convenience at his own home or at any other place in said town, but it shall be the duty of the registrar in each ward to attend with his registration book at the place designated by the mayor in his proclamation on Thursday, Friday and Saturday next preceding the election from two o'clock to sunset each day for the purpose of registering all persons entitled to register and who have not been registered. And it shall be the duty of judges of election to attend with the registrar in their respective wards on Saturday preceding the election for the purpose of hearing and determining all contests and challenges as to registration. The registration books shall be open to inspection at all times and they shall be finally closed at sunset on the Saturday immediately preceding the election. If any vacancy shall occur at any time for any cause in the position of registrar or judges of election for said election, it shall be reported to the mayor, who shall immediately fill the same. The polls shall be opened at eight o'clock a. m. on said First Tuesday in April, 1903, and shall be closed at six o'clock p. m. on said day, and all persons whose names are found on the registration books shall be entitled to vote

at said election for or against issuing said bonds. Those desiring to vote for it shall vote a written or printed ticket on which shall be written or printed the words "For Bonds," and those desiring to vote against it shall vote a written or printed ticket on which shall be written or printed the words "Against Bonds." The registrar and judges of election shall immediately after the closing of the polls count the votes cast and shall make and sign duplicate returns thereof and which shall be sealed up and delivered as follows: One sealed copy shall be delivered to the Clerk of the Board of Aldermen, together with the registration and poll books, and one copy to the mayor. The Mayor and Board of Aldermen shall meet at eight o'clock on Thursday next immediately succeeding said election at their usual place of meeting and in the presence of such persons as choose to attend, proceed to open and count said returns, and if all the returns are in, they shall make and publish an official announcement of the result of said election, in which they shall certify to the whole number of registered votes, the number cast for and the number against said proposition. If for any cause the returns have not been made the board, before making and declaring the result, shall procure and compel such returns. The mayor shall, after the result has been declared by the Board, issue his proclamation repeating said result.

Section 3. That if a majority of the qualified voters of said Town as ascertained by said registration and election shall vote "For Bonds" then the Mayor and Board of Aldermen of said Town are authorized and directed to cause to be prepared interest bearing coupon bonds to an amount not to exceed sixty five thousand dollars. Said Bonds shall be of the denomination of five hundred dollars each and shall run for thirty years and shall bear interest at such rate as

may be fixed therein not to exceed five per cent. per annum. The interest on said Bonds be payable semi-annually on the first days of January and July of each and every year. The said Bonds shall be signed by the Mayor and Clerk as they are issued and delivered as herein provided.

Section 4. That said Bonds after being signed by the mayor and clerk shall be issued and delivered from time to time to the Board of Internal Improvements hereinafter provided for in blocks or as a whole as they may be called for, but the entire amount so issued and delivered shall not exceed in the aggregate the sum of sixty-five thousand dollars.

Section 5. That said Bonds shall be numbered consecutively from one to one hundred and thirty, and the Board of Aldermen shall keep a record of the number signed and delivered to the Board of Internal Improvements with the date of their delivery and the Board of Internal Improvements shall keep a record of the sale of each bond, to whom sold and the amount paid, which shall be reported to the Board of Aldermen to be filed and recorded by said Board.

### THE EXTRA TRAIN

Greenville to Have Better Transportation Facilities.

Capt. W. H. Newell, of Norfolk, Superintendent of the Atlantic Coast Line for this district, was here Monday. He called to see THE REFLECTOR relative to the petitions sent the company in December for a double passenger train service over this branch of the Coast Line.

Capt. Newell said his company realized the trouble and delay caused by the heavy traffic of the past fall, that the spirit of the petition sent was appreciated, and that all possible would be done to remedy this trouble. He said the suggestion in THE REFLECTOR (which was endorsed by the Tobacco Board of trade and on which the petitions were based) that another train leave Weldon early in the morning, go through to Kinston and return in the evening, making connection both ways with all trains at Parmele, he thought would be adopted, and while he could not say at present just when this will go into effect, it will be done as soon as practicable.

Of course changes and increased facilities cannot be inaugurated at once, for all are aware that the immense traffic of the last few months has taxed the railroad to their full capacity, and to get on more trains means that more rolling stock and equipment must be provided. For this reason the joint petitions sent from Greenville, Winterville, Ayden, and Grifton asked the Coast Line to take the suggestions under consideration and do the best possible to relieve the situation. The assurance that comes through Capt. Newell is indeed gratifying, and the petitioners can afford to be patient with the improvements in transportation facilities are inaugurated.

The latest objection to the anti-liquor legislation and to the Watts bill in particular, comes from the town of Brevard, through the news columns of the Asheville Citizen. The Citizen's correspondent writes:

This bill would be a drawback to this county. We have but one registered distillery in the county of any note, situated about 2 miles from this place. The proprietor has spent much money getting this plant in operation, being operated by steam; and it would work a very great hardship to the owner to now tear up and come to town if by vote this proposition should carry. No violations of the law have been heard of at this distillery. It furnishes a cash market for all the surplus grain raised in the county, and we think that if this bill as introduced should become a law, that each county should be governed by circumstances, and left out or included in this bill, as the circumstances seem best for the people generally.

The people of any community ought to be ashamed to admit they depend upon the manufacture of whiskey for the sale of products of the soil. If they can't do anything else with their corn, let them send it to the poor of the large cities who are starving, and many of them are starving because corn has been sent to them in the shape of liquor instead of bread.

**Terme.**

It is truly surprising what erroneous ideas are entertained by the general public concerning the true meaning of many terms in general use. A striking example of this is the word "terne" as applied to tin plate. Usually it is understood that this word is derived from the French one, meaning "dull." This is totally incorrect. Terme plate is a sheet or plate of iron and steel covered with an alloy of tin and lead in the proportion of two-thirds lead and one-third tin. It is this union of the three metals—iron, lead and tin—that gave rise to the word terme plate, terme being an equivalent to the English terme, meaning "threefold." The origin of the erroneous definition of this term was the fact that because of the large percentage of lead used in coating terme plates it is duller in hue than the ordinary tin plate, which is frequently designated "bright plate" in contradistinction to the former.


