THE GRADED SCHOOL BILL

The General Assembly of North Carolina do enact:

Section 1. That there shall be an election held in the Town of Greenville on the First Tuesday in April, 1903, for the purpose of taking the sense of the qualified voters of said Town on the question of establishing and maintaining a Graded School therein for each race and issuing Coupon Bonds to the amount of ten thousand dollars for the purchase of sites, erection, repair and equipment of the necessary buildings therefor.

Section 2. That said election shall be held at the same time and place as the election is held which is authorized by an Act passed at this Session of the General Assembly for the purpose of taking the sense of the voters of said Town on the question of issuing coupon bonds to the amount of sixty-five thousand dollars for the purpose of constructing and installing a system of electric lights, water works, and other improvements in said Town. The election provided for in this Act shall be held and conducted by the same registrars and judges of election and under the same registration as the election aforesaid for issuing sixty-five thousand dollars of bonds, and the returns shall be made, counted, and the result declared in like manner as in said election. But a separate box shall be provided for in this Act and the voters shall vote in this election on a separate ballot from that on which the vote in the box for the other bonds. Those who favor establishing the Schools and issuing the bonds hereinafter provided for for the erection of the necessary buildings and levying the necessary tax for

the maintenance of the schools and the payment of the interest on said bonds shall vote a ballot on which shall be written or printed the words "For the Schools" and those who are opposed thereto shall vote a ballot on which shall be written or printed the words "Against the Schools."

Section 3. That if a majority of the qualified voters of said town at said election shall vote in favor of establishing the schools as provided for in this Act it shall be the duty of the mayor and Board of Aldermen of said Town to cause to be prepared at the earliest possible day ten thousand dollars of interest bearing coupon bonds of the denomination of one hundred dollars each, to be numbered consecutively from one to one hundred inclusive. The said bonds shall be issued in the name of said Town, be signed by the mayor, countersigned by the Clerk of the Board of Aldermen, and shall run for thirty years, and bear five per cent. interest per annum, payable semi-annually on the first days of January and July of each and every year. The coupons on said bonds shall be receivable in anything due the town and both the bonds and coupons shall be exempt from taxation by said town. The Board of Aldermen shall sell and dispose of said bonds as early as practicable and for the best obtainable price, but they shall sell no bond for less than its face value. The said Board shall keep a record of each bond sold, to whom sold, and the price obtained. The said Board shall cause the proceeds of the sale of said bonds to be turned over to the town Treasurer, who shall hold and pay out said proceeds as hereinafter provided, and shall give such bond for the faithful custody and accounting for said funds as may be required by the Board of Aldermen.

Section 4. It shall be the duty of the Board of Aldermen to cause to be levied and collected a sufficient tax on the real and personal property and other taxable subjects and on the taxable polls in said town a sufficient tax to meet the prompt payment of the interest on said bond as the same may fall due and become payable.

Section 5. That if it shall be declared that a majority of the qualified voters of said town shall have voted in favor of establishing said Graded Schools, then it shall be the duty of the Board of Aldermen of said town to levy and cause to be collected, at the same time that other taxes are levied and collected, a sufficient tax to maintain said schools for a period of not less than thirty-two weeks each year which tax shall not be less than fifteen cents on the hundred dollars worth of property and forty-five cents on each taxable poll and not more than forty cents on the hundred dollars worth of taxable property and one dollar and twenty cents on each taxable poll. In addition to the taxes on the property and poll as aforesaid, the said Board may levy a tax for the support of said schools on all other subjects taxed by said town.

DISPENSARY IN WARRENTON

Bad Effects of Drunkenness Decreased Sixty Per Cent and Revenues Increased Eighty-six Per Cent.

(News and Observer.)

To the Editor: As I have been asked by so many about the workings of the dispensary here, which we have had about three and a half years. The main object in getting the dispensary here was not so much for revenue as it was to do away with the social feature of barroom drinking. In this particular the dispensary is a complete success and is a very great support to the morality of our community. As to the quantity sold by the bar-rooms and dispensary I am not able to say which sold the most, but there is a good deal sold by the dispensary, but the bad effects of the sales as to drunkenness and disorderly conduct in town is at least fifty per cent. less in favor of the dispensary.

I remarked a few days ago to a friend that there was so few violations of the law here now that I had almost as well make an assignment and go out of business. If liquors are to be sold at all there is no doubt that a well-managed dispensary is fifty per cent. the best way to do it. There was no arrest made here during Christmas week. Our county jail has no prisoners and has been without one nearly ever since our September court, and our February court is close by and not a prisoner in jail for it. Our Superior courts usually get through with the criminal docket in from one to one and half days. (We have a dispensary, see!)

Now as to the amount of revenue that the town gets now and when we had bar-rooms: I saw one of the board of managers of the dispensary yesterday and he gave me difference from the books of 86 per cent more in favor of the dispensary. Many of the strongest opposers of the dispensary in its beginning are its strong friends now. I can not see why every county in the State in which liquor is sold does not have it done by a dispensary.

THE LEGISLATURE.

SENATE—TUESDAY

Being the day on which the constitution requires that balloting begin for a United States senator, not much business besides voting was done in the senate wing of the general assembly. In the voting the members cast their ballots as they pleased, this being agreed by a previous resolution to so vote as to prevent an election until the caucus shall reach a discussion. Twenty nine different men were voted for, the highest receiving only four votes. These were among the bills introduced:

By Webb, of Buncombe: To amend chapter 1164 of Code. This provides that counties sending prisoners to other counties shall pay expenses.

By Wellborn, of Ashe: To repeal chapter 8, laws of 1901, relating to increase of the governor's salary.

By Spruill, of Tyrell: To make drunkenness a misdemeanor. For the first offence \$10 or 10 days imprisonment; each offence afterward \$25 or 30 days imprisonment.

HOUSE TUESDAY

The House also devoted most of the days session to voting for United State Senator, the same regulation applying in their branch as in the senate. Every member voted to suit himself and the number of complimentary votes was large.

The following were among the bills introduced:

Morpheus, of Graham: To protect timber dealers.

Parker, of Wayne: To establish the North Carolina Industrial School.

Willis, of Bladen: To amend chapter 415, Laws of 1895, that all records or wills transcribed by virtue of that act shall have the same force as the original document.

Woodley, of Chowan: To amend chapter 666, Laws of 1901, relating to cutting trees pending action to try title.

AN URBANE MAN

I have met a few urbane men in my time, but when I come to recall them man by man I realize that John Hicks stands alone at the head.
