THE GRADED SCHOOL BILL

(CONTINUED FROM YESTERDAY'S REFLECTOR.)

Section 6. That if it shall appear that a majority of the qualified voters of said town have voted in favor of establishing said Graded Schools, then such schools are hereby declared established and the following named persons are hereby appointed Trustees of said Schools, to wit:—E. A. Moye, Jr., J. R. Moore, T. J. Jarvis, W. H. Bagwell, B. F. Patrick, Chas. Cobb, W. L. Brown, B. W. King, W. B. Wilson, D. S. Spain, E. B. Ficklen, R. L. Carr, S. T. White and M. A. Allen. And it is further enacted that said Board of Trustees be divided into seven classes, and that their terms expire as follows:

Class 1 shall be composed of W. H. Bagwell, and D. S. Spain, and their term of office shall expire on the 30th day of June 1904.

Class 2 shall be composed of E. B. Ficklen and B. F. Patrick, and their term of office shall expire on the 30th day June, 1905.

Class 3 shall be composed of W. B. Wilson and E. A. Moye, Jr., and their term of office shall expire on the 30th day of June, 1906.

Class 4 shall be composed of W. L. Brown and J. B. Moore and their term of office shall expire on 30th day of June, 1907.

Class 5 shall be composed of R. W. King and M. A. Allen and their term of office shall expire on the 30th day of June, 1908.

Class 6 shall be composed of R. L. Carr and Chas. Cobb and their term of office shall expire on the 30th day of June, 1909.

Class 8 shall be composed of T. J. Jarvis and S. T. White, and their term of office shall expire on the 30th day of June, 1910.

It is further enacted that as the term of each class expires the vacancy shall be filled by the Board of Aldermen at an election to be held at the first regular meeting of the said Board after the expiration of said terms respectively and the persons so chosen shall hold for seven years and any other vacancy occurring in said Board of Trustees by resignation, death or otherwise shall be filled by an election by the Board of Aldermen and the person so chosen shall hold for the unexpired term of the Trustee whose vacancy he is appointed to fill.

Section 7. That said Board of Trustees shall have the general control and management of the said Graded Schools and they may determine the location, character and equipments of the buildings therefor, which shall not cost in the aggregate to exceed the sum of ten thousand dollars, and they may employ such teachers and officers for each of said schools as they may deem proper and fix the compensation thereof. They may appoint an executive committee of their number who shall have the more direct control and management of such schools under such rules and regulations as the Board of Trustees may prescribe, and the said Board, if they shall deem it advisable to do so, may appoint a committee of colored persons to aid the Board in looking after the interest of colored graded school under rules and regulations as the Board of Trustees may prescribe.

Section 8. That the persons herein named as Trustees of the Graded Schools are hereby constituted and appointed Trustees of Pitt Academy and they together with W. M. B. Brown, S. B. Wilson, A. W. Moye, J. B. Cherry, and W. H. Tucker, the surviving members of the Pitt Academy, shall be and they are hereby constituted the Board of Trustees of Pitt Academy.

Section 9. That if the Trustees of the Graded Schools shall deem

the ground on which Pitt Academy is now located a suitable place for the location of the Graded School for the white race, then said school may be located there by and with the consent of the Trustees of the said Academy, but if the Trustees of the Graded schools shall deem some other location more suitable, then the Board of Trustees of Pitt Academy as herein constituted may if they shall deem it advisable to do so, sell said Academy and all the lands belonging thereto in such manner and on such terms as they may deem best, make good title to the purchaser and invest the proceeds of such sale in the purchase of the location and in the erection of buildings for the Graded School for the white race.

Section 10. That if the Trustees of the Graded Schools shall deem the present location of the Public School Building for the colored race a proper location for the Graded School buildings for that race they may locate the Graded School at that point and with the consent of the proper school committee and the County Board of Education, use the Public Colored School Building for that purpose and make such changes and additions thereto as they may deem proper.

A colored woman named Annie Telfair, employed as a stemmer at the Imperial tobacco factory, while sucking a stick of candy yesterday afternoon, drew the candy down her windpipe. She fell against a bench and was taken down stairs. Dr. Bagwell was summoned, and found that the woman's left side was paralyzed. She was carried home and died last night at 8 o'clock. The unusual cause of the woman's death is much discussed.

NEGROES AT PRESIDENTIAL RECEPTION IN WHITE HOUSE

President Roosevelt Gives the Country Something Else to Talk About.—Southerners at the Capital are Mad.

Dead Sea Evaporation.

Scientific observation justifies the estimate that a daily average of 6,500,000 tons of water is received into the Dead sea from the Jordan and other sources during the year. During the rainy season, says the Chicago Record-Herald, the amount is very much greater; during the dry season it is of course very much less, but this average will be maintained year after year. There is no outlet, and the level is kept down by evaporation only, which is very rapid because of the intense heat, the dry atmosphere and the dry winds which are constantly blowing down the gorges between the mountains. This evaporation causes a haze or mist to hang over the lake at all times, and when it is more rapid than usual heavy clouds form and thunderstorms sometimes rage with great violence in the pocket between the cliffs even in the dry season. A flood of rain often falls upon the surface of the sea when the sun is shining, and the atmosphere is as dry as a bone half a mile from the shore. The mountains around the Dead sea are rarely seen with distinctness because of this haze.

The Rattlesnake's Rattle.

The utility of the rattle to the rattlesnake is a problem still awaiting solution. It has been supposed to be useful as paralyzing its prey through terror excited by the sound thus induced. But this is a very doubtful explanation. It is akin to the notion formerly entertained that serpents had a power of fascinating other creatures. Others have thought that it seems to excite the curiosity of animals and so brings them within the rattlesnake's reach. It has also been supposed that it serves, as it may do, to enable snakes of different sexes to find each other and also to guard the animal from attack when it is helpless from its power of offense having been temporarily exhausted. No sufficient evidence has, however, been collected to show that any of these ingenious speculations affords us a real clue to the true cause of such a curious and elaborate mechanism.—Quarterly Review.

THE LEGISLATURE.

SENATE—WEDNESDAY.

The senate put in a good day's work Wednesday, both in the matter of giving bills their second and third reading and introducing new bills.

Among the new bills introduced were the following:

By Walker, of Caswell: To fix a penalty for carrying concealed weapons. This puts \$50 in place of imprisonment, one half to go to the informer.

By Gilliam, of Edgecombe: To regulate child labor. The act provides that no child under fourteen shall work in a factory except during the day, and then not during the public school term. Children under twelve only to work when necessary to support a widowed mother or a totally disabled father, no children under ten to work at all in factories.

By Webb, by request: To provide for the marriage of husband's and wives who have lived separate and apart for five years.

By Justice, of McDowell: To provide for the care and treatment of certain insane persons, idiots, lunatics and inebriates. This makes all private institutions founded under section 60, chapter 1, Laws of 1899, a part of the public charities of North Carolina. Regulates admission to them, and the legal control of the patients.

By Glenn, of Guilford: To amend chapter 69, Laws of 1895, by making the provisions of the sale of stocks and bonds of public corporations so clear as to remove apprehensions of violation of the usury law.

By Henderson, of Rowan: To erect a building for a Hall of Records, State Arsenal, offices Commissioner of Labor and Printing and Legislative Committee rooms, cost not to exceed \$25,000.

By London, of Chatham: A bill making the insuring of the lives of infants under ten unlawful. If over ten then only after examination by a physician.

By Pollock, of Lenoir: To appropriate \$1,000 for the repairing, restoration and preserving of the Caswell monument at Kinston.

Siler: To amend law relatives to divorce for abandonment.

Koberson, of Guilford: To amend section 1857 of The Code, relating to repairing and rebuilding of water mills.

Doughton, of Alleghany: To amend the law relating to the public banking system of North Carolina.

Leeper, of Gaston: To amend law relative to branches of Farmers' Mutual Fire Association.
