### THE LEGISLATURE.

SENATE—MONDAY.

The following were among the new bills introduced:

Godwin, of Harnett: To prohibit the kissing of the Bible in taking oaths in court and by certain officers. Providing that the sanctity of the oath shall remain.

Webb, of Buncombe: To authorize judges of the Superior court to limit the argument of counsel in hearing and pleading in the Superior court.

Blow, of Pitt: For the benefit of graded schools. Fines collected by mayors of towns and cities to go to these. To Judiciary Committee.

McMullan, of Pasquotank: To amend section 97, chapter 2, Laws of 1901, by providing that charitable, educational, benevolent and religious institutions as well as associations having to capital stock may be incorporated by the General Assembly without paying a tax.

HOUSE—MONDAY.

The following were some of the new bills introduced:

Thomas, of Ashe: For the relief of sheriffs and tax collectors.

King, of Pitt: Providing for the appointment of cotton weighers for the towns of Pitt county.

Davidson, of Buncombe: To regulate practice and procedure in special proceedings.

Fuller, of Durham: To amend section 1077 of the Code, forbidding the sale of liquor to idiots and lunatics as well as minors.

Foy, of Pender: To amend section 1810 of The Code so as to prevent first cousins from intermarrying.

Stubbs, of Martin: To amend the Constitution of North Carolina relative to dividing the school fund.

### To Work Edgecombe Roads.

W. E. House, supervisor of roads in Edgecombe county, came down Tuesday evening and took two convicts from this county back with him this morning. Owing to insufficient arrangements for working convicts on the roads in this county, none were sentenced to work on the home roads at the last term of court.

### CUT TO KILL.

A White Man Murdered by a Negro in Beaufort County

Washington N. C., Jan. 26—Early Saturday night Hunter's bridge, sixteen miles below Washington, was the scene of a murder. The facts as reported are that George M. Latham, a young white man, and Rufus Woolard, a colored youth, became involved in a quarrel which led to blows. Woolard cut Latham with a knife in the abdomen, right thigh and hip. Latham died in about fifteen minutes after he was cut. It seems that both the parties were drinking at the time, and up to the time there was no bad blood between them.

Woolard escaped, but was captured Monday by a colored man and brought here and lodged in jail Saturday night. An inquest was held and the verdict of the jury was that Latham came to his death at the hands of Rufus Woolard by cutting with a knife. Woolard claims that he acted in self defense.

Saturday night some unknown person shot at Mr. M. M. Jones, near the A. C. L. depot, as he was coming down town. He has no idea who did it or the motive that prompted the act. He says no one is unfriendly toward him that he knows of.

## Unconscious From Croup.

During a sudden and terrible attack of croup our little girl was unconscious from strangulation, says A. L. # Captured By Convicts

We had discharged our cargo at Georgetown from the brig Albatross and were ready to start on our return voyage to Liverpool when the captain was notified that ten French convicts from the penal settlement of Cayenne had escaped to sea in a yawl.

Three days later and 120 miles to the south our lookout sighted the craft and her convict crew. In a quarter of an hour the yawl lay off our port bow within speaking distance.

"Hello, captain! Our ship went down off here (pointing to the east) yesterday afternoon. We have neither food nor drink, and we ask you, in the name of humanity, to supply us."

"I have nothing to spare, and I warn you to keep off!" shouted the captain in answer to the request.

We had seen no arms among them and had supposed them to be without weapons of any sort. To our great surprise, five muskets, taken from the guard when they escaped, were suddenly lifted into view, while four oars dropped into the water, and the yawl made for our bows. There was a fierce yell from every convict, and those with muskets opened fire. Captain Rothsay was killed and the second mate wounded even before they had hooked on. We scalded them with boiling water and fought them with whatever we could lay hold of, but within five minutes the brig was captured. We had a foremost hand killed in the fight on deck, and none of us escaped injury. As an offset we killed two of the convicts while they were trying to board.

As chief officer I was asked about our cargo and destination, and on the other hand the leader informed me that they were sorry to interrupt our voyage, but intended to use the brig to make good their escape.

The first thing was to get rid of the dead bodies. They allowed us to sew them in canvas before they went overboard, and then our wounded men were made comfortable. After the burial the leader said to us:

"We mean you no harm. We are desperate men and intend to make our escape. After we have been landed in some safe place you may sail away with your brig. If you try to deceive us, we will show you no mercy."

I was further informed that I must act as captain and navigate the brig, and I was allowed to choose a mate from among my men. After that a council was held among the eight of us as to what place should be steered for. I brought them the charts from the cabin, and after a long debate it was decided to run for the Amazon river.

From the very first I had hoped that we might retake the brig, but the convicts would only trust us so far. The watches were so divided by order of Moran that our men were separated, and two of the convicts were kept under arms to act as sentries. Moran and the second mate had quarters aft with me, while all the others berthed forward. All of us were under surveillance, and no two of us were ever left alone together. While none of them could take the wheel, they kept constant watch on the compass.

The winds were light and variable, and it was the sixth day after our capture before we drew in with the coast. Moran's orders were to avoid Para by entering the north mouth, and when we were fairly in the river he told me their plans. I was to take them in the brig up as far as the mouth of the Xingu river, and they then would pull up the stream in the yawl and make for the diamond district. We were not above thirty miles up the river when we were obliged to come to anchor for want of a breeze. About the time we anchored the demeanor of the convicts seemed to change for the worse. It appeared as if three or four of them were anxious to pick a quarrel with our men. That evening the second mate found opportunity to say to me:

"Depend upon it, Mr. Lenox, they never meant to stand by their bargain. I shouldn't be surprised if they were planning to cut our throats and scuttle the brig."

I strongly suspected them of some evil intention, but nothing came of it that night. Next morning we had wind and tide in our favor, and at noon, when we anchored again, we had made twenty-five miles. Right away after dinner the yawl was lowered and Moran began to outfit her. Whatever they thought could be made useful was placed in the boat, and they were rummaging about the whole afternoon. At about 6 o'clock Moran ordered all of the old crew of the brig into the cabin. Every man of us at once realized that the climax was at hand, and, acting in concert, we got a sudden and furious attack. We got possession of two of the muskets and were making a good fight of it, though bound to be beaten in the end, when a Brazilian gunboat, which was on her way up the river, sheered alongside of us and had grappled on before some of us saw her. Her presence put an end to the fight, of course. We had two men wounded, while we had killed one convict and wounded a second.

Our captors were neatly trapped, but they no sooner realized it than they claimed to be the real crew of the vessel and denounced us as convicts. They were so earnest and emphatic in their declarations that the commander of the gunboat was almost convinced. I destroyed their case, however, when I asked them for the captain's name, our part of haul, the names of the different ropes and sails, etc. They were ironed and taken aboard the gunboat to be conveyed to Cayenne, while the brig was towed down to Para to be put through the legal forms necessary in such cases. ## Desert Lizards.

There is no place like the desert for lizards. As a man rides through the white sands or over the black malapai mountains in Arizona or southeastern California and sees the flash and scurry of these brilliant and graceful creatures the suggestion of death and solitude is broken, and beholding so much life, he is brought to wonder if the country is really a desert or only a land to which a man is not adapted, for here are animals which never drink, yet frisk about through thorns and cactus and fatten on the bitter plants. Many a desert prospector had lain down with his burros to die and seen on the rocks about him the black heads of the chuckwalla lizards outlined against the brazen sky. The chuckwallas were happy and corpulent with good eating. It was their country. For thousands of generations their ancestors had never thirsted for water, and plants which the starving burros passed by furnished both food and drink for the scaly natives on the rocks. Next to the slow moving and deadly Gila monster the chuckwalla is the largest lizard of the desert, being from a foot to a foot and a half in length.—Country Life in America.

## How Snakes Fascinate.

The cobra of the Cape fascinates birds by colling itself on a branch, erecting its head and swinging to and fro. Sundowner states that the snake will go on "fascinating" and keeping the bird twittering and unable to leave the tree in which it is "for hours" and that if the bird is driven away it comes back. This may be a "yarn," but from the curious fascination which non-terrestrial objects, such as "lark glitters," have for some birds and their apparent inability to resist hovering around the lure the far greater mesmerizing power of the serpent may be conjectured. Movement, more or less regular, is always part of the means of fascination employed by snakes. Their fondness for music of any kind is not extended to the sound of the human voice singing, which snakes clearly do not appreciate at all. They only care for "instrumental music," which includes the concertina, tomtom and Jew's harp. But from experiments made in this country it was evident that they like the bagpipes best.—Spectator.
