### A REPUBLIC OF STATES OR A REPUBLIC OF DEPENDENCIES?

The following extract from an article by Thomas F. Ryan in February's North American Review, is, in view of the recent nationalization of the state guard of the different states, particularly timely. While the change in the ordering of the state troops affects all states alike, it is but another step of the federal government toward the centralization of power over the destiny of the nation:

"Local self government and the rights reserved to the state are among the most essential safeguards of our institutions. A system of checks and balances, which shall prevent encroachment by one department of government upon another, or by either upon the people, is the essential feature which distinguishes our republic from those centralized bureaucracies which mimic representative government on the continent of Europe and in Latin America. It will be a day of dark potent for the future of our institutions when the federal government lays its heavy hand on every man's shoulder, and reaches down into his private business and his household life. Such interference is tolerated at the custom houses and in the manufacture of liquor and cigars, because it is limited to the special purposes of taxation; but if the time ever comes when the same degree of interference is extended to all the relations of life, the American republic will represent a systematized machine, only waiting the firm hand of a Caesar or a Napoleon to divert its potent machinery to personal and dangerous ends. If a president can lawfully interfere between one class of employers and their employees, he can interfere in all, and the safeguards of state law and local courts will become as impotent as the empty forms of the Roman constitution under Augustus."

The same writer draws a forceful picture of the result of the tendency to vest autocratic power in the federal government. Under the head, "The restriction of the federal government to its legitimate functions and opposition to the further extension of its power over the acts and industries of the people of the state," Mr. Ryan says:

"Upon the vital question of the scope of federal power, the democrats of the South can afford to take a position which conforms to the historical teachings of Jefferson, Madison and Monroe. The people of the South have suffered enough from abuse of federal power—from the presence of United States deputy marshals at their elbows when they are seeking to govern themselves, from the intervention of federal courts to foist upon them laws and decisions which would not be enacted by their own legislatures and could not be enforced by their local courts—to make them think twice before giving their sanction to the further extension of federal authority. They would again have federal judges invading every province of their domestic life, passing upon legality and interpretation of those laws which they had formed to regulate limited liability and interpretation of those laws which they had formed to regulate liability in stock companies, to provide for the distribution of the assets of such companies and to regulate their employment of labor and all the points at which they come in contact in production transportation and distribution with the individual in his private life."

The Greenville REFLECTOR severely denounces the lawyers who are appearing as counsel for the liquor men before the legislature to oppose prohibitive or restrictive legislation, and in the course of its remarks says: "We believe that the ethics of the legal profession forbid a lawyer to defend a man whom he knows to be guilty." That exists only in theory, beloved. We assume that every lawyer has to be his own judge as to whether it is proper or improper for him to appear in a case. It is impossible for a layman or a lawyer either, for that matter, to lay down an iron-clad rule that would fit all cases. But we do know that if lawyers appeared only in cases where they knew or believed that their clients were innocent a great many lawyers would be without clients and a great proportion of the folks who get into court would be without counsel.—Statesville Landmark.

Our usually logical contemporary is decidedly out of order in this instance. We did not say that a lawyer should defend only those he knows or believes to be innocent, but that he should not defend one whom he knows to be guilty. The virtues of the carbuncle are resistance to fire, preservation of the eyes, promotion of pleasant dreams, creation of happy illusions and an antidote against impure air.

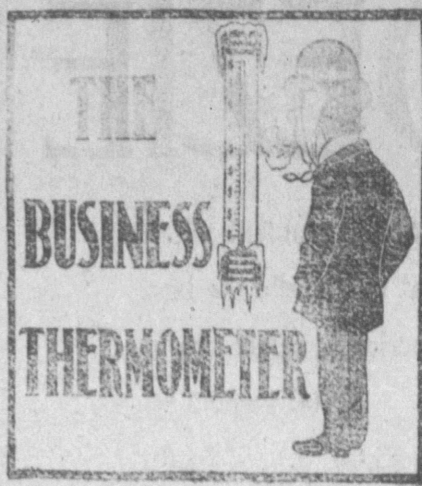

### Watterson on Monroe Doctrine.

Binghamton, N. Y., Feb. 15.—Colonel Henry Watterson, speaking at a dinner given him by the Binghamton Press Club, said: "Fifty years from today Germany will bear the same relative position to the United States Holland does now. Fifty years from now unless the United States places restraining hands under John Bull's arm, God knows what will become of him.

"The Monroe doctrine, or republicanism, is no longer on trial; it is monarchy that is in danger. The president of the United States today has tenfold more power than the king of England and the emperor of Germany.

"It accordingly may be well for us to sit down and see what the Monroe doctrine is. We have said that no European power shall acquire territory on this continent.

"If we are going to protect every little mongrel nation in order to uphold the Monroe doctrine, why let's pay Germany her debts and let her get out. But if we start on this course, we will need an enlarged navy. If I owned this government, I would take the Isthmus of Panama and blow out the canal and let the two oceans flow together. Then I would say to England: 'Take all of South America that you want.' And to Germany: 'Take all of Central America you want.' I would greatly prefer to have England and Germany on those countries than the mongrel governments that are there now."

Senator Overman's appointment of Representative Carr, of Greene as his private secretary is a deserved compliment to an efficient young legislator who is serving his second term. Senator Simmons named his private secretary from the west and Senator Overman has taken his from the east.—Raleigh Times.
