New Corporations.

The secretary of state today received articles of agreement for the incorporation of Pine Product Construction Company of Fayetteville with an authorized capital stock of \$125,000. The purpose is the manufacture and sale of stills and fixtures for turpentine business. Mr. A. A. McKethan of Fayetteville is the main incorporator.

The Joseph J. Stone and company of Greensboro was incorporated with an authorized capital of \$100,000 to conduct a printing establishment. The company has broad powers. Of the capital stock 750 shares are common and 250 are preferred.—Raleigh Times.

Hail and Fire Insurance.

In another column will be found an advertisement of the Tobacco Planters Mutual Hail and Fire Insurance Company. The home office of the company is at Raleigh with E. A. Parker as secretary, but two of the principal officers reside at Greenville. O. L. Joyner, president, and R. J. Cobb, secretary. The company is organized by leading farmers of the state for the benefit of its members. It is co-operative insurance, the members agreeing to pay each other's losses in case of damage. It is a home company devoted to North Carolina only. It is under the direct inspection of the insurance commissioner of the state and all agents are under bond.

The company insures tobacco for \$100 per acre, garden truck for \$100 per acre, strawberries for \$100 per acre, cotton for \$20 per acre and small grain at \$8 per acre. This affords protection to crops against destruction by hail that the farmers ought to be eager to take advantage of. The cost of becoming a member of the company and insuring crops is small.

If there is one thing in North Carolina that needs reforming it is the present jury system, and there ought to be such a discussion of the subject, both by the press and people of the state, as to lead to the election of a legislature two years hence that will enact this reform. If the present jury system is analyzed there need be little surprise that it is so hard to secure conviction of a person tried for committing a high crime. To this fault is due in great measure the large increase of such crimes. For example, let a man commit a cold blooded murder, and what is the result when the case comes up for trial? The state in prosecuting is allowed only four challenges in selecting the jury, while the man on trial has twenty-four challenges. When the jury is selected the state must get the entire twelve men composing it to agree upon a verdict of guilty before there can be a conviction, while the man on trial has to get only one of them to say he is not guilty and there is no conviction. Can anything be more unfair or unjust than this? With such conditions existing is it any wonder that men who commit crime have little fear of being convicted? The one committing a crime should not have any better chance of acquittal than the state has to convict, and until there is reform along this line no decrease of crime need be expected.

Upon being thanked by Bishop the murderer, for the light sentence given him, Judge Neal said:

"Bishop, I gave you a fair trial and a just sentence and do not deserve your thanks."

And now the Wilmington Messenger, with steady nerve and grim purpose, has it in for the judge as follows:

"When it comes Judge Neal's turn to ride this circuit and while holding New Hanover superior court he sends to the penitentiary for five years for stealing a chicken or a pig some uneducated, half-civilized negro, The Messenger will call his attention to what he has said about the sentence of Bishop for the same length of time for slaying Wilson while the latter was in the act of protecting his wife and children against the questionable conduct of this man Bishop."

Mosquitoes will now begin to select their summer homes. The first one of the season came in yesterday but met an untimely end. 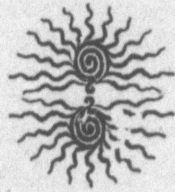
