The Teacher's Work and Reward.

[Essay read by Miss Alyse Harper before Pitt County Teachers' Association.]

Our work is to train morally, mentally and physically, the boys and girls, who in a few years will be the men and women of our land. There is an old adage, "The hand that rocks the cradle, rules the world." To a certain extent this is true, but let's see if the teacher does not have right much to do with it.

From infancy until a child is six years old they are usually under the tender care of a mother. She, who has been so careful to shield it from all tendencies of evil, places it in the hands of the teacher. How quick a child is to notice every action of the teacher! How careful we must be in all our words and deeds, for a child is the best of mirrors and in them we see ourselves as we are.

Then we take the child that comes from homes where drunkenness, lying and profanity reign supreme. What hope is there for such a child unless the teacher can and does gain his confidence, and by precept and example educate him so that he may make a useful citizen and a servant of God, instead of a disgrace to himself, a terror to the world and an imp of the devil?

How necessary it is for us to study carefully the disposition of each child, so that we may know just how to deal with each to obtain the best results. How we must watch them and still at the same time put them on their honor and instill in them the principals of honor and truthfulness.

How few of our people know or even care one straw about the laws of hygiene. Why are the people of our land becoming weaker and weaker physically? Does the child who rises in the morning with an aching head and feeling more tired than before retiring stop and consider, first of all the heartiest meal of the day was eaten a short while before going to bed and possibly the room in which he slept was occupied by three others? Every door and window closed, the key hole stopped possibly to keep out the cold, night air and yet we wonder why we are so tired, when we have been forced to breath over and over again air of which all the oxygen has been consumed.

Again, pa chews tobacco and smokes, and I must. Pa drinks whiskey and so must I.

If you tell him of some one who drinks poison, he is shocked at the idea of one so silly and yet ignorantly he takes into his system these poisons that will surely shorten his days.

If the teachers, in whose hands these children are placed, can and will dwell on these subjects and impress upon their minds the harm they do and the curse they are to the human race and so learn them to abhor the vile stuff, what a noble work is ours.

What golden opportunities are presented to us to imbibe in the minds of the child a love for God and his word.

We so often tell the children tales and have them reproduce them. Instead of some silly story, how much nicer to tell them the story of the life of David, Samuel, Saul, Joseph or some of the old patriarchs. Surely this can do no harm and from the lives of each, some valuable lesson may be learned.

In a few words, our work is the upbuilding of mankind, trying to raise them to the sphere God intended them to occupy, just a little lower than the angels. Our re-

ward, a few paltry dollars, (and very few at that) and if we have been faithful, a self consciousness of duty well done.

Misbehavior in Public.

It is astonishing how people, who would be indignant were they called unrefined, will misbehave in public assemblies, yet they are often seen so doing. It is no unusual thing after a performance in the opera house to hear some who were there complaining of being so disturbed by loud talking of others that they were unable to hear what was being said on the stage.

And misbehavior also frequently occurs in the churches, when some are prevented from enjoying the worship and sermon by the talking of others. These things ought not so to be. It matters not what the occasion be that calls people together, none should so far lose their sense of refine ment as to behave in such manner as will disturb others.

"THOUGH THY SINS BE AS SCARLET"

Daily—yea, hourly—the questions of moment which agitate the good old North State grow more complex and far reaching.

We settled the race question, so far as we are concerned.

We are building up an industrial commonwealth.

We are borrowing money for the highest purpose to which it can be put—education.

We are striving to tell the world something of our wonderful resources, and the possibilities in their development.

We are slowly but surely crushing out the life of the whiskey evil.

And now, upon the threshold of our prosperous and pleasing prospect, we are grappling with one of the saddest, most pathetic problems ever faced by publicists since the black dawn of original sin.

The city of Charlotte of fair renown, is stretching out the hand of hope and mercy to fallen women—stars that left their places in the glowing firmament of virtue and became soiled and stained by the sin of the world.

Charlotte does not seek to reform human nature, nor to cloak blackness in deceptive robes. It simply intends to provide a home for those who are homeless because their sins have made them so. It is hoped and trusted that this home will throw an influence around the unfortunate sinners within its walls that will redeem the waste and darkness of their lives. It is a home for the reformation of fallen women.

This looks like the work of a Saviour, doesn't it?

But the Durham Herald appears not to see it that way. The Herald says:

"After these women have been reformed what is to be done with them? The only answer is a sigh."

"For God so loved the world that he gave His only begotten son, that whosoever believeth in him should not perish but have everlasting life."

Some days ago we referred to a reward of \$200 offered for the best plan to avoid a strike. We suggested the "Gilded Rule." We did so on the spur of the moment. Thinking it over since, we are sure this is the only permanent and satisfactory basis for settling these troubles. "Do unto others as you would have them do unto you."

When men come honestly to act upon this principle it will not only mark the end of strikes, but strife and unjust litigation would, in the same way, cease. This is no unreal nor imaginary condition. Capital and labor ought to dwell together in the most perfect harmony, because they are mutually dependent on each other. So when profits are good capital ought to be liberal to labor, and when profits are small labor ought to share the depression until times become easy. If this sort of spirit prevailed strikes and strife between labor and capital would have a speedy end.—Raleigh Times.

Births in Africa.

It may be a surprise to the unenlightened to learn that probably no explorer, in forcing his passage through Africa, has ever for more than a few days at a time been off some beaten track. Every village is connected with some other village, every tribe with the next tribe, every state with its neighbor and therefore with all the rest. The explorer's business is simply to select from this network of tracks, keep a general direction and hold on his way. They are veritable footpaths, never over a foot in breadth, beaten hard and netted beneath the level of the forest bed of centuries of native traffic.

Like the roads of the old Romans, these footpaths run straight on through everything, ridge and mountain and valley, never shying at obstacles, nor anywhere turning aside to breathe. Yet within this general straightforwardness are a singular eccentricity and an indirectness of detail. And the reason is not far to seek. If a stone is encountered, no native will ever think of removing it; he simply walks around it. It would never occur to him that that stone was a displaceable object and that for the general weal he might displace it.

The Whale's Appetite.

A whale's appetite is phenomenal. His chief diet consists of jellyfish. He has simply to open his mouth and paddle along leisurely in order to take in jellyfish by the wagon load. Such is the method adopted by the whalebone whale. The sperm whale, on the contrary, captures huge squids weighing often several tons. Like his brother the whalebone whale, he must be constantly on the lookout for food; otherwise he would starve. As many as fourteen seals have been taken from a thirty foot "killer." Other fishes of enormous appetites are not uncommon. The bluefish, for example, thrives on sardines and other small fish. Assuming that one bluefish eats ten small fish a day, it has been figured that it requires 10,000,000,000 sardines to feed the 1,000,000,000 bluefish on our coasts every summer. Most curious of all eaters is the hydra—a strange creature that can be turned inside out without impairing its appetite or its power to eat.—Scientific American.

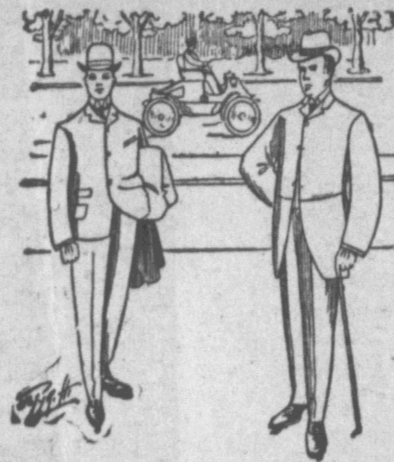
