COMPILING THE ROSTER.

People Urged to Furnish Information as Rapidly as Possible.

Raleigh, N. C., March 26.—Today State Auditor Dixon received a long letter from General F. C. Ainsworth, chief of the record and pension office, war department at Washington, saying "In acknowledgement of the receipt, of your letter of the 14th instant, I beg to express the gratification of the department at your cordial assurance of co operation with it, in the effort to make the recently authorized roster of officers and men of the union and confederate armies as nearly complete as it is possible to make it, so far as North Carolina troops are concerned."

"A considerable collection of rolls of North Carolina Confederate organizations is now in the possession of this department. While the collections does not by any means show all the names of officers and men who were in the Confederate service from North Carolina, and while it does not show the complete military history of those whose names it does show, it is hoped that the lists of names and histories of individual officers and men can be made much more nearly complete by the record evidence obtainable from other original rolls, that may now be in possession of the state of North Carolina, or of historical societies, memorial associations and individuals of North Carolina and other states." Auditor Dixon says regarding the letter that he agrees entirely with the plans suggested therein, and urges upon the people of the state that information be sent to him as rapidly as possible so he can arrange it and forward it to the war department.

FARMERS RUN OVER BY TRAIN.

They Were Killed Instantly at a Crossing Near Durham.

Durham, N. C. March 26.—Eastbound passenger train No. 136 on the Southern Railway, due here at 3:15 o'clock this afternoon, but running behind time, ran into a wagon at forty-seventh mile post, seven miles west of Durham, instantly killing W. A. Cooper and R. L. Rowland, well known and well to do farmers of Caswell county. They left Durham, where they sold tobacco, less than two hours before the accident. The bodies of the men were brought back to Durham on the train that killed them. After being prepared for burial at an undertaking establishment the bodies were taken to Mebane on the west bound train late tonight. From there the trip home will be made through the country.

The point where they were killed is a very dangerous crossing. Several have been killed there. The crossing is approached by steep grade and is on a sharp curve in the road, making it impossible to see a train more than twenty or thirty steps.

A Number of Employees of the Postoffice Department to Lose Their Jobs.

Washington, March 25.—It was learned at the postoffice department today that while the resignation of George W. Deavers, as chief of the salary and allowance division, was voluntary, it is but the forerunner of a number of other resignations which soon are to follow. It is said that a condition of affairs has grown up in the department which has become intolerable and that a number of chiefs of divisions and clerks will be given an opportunity to submit their resignations. As a result of this announcement there is more or less consternation among the employees in the department, it being understood that the decision to weed out a number of officials has been definitely determined upon.

Sale-Crackers Get Over \$700

Asheville, March 26.—The postoffice at Flat Rock was burglarized at an early hour this morning. If thoroughness may be taken as a safe guide to such a conclusion, the robbery was committed by expert cracksmen, for not only was the safe demolished and its contents carried away but a great hole was torn through the wall of the store building in which the office is located. The robbers got rich booty, the money, cash, checks and stamps which they secured aggregating something over \$700. Of this amount only \$100 belonged to Postmaster Lynch Brookshire, about \$150 belonged to the government, while the remainder was in stamps and checks.

PROCLAMATION

—BY THE—

Mayor of Greenville,

Giving Notice of an Election to be held in said town on the

7th day of April, 1903.

Whereas, the General Assembly of North Carolina, at its present session has passed an act entitled "An act to authorize the town of Greenville to issue bonds," to an amount not exceeding sixty-five thousand dollars, for works of internal improvements, if approved by the voters of said town;

And another act entitled "An act to establish a Graded School in the town of Greenville," and providing for the issuing of ten thousand dollars of bonds for the erection and equipment of the necessary buildings therefor, if a majority of the qualified voters of the said town shall so direct;

And whereas, by the terms of said acts, the board of aldermen of the town of Greenville were required at a meeting to be held on or before the first Thursday in March, 1903, to appoint a registrar and two judges of election for each of the wards of said town, to hold and conduct said election;

And whereas, the mayor of said town is required by said acts to issue his proclamation at least 20 days before said election, giving notice of said election and designating therein the persons chosen to conduct the same, and the exact place in each ward where said election is to be held;

Now therefore, I, Harry W. Whedbee, mayor of the town of Greenville, do, in accordance with said acts, issue this my proclamation giving notice to the qualified voters of the said town of Greenville as follows:

1. That an election will be held in the town of Greenville, at the several places in the several wards of the said town, on Tuesday, the 7th day of April, 1903, (it being the first Tuesday in April, 1903,) for the purpose of taking the sense of the voters of said town on the ratification or rejection of the provisions of said acts. Those who favor the issuing of said bonds for the purposes specified in the act entitled "An act to authorize the town of Greenville to issue bonds" will vote a ticket on which shall be written or printed the words "For Bonds," and those desiring to vote against them shall vote a ticket on which shall be written or printed the words "Against Bonds." Those persons who favor establishing graded schools in accordance with the provisions of an act entitled "An act to establish a graded school in the town of Greenville" shall vote a ballot on which shall be written or printed the words "For the Schools" and those who are opposed thereto shall vote a ballot on which shall be written or printed the words "Against the Schools."

2. That at the meeting of the board of aldermen of the said town held on the first Thursday in March, 1903, (it being the 5th day of March, 1903,) it was ordered that said election be held in the several wards at the following places to-wit:

First ward, at the old Eborn house on the corner of Second and Greene streets.

Second ward, at the residence of J. N. Booth on Third street.

Third ward, at the court house.

Fourth ward at J. H. Starkey's store at Five points.

Fifth ward, at the Farmers' warehouse, on Dickinson avenue.

That at said meeting on said 5th day of March, 1903, the said board of aldermen appointed the following named persons as registrars and judges of election, to register the voters and conduct the said election in the several wards as follows to-wit:

First ward—Henry Harding, registrar, B. T. Bailey and W. J. Cowell, judges of election,

Second ward—J. N. Booth, registrar, Allen Warren and J. L. Starkey, judges of election.

Third ward—L. W. Lawrence, registrar, G. E. Harris and J. D. Garden, judges of election.

Fourth ward—J. G. Bowling, registrar, T. E. Hooker and G. C. Moore, judges of election.

Fifth ward—J. C. Lanier, registrar, W. H. Dail, Jr., and J. S. Tansall, judges of election.

I therefore give notice that said election will be held at the places designated above in the several wards and conducted by the persons above designated as registrars and judges of election.

3. It is also provided in said acts that there shall be an entire new registration of the voters of said town, and that the registrars of the several wards shall attend at the above designated voting places on Thursday, Friday and Saturday next preceding the election, from 2 o'clock p. m. to sunset each day, for the purpose of registering all persons entitled to register, and who have not been registered, but the said registrars may, for convenience, register any person entitled to register at his home or at any other place in said town. Notice is therefore given that all who desire to vote must register before the day of election, as only those can vote whose names are found on the registration books.

4. It is provided by the 9th section of the act entitled "An act to authorize the town of Greenville to issue bonds," that at the same time and places as above set out there shall be elected five citizens of the said town, who shall be known and designated as the Board of Internal Improvements for said town. Notice is therefore given that each voter entitled to vote for or against bonds will also be entitled to vote in a separate box for five citizens to constitute said Board of Internal Improvements.

5. That it is provided by the 6th section of the act entitled "An act to establish a graded school in the town of Greenville," that at the election above provided for, to be held on the 1st Tuesday in April, 1903, there shall be also a separate election to determine and select fourteen trustees of said school and a separate box provided for same, which trustees shall be the trustees of the said school for the terms for which they have been elected. In the event the said schools shall have been established as above provided, to-wit: Two persons whose terms shall expire on 30th day of June, 1904; two persons whose terms of office shall expire on 30th day of June, 1905; two persons whose terms of office shall expire on 30th day of June, 1906; two persons whose terms of office shall expire on 30th day of June, 1907; two persons whose terms of office shall expire on 30th day of June, 1908; two persons whose term of office shall expire on 30th day of June, 1909; two persons whose term of office shall expire on 30th day of June, 1910.

Notice is therefore given that all persons who are entitled to vote for or against the schools will be entitled to vote in separate box for trustees as above set out.
