DO UNTO OTHERS.

We condemn the course of Mayor Studdart, of Washington, in sending that town's worthless characters forth to prey upon other communities. We learn from the Gazette-Messenger that the mayor recently ordered a negro with a terrible reputation to leave the town, and that policemen accompanied him to the frontier and saw to it that he hit the grit. The Messenger also states that the mayor has disposed of about 200 cases in this manner, and commends the method. The logic of the Messenger's commendation is hard to find. If Washington had cases of small-pox, and it would rid the town of the pest by sending it else where, would the Messenger advocate thrusting its evils on others? Again, is it not likely that the Washington mayor's method of dealing with this class of people tends to make Washington the favorite stopping place of human birds of prey, because they know that when they are finally brought before the mayor the worst that can befall them will be banishment? If these arguments fail to move our contemporary to a reconsideration of its indorsement we would ask if it is not nearer justice to punish offenders according to the laws of the town. Since all men will not obey the law, those who do obey it must provide for the punishment and safe keeping of malefactors, and we think Washington shows a very unenviable spirit of selfishness in thrusting its law-breakers upon other people. "Do unto others."

If Governor Aycock's plan to appeal to the business interest of the state to furnish a companion to the \$10,000 bill appropriated by the legislature for a St. Louis exhibit meets with no better success than the effort to erect a Sir Walter Raleigh monument, we suppose the Charlotte News and Asheville Citizen will chip in enough from their respective piles to make the amount at least large enough to suit the Durham Herald and the Greenville REFLECTOR.

**PROCLAMATION**

—BY THE—

**Mayor of Greenville,**

**Giving Notice of an Election to be held in said town on the**

**7th day of April, 1903.**

Whereas, the General Assembly of North Carolina, at its present session has passed an act entitled "An act to authorize the town of Greenville to issue bonds," to an amount not exceeding sixty-five thousand dollars, for works of internal improvements, if approved by the voters of said town;

And another act entitled "An act to establish a Graded School in the town of Greenville," and providing for the issuing of ten thousand dollars of bonds for the erection and equipment of the necessary buildings therefor, if a majority of the qualified voters of the said town shall so direct;

And whereas, by the terms of said acts, the board of aldermen of the town of Greenville were required at a meeting to be held on or before the first Thursday in March, 1903, to appoint a registrar and two judges of election for each of the wards of said town, to hold and conduct said election;

And whereas, the mayor of said town is required by said acts to issue his proclamation at least 20 days before said election, giving notice of said election and designating therein the persons chosen to conduct the same, and the exact place in each ward where said election is to be held;

Now therefore, I, Harry W. Whedbee, mayor of the town of Greenville, do, in accordance with said acts, issue this my proclamation giving notice to the qualified voters of the said town of Greenville as follows:

1. That an election will be held in the town of Greenville, at the several places in the several wards of the said town, on Tuesday, the 7th day of April, 1903, (it being the first Tuesday in April, 1903,) for the purpose of taking the sense of the voters of said town on the ratification or rejection of the provisions of said acts. Those who favor the issuing of said bonds for the purposes specified in the act entitled "An act to authorize the town of Greenville to issue bonds" will vote a ticket on which shall be written or printed the words "For Bonds," and those desiring to vote against them shall vote a ticket on which shall be written or printed the words "Against Bonds." Those persons who favor establishing graded schools in accordance with the provisions of an act entitled "An act to establish a graded school in the town of Greenville" shall vote a ballot on which shall be written or printed the words "For the Schools," and those who are opposed thereto shall vote a ballot on which shall be written or printed the words "Against the Schools."

2. That at the meeting of the board of aldermen of the said town held on the first Thursday in March, 1903, (it being the 5th day of March, 1903,) it was ordered that said election be held in the several wards at the following places to-wit:

First ward, at the old Eborn house on the corner of Second and Greene streets.

Second ward, at the residence of J. N. Booth on Third street.

Third ward, at the court house.

Fourth ward, at J. H. Starkey's store at Five points.

Fifth ward, at the Farmers' warehouse, on Dickinson avenue.

That at said meeting on said 5th day of March, 1903, the said board of aldermen appointed the following named persons as registrars and judges of election, to register the voters and conduct the said election in the several wards as follows to-wit:

First ward—Henry Harding, registrar. B. T. Bailey and W. J. Cowell, judges of election.

Second ward—J. N. Booth, registrar. Alton Warren and J. L. Starkey, judges of election.

Third ward—L. W. Lawrence, registrar. G. E. Harris and J. D. Garden, judges of election.

Fourth ward—J. G. Bowling, registrar. T. E. Hooker and G. C. Moore, judges of election.

Fifth ward—J. C. Lanier, registrar. W. H. Dail, Jr., and J. S. Tunstall, judges of election.

I therefore give notice that said election will be held at the places designated above in the several wards and conducted by the persons above designated as registrars and judges of election.

sons above designated as registrars and judges of election.

3. It is also provided in said acts that there shall be an entirely new registration of the voters of said town, and that the registrars of the several wards shall attend at the above designated voting places on Thursday, Friday and Saturday next preceding the election, from 2 o'clock p. m. to sunset each day, for the purpose of registering all persons entitled to register, and who have not been registered, but the said registrars may, for convenience, register any person entitled to register at his home or at any other place in said town. Notice is therefore given that all who desire to vote must register before the day of election, as only those can vote whose names are found on the registration books.

4. It is provided by the 9th section of the act entitled "An act to authorize the town of Greenville to issue bonds" that at the same time and places as above set out there shall be elected five citizens of the said town, who shall be known and designated as the Board of Internal Improvements for said town. Notice is therefore given that each voter entitled to vote for or against bonds will also be entitled to vote in a separate box for five citizens to constitute said Board of Internal Improvements.

5. That it is provided by the 6th section of the act entitled "An act to establish a graded school in the town of Greenville," that at the election above provided for, to be held on the 1st Tuesday in April, 1903, there shall be also a separate election to determine and select fourteen trustees of said school and a separate box provided for same, which trustees shall be the trustees of the said school for the terms for which they have been elected, in the event the said schools shall have been established as above provided, to-wit: Two persons whose terms shall expire on 30th day of June, 1904; two persons whose terms of office shall expire on 30th day of June, 1905; two persons whose terms of office shall expire on 30th day of June, 1906; two persons whose terms of office shall expire on 30th day of June, 1907; two persons whose terms of office shall expire on 30th day of June, 1908; two persons whose term of office shall expire on 30th day of June, 1909; two persons whose term of office shall expire on 30th day of June, 1910.

Notice is therefore given that all persons who are entitled to vote for or against the schools will be entitled to vote in separate box for trustees as above set out.

### Crocodiles in Water.

The crocodiles are thoroughly aquatic in their habits, and their peculiar conformation enables them to attack and seize their prey unawares. Their nostrils, which lead by a long canal to the back part of their throats, their eyes and their ears are placed on the upper part of the head, so that when in the water they can breathe, see and hear, while they are themselves practically invisible. When they dive, their nostrils and ears are closed by lids or valves, and their eyes are covered by a transparent nictitating membrane. They are further furnished with an arrangement which prevents the water from getting down their own throats when they are holding large animals under the water to drown them.

The dentition of these reptiles is peculiar. The teeth are sharp and conical and are hollow at the base, and each tooth serves as the sheath of another, which will in time replace it. The tongue—for notwithstanding the ancient belief the crocodile does possess a tongue—is fleshy and is attached to the bottom of the mouth. And finally the lower jaw is hinged at the very back of the skull, thus giving the animal its extraordinary gape and also the peculiar appearance which caused the notion that it moved its upper jaw.

### Curious Fire Alarms.

In St. Petersburg the arrangement of fire alarms is rather peculiar and decidedly unique, and the fire alarm telegraph is an unknown thing. Instead a fireman is at all times in the tower of the city hall, and he watches the surrounding city to catch the first glimpse of a fire. When a fire is discovered during the day, he runs up black balls on the top of the tower as signals; at night red lanterns are used. The number of the balls or lanterns shows the district or ward in which the fire is located, says a writer on "Foreign Fire Fighters" in Cosmopolitan. As soon as the signal is seen by the man on duty at the engine house he rings a bell outside, which calls together the members of the company, who may be scattered over a couple of blocks. This method is not conducive to quick time in reaching the scene, and from twenty minutes to half an hour is good work unless the fire happens to be near an engine house.

### Good Paste.

Not every man can make a good flour paste that can be preserved without decay or mold. Add to this a spoonful or two of brown sugar, a little corrosive sublimate and a few drops of oil of lavender and you will have a paste that will hold with wonderful tenacity.
