## Washington Letter

Special Correspondence from the Capital of the Nation.

Washington, D. C. April 20.

The appearance of "Cousin" Abner McKinley in Washington this week was not altogether surprising but it is taken to confirm the rumor that Mr. McKinley is trying to protect his old friend Superintendent Machen of the postoffice department from the fire of presidential wrath. Mr. McKinley had a long talk with Mr. Machen and from him went immediately to the postmaster general, with whom he was closeted for some time. It was generally believed that when Perry Heath was first assistant postmaster general, it was Mr. McKinley that effected the withdrawal of the request for Mr. Machen's resignation which had been made at that time.

A proceeding which reflects grave discredit on certain officials of the administration has just come to light in connection with the smuggling cases in Porto Rico. Officers of the army and navy and some civilians were recently arrested for smuggling wines, silks and tobacco into Porto Rican and the case was taken up at the instance of the United States Attorney for the island. When Secretary of the Navy Moody, Postmaster General Payne, Representatives Cannon and others were in Porto Rico they were appealed to in the matter and immediately on their return to Washington the United States attorney was instructed to "holle pros" the cases. The Porto Rican judge refused to entertain the plea, however, and the grand jury has indicted the officers and civilians. The department of justice, on being notified that the local judge refused to dismiss the cases, cabled the attorney, in part, "Considerations of moment not confined to Porto Rico or individuals involved have moved administration, after full investigation and deliberation, to course directed which will be adhered to." What will be the further course of the administration, now that the culprits have been indicted remains to be seen, but it is difficult to see reason or justice in the apparent exemption granted to smugglers, apparently on the ground that they are army and navy officers who should be the first to uphold the law.

A scheme put into operation, by which Secretary Shaw has just afforded the National City Bank of New York an opportunity to make some very handsome profits in connection with his bond refunding scheme has just come to light and has occasioned the greatest indignation on the part of other New York bankers. The secretary caused to be addressed, from the list of registered bond holders in the possession of the treasury department, circulars of the bank named, offering to purchase the 4 per cent. bonds and exchange them for the new issue of 2 per cents. As there is a very handsome profit in the transaction for the bank making this exchange and the secretary was party to the scheme numerous protests are being received.

**NORTH CAROLINA MUST BE REPRESENTED.**

Referring to the much desired representation of the state's resources at the St. Louis exposition, the esteemed New Bern Journal does us justice in saying that THE REFLECTOR'S record does not show that we believe in quitting. This subject is one that is close to the heart of every North Carolina newspaper man who loves his country. It is doubtful if any other class of people appreciate the value of advertising as does the newspaper makers, many of whom have studied advertising all their lives. Many men believe that advertising pays, but newspaper men know it.

The Journal gets at the bottom of the matter in the following eminently sensible remarks:

"The legislature's failure to provide an ample fund for a North Carolina exhibit at the St. Louis Exposition, was weakness, a shortsightedness, which in a business house would have been a distinct set back in its management and probably injury to its trade.

"While there is no real analogy, perhaps, yet could not a state's credit be injured, at least there be a hesitation to purchase its bonds, when those who seek to sell its bonds refuse to advertise its resources and show its products to the world that is seeking investment?"

"Let the merchant keep his store filled with the choicest articles, yet if he does not make known what he has, there will be no demand or sale of his goods."

Let the matter be thoroughly discussed and advocated before the coming meeting of the North Carolina Press Association at Wrightsville. North Carolina owes no small amount of its present prosperity to the patriotic and unselfish efforts of its public journals, and they will gladly take up this new burden. North Carolina MUST be represented. That is the cry. Take it up and sound it from Manteo to Murphy.

The Gastonia Gazette is about to come forth from the struggle to remove the county seat of Gaston county from Dallas to Gastonia with more honor than a Caesar's laurels. The fight has been fierce from both sides, and feeling runs high. **Perfect Respiration.**

For perfect respiration two things are necessary—chest capacity and breath control. The average individual, woman especially, uses but a limited portion of the lungs and upper chest in ordinary breathing. Whenever a little unusual physical effort makes demand for an extra breathing capacity, note how she puffs and pants, almost to a point of gasping. The reason for this is that the muscles of the lower chest, waist and abdomen have become well nigh atrophied through neglect and abuse. They are stiff and unresponsive and have now to be coaxed back to a condition of activity and obedience.

It is quite as possible to educate these muscles so that they shall respond to our slightest demand as it is that our hands are trained to do our bidding. Different teachers will advocate different forms of breathing—upper chest, side chest, lower chest and abnormal breathing—but what we most want is absolute control, such control of the muscles as shall enable us to make use of any desired form of breathing at the word of command, for all forms have special values. Full upper chest breathing is used most, but lower chest and abdominal breathing are very valuable in cases of nervousness, indigestion, stomach and bowel troubles.

**The Truthful Pioneer.**

"One day," said the truthful pioneer, "I was whacking up some wood down by the creek, and ten Indians loomed up. They were pretty thirsty even for Indians, and they said they knew I had a jug somewhere, and they wanted to sample it. I had a log about half split at the time, and the ax was sticking in it. I told them if they would help me get that log in two I would show them where the jug was. So they took hold, five on one side and five on the other, and pulled. Then I walked away to the house and loaded the shotgun and three or four pistols and then went back and argued with them, and they reformed right away." This story, says the Nebraska State Journal, was originally told of Daniel Boone or Davy Crockett and has done good service ever since. It is not copyrighted, however, and there is no good reason why Nebraska pioneers should not use it.

**The Wild Giraffe.**

Perhaps the most difficult of all wild animals to capture is the giraffe. In addition to being very rare giraffes are exceedingly timid and are very swift footed. There is no special way to capture a giraffe, as almost every way has been tried, and all have been almost equally unsuccessful. The method which has occasionally resulted in a capture is by using a long cord, at each end of which is a round weight. Most of the giraffes in captivity have been caught by chance when young.

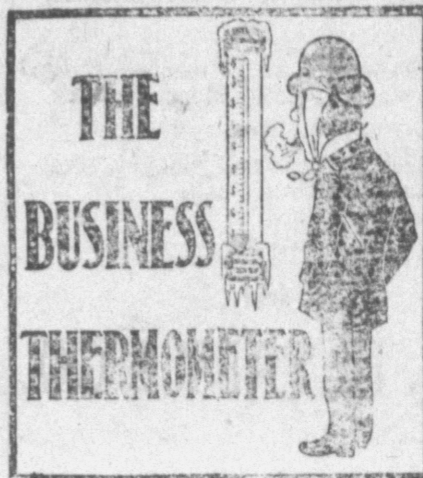
