## WILCOX PLAYS THE MANIAC.

### FIRED THREE SHOTS AT HIS PRISON WALLS.

### TAKEN TO THE PENITENTIARY.

### Cursed His Captors and Said He Would Soon Return to the Scene of His Crime.

Elizabeth City, June 15.—Sheriff T. F. Winslow and Deputy Sheriff Isaac A. White, of Perquimans county, left on the evening train with James H. Wilcox, the murderer of Nellie Cropsey, who is being carried to the penitentiary to serve a sentence of 30 years.

He was driven from the jail to the depot in a closed carriage, accompanied by the above officers and Sheriff Reed, of Pasquotank county. A large crowd gathered at the depot to see the prisoner.

Wilcox stubbornly refused to leave the jail in which he has lain so long, saying he was not going to the penitentiary. He had to be carried by force to the carriage, notwithstanding the entreaties of his father and friends.

He refused to put on decent clothes, and went out without coat or top shirt. He put on an old ragged pair of shoes, and torn pants and a worn and soiled hat. He was very impudent and abusive to the officers when they attempted to remove him from jail. He fired three shots in his cell today from a revolver which he had concealed on his person. He then gave it to the jailer, saying: "I had that gun on me in the court room during both trials."

"I don't expect to work in the penitentiary," Wilcox said. "I shall not be there long—I shall soon be back here, and people will know when I get back."

He took a big drink of whiskey before leaving the jail. A bottle was given him at the depot, but was taken away by an officer.

He said Sheriff Reed had been kind to him. He had nothing for the press, but said he would make a statement to reporters at Weldon.

Wilcox was exceedingly troublesome at the depot, becoming violently boisterous and abusing the officers.

His father did not see him after he left the jail, but remarked that "Jim had more hell in him to the square inch than any man I ever saw."

### Parade and Triumphal Arch.

It has been suggested as a feature of the Confederate Veterans' reunion to be held here on Friday, the 3rd of July, that there be a great parade and that a triumphal arch be erected at the intersection of Evans and Fourth streets. No doubt the business men of the town would join in helping to make the parade a success, and it would add interest to the reunion. The suggestion is referred to the committee on arrangements for consideration.

What a happy old world this would be if men who don't know anything would only keep it to themselves instead of telling it.

## WILSON MURDER CASE.

### Looks Like the Defendants Have Somethings Coming to Them From Judge Shaw.

Wilson, June 15.—The case of state vs. Lawrence Morgan, John Allen, George Whitley, Gil Ward, J. B. Piver, J. T. Bass, W. W. Barnes, W. P. Croom, John Pittman, S. J. Walls and W. H. Riche, charged with the murder of Percy Jones, was called at the beginning of the afternoon session of the Superior court today.

Three of the defendants, J. B. Piver, John Allen and W. W. Barnes, were not present to answer. A plea of absence on account of sickness was made for them.

Solicitor Daniels, of Wilson; Frank Spruill, of Louisburg, and Prof. J. R. Uzzell represent the state. The defendants are represented by Messrs. Pou and Finch, J. B. Woodard, Fred. A. Woodard, S. A. Woodard, Connor & Connor, W. P. Farmer and E. C. Barnhill.

A certificate by Dr. F. C. Walton as to Allen was read to the effect that Allen's condition is critical, as he was suffering from wounds received during the attack upon Jones.

Solicitor Daniel stated that another physician had examined Allen and that in his judgement he was able to come to court.

Mr. Spruill said he would not charge anyone with trifling with the court, but that he was in possession of reliable information to the effect that Allen had almost if not entirely recover from his wounds. He asked that a *capias instanter* be issued, so that it could easily be determined if the absent men were too unwell to appear in court.

In reply John E. Woodward for the defense said he had never seen a *capias instanter* whose service could be discretionary with the offers in whose hands it was placed.

The solicitor said the state wanted to try the case. He read the certificate as to Allen's condition said that one physician who had examined Allen recommended that a sick benefit which the accused had been receiving be withdrawn.

Mr. Woodward said the defense had no thought of trifling with the court but was simply relying upon plain facts to justify the absence of the three defendants.

### CAPIAS INSTANTER ISSUED.

Judge Shaw directed the clerk to issue a *capias instanter* for Piver, Barnes and Allen, and that the county physician accompany the officer serving the *capias* and ascertain if the men are or are not able to appear in court.

Piver and Barnes are at their homes in Wilson, while Allen is in Pitt county, about 20 miles from Wilson, with relatives, and can easily be reached.

Judge Shaw then asked if the state would be ready for trial at this term of court, and was answered in the affirmative. The defense stated that they would not be ready for trial at this term.

The judge then ordered the defense to prepare affidavits for a continuance. The defense replied that the affidavits would be ready and would be supported by legal argument when court opens at 9:30 tomorrow morning.

### SOLICITOR WILL STAND NO TRIFFLING.

Solicitor Daniels said this afternoon that he would urge the trial of the other defendants, regardless of the condition of Piver, Barnes and Allen.

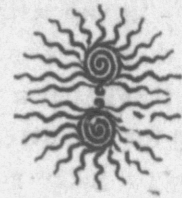

**TIME TO EQUALIZE TAXATION.**

The communication of ex-Gov. Jarvis in Monday's issue of THE DAILY REFLECTOR in reference to the article in this paper on Saturday advising that the graded school building be of brick instead of wood, brings out some facts that deeply concern every citizen of the town. The declaration is made that the leaning of the trustees to a wood building is not from choice, but necessity, and that they would much prefer a brick building if the fund at their disposal was sufficient. Gov. Jarvis gives figures showing the amount of the school bonds to be about \$2,000 short of enough to erect and properly equip a building of brick, and asks, will some one tell how they can get this additional money. He then offers a suggestion by which the needed \$2,000 can be obtained, and THE REFLECTOR does not believe a better suggestion can be made.

As to the town's ownership of the street and sidewalks adjoining the old academy lot, Gov. Jarvis' point is clear, and there should be no hesitancy in the willingness of the aldermen to pay for it. It is just to do so. The school is of the town and for the town, and THE REFLECTOR believes that the aldermen, in paying a just price for the street through the property, would represent the wishes of a large majority of the citizens and the act would have their approval. As to the suggestion that a higher license tax be levied upon liquor dealers and a part of it applied to the school building fund, nothing could be more fair. Especially is this true when the inequality heretofore existing between the liquor license tax and the property tax is taken into consideration. While the liquor license tax has been at almost the lowest figure prescribed under the town charter, the tax on property has been raised to the full constitutional limit. As they have had almost as near immunity from taxation as the charter would permit, we do not believe the saloon keepers themselves could conscientiously complain if they are required to pay a higher license.

THE REFLECTOR stands by what it said Saturday, that the graded school buildings ought by all means to be of brick. We hope the additional money necessary to this end may be secured.

The board of aldermen soon to retire from office could do the crowning act of their administration by paying the trustees a just sum for the street across the school property; and the incoming board could begin their administration with no higher credit than increasing the liquor license tax and applying it to the school building fund.

**"OUR BEST PEOPLE" AGAIN.**

We would like to know where Insurance Commissioner Young deigned the power to allow law-breakers to go unmolested upon their promise to sin no more. The following dispatch brings forth our query:

Raleigh, N. C., June 13—Insurance Commissioner Young has returned from Asheville, where he went to look after unlicensed agents of unlicensed investment companies. He found that these agents had not done much business. He met them and they agreed to quit business and thus avoid trouble.

We suppose these insurance agents who were violating the law by doing business without a license were "some of our best people," else they would not have escaped so lightly. "He found that agents had not done much business"—in other words the law breakers had only broken the law in a few places, because they had not had the opportunity. Truly, the man who obeys the law and expects to be protected by its strict enforcement against those who do not obey, is a simple citizen.

The federalized state militia is to be furnished with new rapid-fire rifles. No doubt the United States government will provide the right kind from its point of view, but from our point of view broomsticks would be the proper weapons with which to arm the United States army in North Carolina.

Shall it be of Brick or Wood?  
That is the Question.

EDITOR REFLECTOR:

In Saturday's paper you say, "We hear it talked that some members of the board of school trustees are in favor of erecting a wooden building for the graded school. THE REFLECTOR believes it would be a serious mistake to have such a building built of wood and if the trustees have such in contemplation we hope they will change their plans and put up a brick house instead."

The above extract is from Saturday's REFLECTOR and it reads like you thought the trustees had determined on a wood building as a matter of choice and not from a matter of necessity. Such is not the case. I do not think there is a man on the board who would not prefer a brick building. The situation is simply this: We are trustees of a sacred public trust, we are charged with certain public duties. The sum of \$10,000 has been placed in our hands with which to meet and discharge the duty of erecting and equipping the necessary buildings for the graded schools for the two races.

Of this sum we must set apart at least \$1,000 for heating and ventilating the buildings for the whites, and this is true whether it be of wood or brick.

We must also set apart at least \$1,000 for the furniture and other equipments for the white school building.

We must also set a part at least \$1,000 for the enlargement and repairs to the colored school buildings.

This leaves us but \$7,000 to put into buildings for the white children. Out of this we must pay the charges of the architect, the commissions of the treasurer, &c., which will leave us about \$6,500 for the building.

We must put up a building of sufficient dimension and capacity to accommodate the white children of the graded school district. It will not do to put up one of only capacity to accommodate a part of the children in order to get a brick building. We have gone far enough in our investigations to know we can put up such a building out of wood with the funds we have in hand and that we cannot put it up of brick. The architect and the contractor tell us that a brick building costs about one third more than a wooden building. That is to say, that if a wooden building costs \$6,500 the same building in brick will cost about \$8,500. We have the \$6,500. We have not the \$8,500. If we had the \$8,500 we would all be for brick. We are short \$2,000. How can we get it? Will you or some one else tell us?

Do you say borrow it? Then, I reply, two questions arise. 1st. Have we the authority to do so? 2nd. If we have the authority to borrow is it wise to do it? For one I am anxious that the management and work of the school shall be such as to silence all opposition. Will going in debt tend to bring about this end?

I can suggest one way in which the needed two thousand dollars can be obtained. The town charter gives the board of aldermen power to condemn property for streets, side-walks, &c., but it requires the town to pay for it. The town has no title to the streets and side-walks in front of the o'd academy. It has never condemned it. The deed to the trustees of Pitt academy includes these streets and side-walks. The boundaries of the academy property extends to the line of the Alfred Forbes street, so that the legal title to the street is in the trustees of the academy.

When Forbestown began to build up people began to cross the academy grounds and then Evans street was opened across these grounds

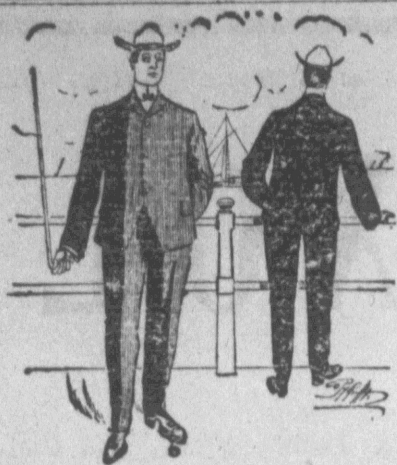

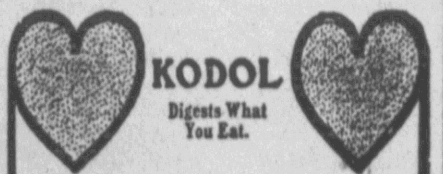

simply by working them and not by any condemnation proceedings and no compensation has ever been made to the trustees. The only title the town has to the street either legal or equitable is such as it has acquired by user. Now if the board of aldermen will appropriate out of its funds on hand the sum of \$1,000 to the board of trustees as compensation for the property taken we will have half of the needed sum to erect a brick building. I know such an appropriation would be legal and I believe it would be wise.

Then if the incoming board of aldermen will make the tax on liquor license \$350—\$150 to the town for general purposes now—\$100 to help erect the school building and \$100 to help run the school, this will give us another \$1,000. Now with the two thousand dollars derived from these two sources we can change from a wood to a brick building. So it is in the power of the outgoing and the incoming board of aldermen to enable the board of trustees of the Graded school to erect a nice brick building. Or if the board of aldermen would have a conference they might come to our help. The limit in the charter for liquor business is \$500. In some towns it is \$1000. If the incoming board would make the tax say \$400—\$150 to go to the erection of the buildings and the outgoing board would appropriate \$500 for the property taken this would raise the necessary \$2000. Or if the incoming board choose to go to the limit that alone would be sufficient. Now will those who so strongly advocate a brick building interview the two boards of aldermen and see if some agreement cannot be reached by which the needed \$2,000 can be had, or suggest some other plan to get it other than borrowing it. I am sure the board of trustees would gladly change to a brick building if some one will open the way to them that does not require them to go in debt. We meet on the 25th to let the building to contract and I think I voice the sentiment of the board when I say it would delight us if the citizens would take the matter up and in some way provide us with the money to contract for a brick building.

### Pittsburg Banks to Combine.

Pittsburg, June 13.—Plans have been perfected for the formation in Pittsburg of one of the greatest combinations of banking interests ever undertaken in the country. By the deal the Farmers' Deposit National Bank, Colonial Trust Company, Colonial National Bank, American Trust Company, Pennsylvania Trust Company, Columbia National Bank, Tradesmen's National Bank Germania Savings Bank and Freehold Bank will be merged, making the largest and most powerful financial institution between Philadelphia and Chicago. The capital of the concern, which will be probably known as the Colonial Trust Company, will be \$7,000,000 with \$16,000,000 surplus and undivided profits and about \$55,000,000 deposits, making total resources of \$78,000,000. T. Hart Given, the president of the Farmers' Deposit Bank, will be the head of the new concern.

### GRADED SCHOOL MATTERS.

#### Prof. W. B. Dove Elected Superintendent

The board of trustees of the graded school held a meeting Monday afternoon to consider matters in connection with the school.

An agreement was entered into between the trustees and the county board of education by which the public school building for the colored race, situated just west of town, is transferred to the trustees to be used for the graded school for that race.

A committee was appointed to go before the board of aldermen and ask for the levying of a tax sufficient to meet the running expenses of the school.

Prof. W. B. Dove, of Reidsville, was elected superintendent of the graded schools at a salary of \$1,000.

### Correction.
