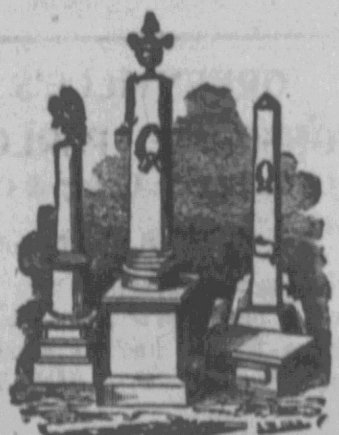

PAYNE IS VERY MUCH PAINED.

A TWENTY-ONE YEAR GRAFTER WALKS THE PLANK.

METCALF AND MONEY ORDERS

Papers Upon Which Tulloch's Charges Were Based Made Public.

Washington, D. C., June 17.—Postmaster General Payne late this afternoon issued an order summarily dismissing James I. Metcalf from the position of superintendent of money order system which he had held for twenty-one years, for endeavoring to divert a contract for manufacturing money order blanks. Mr. Payne showed considerable emotion as he announced to the newspaper men his action in the Metcalf case.

Washington, June 17.—Postmaster General Payne today made public all papers connected with the investigation of the Washington postoffice in 1899 and 1900, as a result of charges preferred at that time by Seymour W. Tullock, former cashier of the Washington postoffice and which were recently repeated by Tullock in a formal communication to the postmaster general. The charges reflect very discreditably upon Perry S. Heath, former assistant postmaster general, and at present secretary of the republican national executive committee.

Heath has announced his intention of going to China soon. As previously announced the postmaster general declared at first that he would not make the documents public, as they related to matters connected with the administration, but the pressure has been so strong that he has been forced to stand and deliver.

The most interesting feature of the document is the admission of Fourth Assistant Postmaster General Bristow that he recommended to former Postmaster General Charles Emory Smith that the office of Perry S. Heath be investigated. The papers show that later the investigation was made and a number of irregularities corrected.

FIGHT IN MONTICELLO HOTEL.

Traveling Man Waited Three Years for Revenge.

Norfolk, Va., June 17th.—A fight occurred at the fashionable Monticello Hotel here in which the proprietor, Sylvanus Stokes, was badly beaten by James Swanson, a traveling salesman from Wilmington, N. C. Swanson was tried today and fined \$50 and cost for beating Stokes, and Edward James, hotel clerk, for beating Swanson was fined \$10 and costs. Swanson was a guest at the hotel three years ago when a boot black mismatched his shoes. Upon returning here this week he demanded six dollars for the shoes and the fight resulted.

THE WAR IN KENTUCKY.

Disgraceful Scenes Enacted in Court.

Jackson, Ky., June 17.—When court convened this morning Judge B. F. French, leader of the French faction of the French-Eversole feud, began the argument for the defense of Jett and White, he declared that County Judge Blanton, who said that witness Crawford had been arrested, had lied. Judge Blanton sprang to his feet and approached Judge French but E. F. Jones threw himself between the two men Judge Redwine threatened to send Judge Blanton to jail for contempt of court, and admonished Judge French to be more moderate in his language. Capt. Ewen, guarded by a detachment of militia, was taken to a train this morning and departed for a place of safety. Previous reports of his departure were given out to throw his enemies off their guard.

Mr. Farrow took the bill from the boy's hand and gave the negro what he thought was a dollar and two 50 cent pieces. Later he discovered that he had swapped \$30.50—a 20-dollar gold piece, a 10 dollar gold piece and 50 cents in silver—for the negro's greasy two dollar bill.

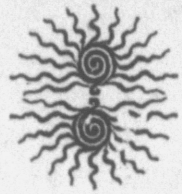

WHERE JUDGES DIFFER.

Some days ago, just after the murderers of Jones at Wilson were admitted to bail by Judge George H. Brown, Jr., THE REFLECTOR made some comment upon it and the judge's declaration that the evidence did not disclose that murder was intended in the assault upon Jones. We compared this to a case of burglary where a person entered a house to rob and not with intent to commit murder, but did kill some one when discovered, and expressed the opinion that the assailants of Jones, upon entering his room to do him bodily harm and killing him because they met with resistance, were just as guilty of murder as the burglar.

Since then we have received a very courteous letter from Judge Brown in which he in part says:

"Burglary is breaking into a dwelling with intent to commit a felony. All the state's evidence before me showed plainly the prisoners broke in Jones' room to whip him and drive him from town. That is not a felony. In the fight some one killed Jones. Who did it the evidence did not disclose. Our Supreme court in State vs. Thomas declares that is murder in the second degree, Act. 1893, a bailable offence. I am not responsible for that decision or that act. Prior to that act it was plainly murder."

Certainly Judge Brown is not responsible for the existing law and the intent of the criticism of THE REFLECTOR was not to charge him with it. However, our opinion, while it may not be in strict accordance with the letter of the law, that the slayers of Jones are just as guilty of murder as the burglar who did not intend to kill when he entered the dwelling remains unchanged. And the law that makes it to the contrary is a huge farce.

Another point that may be raised in connection with the bailing of those who killed Jones, that it was setting aside the action of the grand jury which had already found a true bill for murder against them.

We also observe that Judge Shaw, who is now holding court in Wilson, decides that five of the prisoners must be tried for murder in the first degree. So it seems that even among judges there is a difference of opinion on this case.

There are more merchants who do too little advertising than there are of those who do too much, says Ad-Art. It is better at all times to get more life into the business, and if this may be done by an extra amount of hustle in the advertising department it will be all the better for it. In sober fact, the scenes which have been enacted in Kentucky lately are a disgrace to the entire county and a reproach to the civilization we boast of. If the law is not a helpless example of innocuousness it ought to hang a half hundred of those murderous barbarians on general principles.

Under the law Judge Harlan of the Supreme court can retire on full pay, on account of having reached the 70 year limit, but the venerable judge refuses to put off the harness. He has probably learned that doing nothing is the hardest work.

Modern Sunday School is Harshly Criticized

Chicago, June 16.—That the majority of the Sunday schools of the present day are ineffective educationally, are lagging far behind the public schools in pedagogic methods and are standing almost on the level of the old district school so far as scientific teaching is concerned, are the charges made by Professor Ernest DeWitt Burton and Professor Shailer Mathews.

These statements are made in volume just published from the University of Chicago press on "Principles and Ideals for the Sunday School." The book is the result of years of study and experience on the part of both the authors in Sunday school work.

The Sunday school, it is asserted, is essentially an educational institution, not a plan for direct exhortation to certain lines of action.

Faulty methods of teaching and illogical selection of the subjects taught are blamed for the decline in interest and final dropping out of pupils as they grow beyond the years of childhood.

Professor Burton and Professor Mathews advocated making the Sunday school in many respects exactly like a public graded school where the children of the different grades are taught different subjects according to capacity.

Murder Near Fort Mill.

Yesterday afternoon Tom Bailey and Arthur Frazier, two colored men, became engaged in a quarrel on the farm of Mr. B. D. Springs, near Fort Mill, S. C. An altercation followed, which resulted in the death of Frazier from a pistol fired by Bailey. The murderer at once left for parts unknown. Owing to the fact that negro criminals from that section of South Carolina have a habit of coming to Charlotte, the police officers of this city have been expecting to hear of Bailey's temporary location in this vicinity, but he appears to have given the Queen City a wide berth.—Charlotte Chronicle.

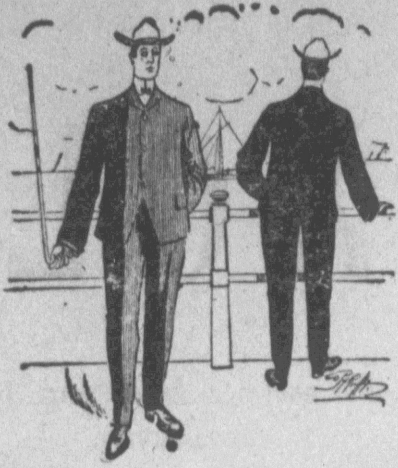
