STRANGULATION PROCESS.

Roosevelt and Payne Are Covering Up Rascality.

Washington, June 29.—The postoffice investigation is to be brought to an end by the strangulation process, and it will be up to congress to expose those guilty of irregularities in high up circles, whom the administration is disposed to leave severely alone on account of the future political controversy involved.

This morning Postmaster General Payne summoned his four assistants to his private office and announced, by order of the president, that no further information bearing on the postoffice investigation should be given out. They were instructed to give all the clerks in their respective departments the benefit of this information, with the further injunction that any breach of this order will be followed by summary dismissal.

For weeks James S. Clarkson, T. C. Platt and other professional politicians have been urging the president to bring the investigation to a close, and the whole thing will now be hushed up.

Ever since Postmaster General Payne announced that there would be no investigation of Bristow's charge against a prominent republican it has been apparent that this investigation, which President Roosevelt announced with so much gusto would go from top to bottom, is not sincere.

It is very likely that Robert J. Wynne, the former newspaperman, who exposed frauds in his office, will be ousted by the republican rulers.

THROUGH IRON BRIDGE.

Wreck on Seaboard Air Line in Virginia.

Richmond, Va., June 29.—An engine and two freight cars on the Seaboard Air line had just crossed the high iron bridge across the Meherrin river near Granby yesterday, when the abutment pillars and two spans of the bridge gave way. The couplings broke and 10 cars loaded with miscellaneous freight fell into the river. The cars filled the break in the bridge sufficiently to check the caboose, in which were the conductor and flagman. To this circumstance is due the fact that no loss of life occurred. The fast Florida vestibule train went over the bridge just ahead of the freight.

Train Robber Makes Escape.

Knoxville, Tenn., June 28.—Harvey Logan, the Montana train robber under sentence of 20 years, escaped from the Knox county jail this afternoon at five o'clock.

While his guard's back was turned Logan threw a wire over his head and lassoed him, tying him tight to the bars of his cage. Having one entire floor of the jail to himself, Logan next secured two pistols placed in the corridor of the jail for use by officers if needed.

When Jailer Bell appeared in answer to a knock from Logan, the prisoner passed out a bottle, saying he wanted some medicine. As the jailer put out his hand Logan covered him with a pistol, forced him to unlock the door and take him to the basement of the jail. Then he forced Bell to take him to the sheriff's stable and saddle the sheriff's horse. This done, Logan mounted and rode away in the direction of the mountains. A posse started in pursuit of the desperado within one hour.

Sheriff J. W. Fox tonight offered a reward of \$500 for the capture of Logan, dead or alive.

A MISTRIAL AT WILSON

Wilson, June 30.—The jury in the Jones murder case has been discharged and a mistrial declared by Judge Shaw. All is quiet.

SHOT FROM AMBUSH.

Negro Fired Into a Crowded Trolley Car.

Media, Pa., June 29.—Six persons were shot and injured in a trolley car between Media and Chester yesterday. A negro, who is believed to have been seeking revenge upon the conductor of the car who recently ejected him, discharged both barrels of a shot gun at the car as it passed through a lonely part of the country. The car was crowded and the shot coming from the dark roadside, caused a wild panic among the passengers, most of whom were women. Four of the latter were wounded in the arms and chest. The negro fired from ambush and in the excitement which ensued made his escape.

Injured in Falling Elevator.

Pittsburg, Pa., June 29.—Twenty-three persons crowded on an elevator in the establishment of H. J. Heinz, in Allegheny, were thrown from the 5th floor this afternoon. Sixteen were seriously injured. The St. George cadets, of the Bohemian Catholic society, who were visiting the establishment with hundreds of others, rescued the injured people.

PITT COUNTY LIQUOR

Said to be Responsible for a Murder in Beaufort County.

Washington, N. C., June 29.—In this county, near Latham's X roads last Sunday Dave Foreman was shot through the heart and killed. It is believed that a crowd of negroes who had been to a still in Pitt county owned by Jas. E. Clark, Jr., and who returned in various stages of intoxication, killed Foreman. Two negroes are in jail here pending coroner's inquest.

Narrowly Escaped Drowning.

Beaufort, N. C., June 29.—Mr. Joseph and family, of Goldsboro, who are at the Mansion House, came near being drowned today on Bird Shoals a quarter of a mile from this place. They were in bathing when one of them, a child, stepped into deep water and the others went to the child's rescue. They were all soon beyond their depth and in great danger of losing their lives, as none could swim. Palmer Davis, a colored boatman, who went to save them, succeeded only by good judgement and heroic effort. All were nearly exhausted and would have soon been drowned.

Emerson's Best Request.

The best thing that Emerson has left us is his spirit, fine and high, stern and sweet. He took life in a royal way, and bore himself toward the eternal mysteries with serene courage and dauntless hope. His essays, which are his most characteristic work, have their chief value not as revelations of the moral order of life, not as discoveries of the final meaning of things, but as disclosures of his own spirit. There is in these essays an immense mass of truth, uttered in picturesque and memorable words. There is in them also an immense mass that is not true. The Emersonian hit and miss are upon every page, and side by side with a golden and perfect sentence one finds sonorous eccentricity. The origin of this strange compound of oracle and imposition in Emerson lies in the confessional character of his writing. He speaks from within, and his generalizations hit or miss according as his personal experience embodies a law of humanity or a mere idiosyncrasy. That Emerson speaks so often and so royally for man is his great distinction. That he speaks so frequently for the idiosyncratic, the isolated and vain is his chief fault. We have a right to hold him at his best, and through the richness and majesty of the confession we are brought face to face with the confessor. —Rev. George A. Gordon, D. D., in Atlantic.

Corn Breeding Fields.

In breeding corn a small field usually an acre in size is used. The land is prepared and the seed bed treated as for the ordinary field. They are usually about 120 hills long and thirty rows wide. Each row is planted from a separate ear. The barren stalks, poor stalks and all undesirable stalks, such as suckers, are removed before the tassels appear. The field is protected or isolated, so that no mixture can take place from other varieties or from any source. In the fall these rows are husked separately, and the seed for the next year's crop is selected from the rows giving the highest yields per acre, of best composition, with the least barren stalks and of the best type. In this way the yield per acre of the variety is increased, the quality improved and the type preserved and developed. By this plan we are able to give personal attention and direct selection to the individual stalk and ear, which would be impossible in a large field.—Cosmopolitan.

A High Priced Fricassee.

Lord Alvanley, a noted wit and high liver in England a hundred years ago, insisted on having an apple tart on his dinner table every day throughout the year. On one occasion he paid a caterer \$1,000 for a luncheon put up in a basket that sufficed a small boating party going up the Thames. Being one of a dozen men dining together at a London club where each was required to produce his own dish, Alvanley's, as the most expensive, won him the advantage of being entertained free of cost. This benefit was gained at an expense of \$540, that being the price of a simple fricassee composed entirely of the "noix," or small pieces at each side of the back, taken from thirteen kinds of birds, among them being 100 snipe, 40 woodcocks and 20 pheasants—in all about 300 birds.

A Cool Soldier.

Remarkable for his self possession even in the most trying moments of battle was the famous Marshal MacMahon. One day he was dictating a letter to his secretary in the midst of an action when a shell from the enemy's camp fell directly upon his tent and exploded within a few feet. Pale with fright, the secretary sprang up, leaving his letter. "What's the matter?" asked the marshal. "The shell," gasped the frightened subordinate. "And what has the shell to do with the letter you are writing? Go on with your work, sir."

Bay Rum.

Bay rum is manufactured from the dried leaves of Pimento acris. Bay rum is procured by distillation and this in a very simple manner. The leaves are picked from the trees and then dried. In this state they are placed in the retort, which is then filled with water, and the process of distillation is carried on. The vapor is then condensed in the usual way and forms what is known as "bay oil," a very small quantity of which is required for each pinchon of rum.

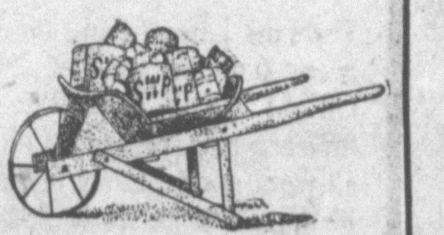

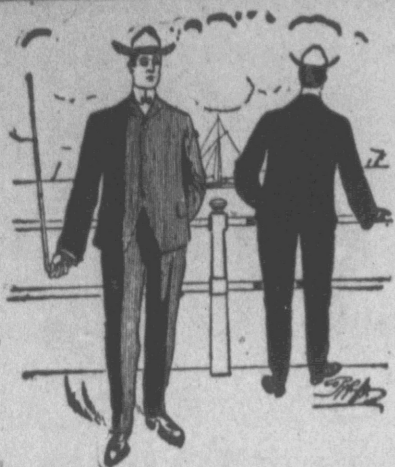
