The new board of aldermen were sworn in today and elected the following town officers:

The bond of the tax collector was fixed at \$5,000 and that of the treasurer at \$15,000. Liquor license was fixed at \$250 per year and licenses granted to all now doing business.

At the close of the last meeting of the old board Mayor Whedbee was presented with a handsome gold headed cane, E. B. Ficklen acting as spokesman.

Mayor Whedbee in his closing remarks to the retiring Board of Aldermen today spoke in the highest terms of the efficient service of Mr. C. D. Rountree, the retiring tax collector.

\$50,000 FOR NORTH CAROLINA EXHIBIT.

Raleigh, N. C., July 1.—U. G. Chatham, of Elkin, and S. B. Arendell, of Raleigh, will visit the various manufacturers of the state and urge that subscriptions be contributed to a fund for a North Carolina exhibit at St. Louis next year. The proposition is to raise \$50,000 and great confidence is manifested in the success of the movement. This course was determined on yesterday during a conference between Governor Aycock and a number of prominent citizens.

STABBED DRUNKEN SON TO DEATH.

Indianapolis, Ind., June 30—Bernard Quinn, of Richmond, 74 years, old stabbed and killed his son James early this morning. The boy had been drinking and demanded money from his father. A struggle ensued, in which the old man drew a pen knife and stabbed his son in the groin. Death was instantaneous.

ANOTHER COOK IN P. O. KITCHEN.

Washington, June 30—The bureau of corporations of the department of commerce and labor will hereafter play an important part in the postoffice investigations. Postmaster General Payne today had a long conference with Chief Garfield, of the bureau of corporations. It is understood that the bureau will aid in the investigation by securing lists of stock holders in various concerns which have contracts with the postoffice department.

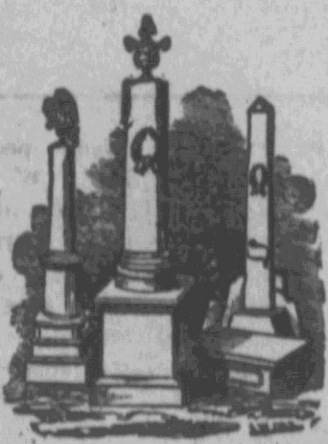

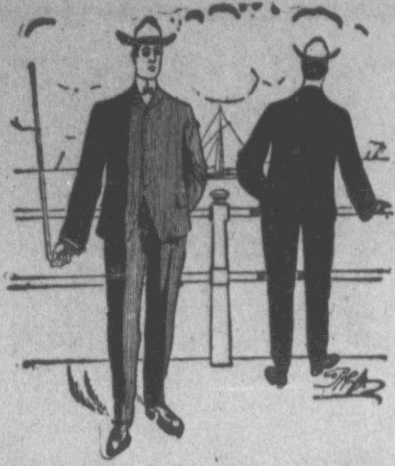

Christian Scientists at Boston.

June 28th, 1903, was an ideal day and will ever be remembered most joyously by the vast number of Christian Scientists from all over the world, gathered for the annual communion service of the Mother church.

Everything has been done for visiting Scientists. The great Mechanics Building, with its auditorium and assembly halls covering several acres of space, has been converted into a general reception room from 9 a. m. to 9 p. m. where thousands meet in good fellowship and love, exchanging greetings. Here is every convenience, information bureaus, etc., so that in a short while a vast throng, for there are more than fourteen thousand persons here, are making new friends.

One from Australia is shaking hands with a scientist from the South. From Manitoba, England and many foreign countries notable scientists are here, as well as from every state in the Union. Earl and Countess Dunmore from London with their two daughters Lady Victoria and Lady Mildred Murray are here, having with many others crossed the sea for this special occasion. It was most impressive to see the more than five thousand people seated at each of the three services. Most simple was the service, the subject of lesson sermon was selected by Mrs. Eddy, "Loving One Another." And the quotations as read gave all present most uplifting spiritual help, in contemplating the future when all the brotherhood of man shall have learned that love alone is the government that can withstand evil.

The hall is beautifully decorated in flags of every nation and red, white, and blue hunting, and altogether a happier scene was never seen than within the hall. One onlooker was heard to say that he never saw such a vast number of intelligent people of all classes together, and it seemed that all had come here to see how happy they could be. The most impressive moment of all was when the great crowd at invitation of the First Reader kneels in silent communion.

Two most interesting points in the service were a despatch from the church to Mrs. Eddy, and a letter from her to the entire church inviting them to be present at Pleasant View, her home in Concord, N. H., on Monday at 1:30 p. m. where she would greet them. This was an entire surprise, but an invitation which no doubt will be unanimously accepted.
