MOOT COURT.

The Teachers at Winterville Have an Interesting Division.

The second week of the Institute has closed, and judging from the work already done, it is to be expected that by the end of the fourth week great good will have been accomplished for the teaching force of the county.

The work of the institute is thoroughly practical, and it is to be doubted whether for the good of the average teacher, who needs an exemplification of real, practical work, the institute can be surpassed.

In order to give teachers, most of whom are ladies, an idea of the workings of our superior courts, Prof. Everett, the teacher of civil government, organized a moot court for that purpose.

So Friday night at 8:30 o'clock, the Superior Court Judicial District, with Judge William H. Ragsdale presiding, began its first session.

The most interesting feature of the opening session was the trial of a case which has gained widespread attention throughout the country, and which, indeed proved to be one of the most remarkable in the history of our courts of justice.

This case was a breach of promise suit for one thousand dollars brought in an action entitled "Kizy Anne Quattlebaum versus Tim Tompkins."

The scene in the bar of the court which greeted the eyes of the spectators was one of dignity, humor, and almost of pathos.

In front of the audience, commanding and dignified, rose the image of the judge. Over to the left sat the newly elected clerk, Mr. J. D. Cox, beaming and smiling, while here and there, bobbing about, Sheriff Everett was making preparations for the trial.

Attorney A. J. Manning appeared for the plaintiff and G. E. Lineberry, Esq., appeared for the defendant.

The trial having begun, the plaintiff called the following witnesses to testify: Miss Jemimy Jug, Miss Nelhe Pink, Mr. Hezekiah Cabbagehead, and Mr. Caesar Wiggins.

The plaintiff brought out evidence to show that defendant had made love to Kizy Anne Quattlebaum and that on the night of Sunday, July 29, between the hours of ten and eleven, he did very tenderly and affectionately make a proposal of marriage to the plaintiff and was accepted. This marriage was to take place on the Wednesday night following, but the defendant failed to keep his promise. Jemimy Jug and Caesar Wiggins both testified that they witnessed the proceedings on the front porch of the girl's dormitory.

Hezekiah Cabbagehead said he proposed to Miss Kizy Anne a day or so afterwards and was refused. He also testified that he couldn't help from loving her, and that she was very attractive.

Nelhe Pink testified that Miss Kizy Anne Quattlebaum was an old friend of hers, and that she had told her of the engagement.

Letters were introduced as evidence, and also a picture of the defendant, which was alleged to have been sent by him to the plaintiff.

The defense introduced Messrs. Marshall Mugwump, Sam Sanday, and Jim Slick, as witnesses, and brought out evidence to show that Miss Quattlebaum was an old maid flirt and that she was, at the time of defendant's proposal, engaged to Marshall Mugwump.

Afterwards, and before the day

set for her marriage to the defendant, she became engaged to Sam Sanday.

After listening to the eloquent appeals of the attorney, the jury brought in a verdict of \$100,000, which was reduced to \$1,000 by the judge, as the plaintiff only sued for that amount.

The defense has appealed and the decision of the higher court is awaited.

OPENING OF TOBACCO MARKET.

About 150,000 Pounds Reported Sold—Prices So Low as to Cause Much Complaint.

The Greenville tobacco market opened the new season today with very large breaks. It had not been expected that very much tobacco would come at the opening, as the farmers are so busy curing that comparatively little of the crop has been graded, and there was also such uncertainty about prices that most of them wanted to hold back until they knew about how it would sell, yet the first sale was considerably larger than had been anticipated.

Six out of the seven warehouses were ready to begin business today and each of them was well patronized. The other house, Brinkley & Hooker's, will be ready to begin sales in two or three weeks. Double sales will be run like last season so as to avoid blocking the market. The forces of the warehouses already in operation are as follows:

The sales in pounds as reported by the different warehouses were about as follows: Star 15,000, Liberty 15,000, Greenville 35,000, Jeffress 30,000, Parham 40,000, Farmers 18,000.

As was expected the prices opened very low and there is complaint among the farmers. Inquiries from other neighboring markets that opened today brings the information that low prices prevailed at all of them resulting in much complaint. It makes a poor outlook for the season so far as prices go, but as the trust has control of the situation it seems there is no remedy.

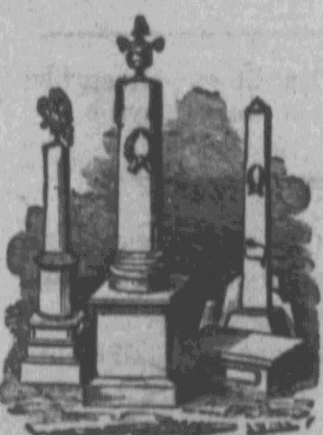

IS IT GOING TO BOLT?

Our contemporary, the Salisbury Truth-Index, is alarmed at the signs of a political revolution in North Carolina. It says:

The democracy has stepped out and fastened prohibitive laws upon the people without first giving them a hearing or an opportunity to say yea or nay, the prohibitionists (and upon their strength, and ability to fasten themselves upon the democracy, much will depend) claim to be beating the bushes on both sides of the road for recruits, are in reality driving democrats to join the state's old enemy in an effort to maintain the fundamental principle of all freedom and wealth—personal liberty, an inalienable and divine right. The effort to create morals by law and force may apparently succeed for a time, but for any question to be settled definitely, it must be upon a basis of right, of justice, of free speech and toleration (we were about to say "Christian" toleration, and really wish we could use the phrase, if it would convey the meaning it should) to all classes and conditions of society, so the permanent success of such an unnatural condition is not possible, and if successful at all time will soon find a way to again bring about normal conditions, just as surely and naturally as water finds a level. The heaven above mentioned is now creating conditions that will, unless speedily checked, bring about the overthrow of the N. C. democracy, or in other words, if democracy and prosperity of the Old North State are to go ahead hand in hand all undemocratic and unnatural allies must be shaken off, while on the other hand if a check is not accomplished, a bid will be made, and likely succeed, by enough voters to put the state in a position, again in the hands of the prohibitionists, who may check the progress of the state it will be a temporary, but the political change may be permanent, as

civil religious freedom must be.

Now we confess that we do not certainly understand this. The language is somewhat misty and vague. We suppose that the reference to a water level might just as appropriately be changed to that of a spirit-level. According to the spirit-level Truth Index finds that the prohibitionists are driving democrats to join the state's old enemy, which we presume is the republican party. Toleration is we also presume toleration of the distillery and the saloon. But while these democrats are supposed to be deserting, the democrats who are counting on the old party to aid them in the fight against the saloon, undemocratic and unnatural allies. It is further intimated that there are enough of these democrats who will join the state's enemy to put Russell and Butler in power again and that a bid will soon be made for these sterling democratic votes. Moreover it is broadly hinted that this change from the democratic to the republican party may this time be permanent, "as civil and religious freedom must be." Well, if the republican party in North Carolina is the party of civil and religious freedom, why is it the state's old enemy? Is the Truth Index going to bolt because of the Watts bill and the local option elections that are being called? We simply ask for information and the interpretation of a dark saying.—Charlotte News.

The Lime Juice Island.

Nearly all the lime juice used in the world comes from the tiny island of Montserrat, in the British West Indies. The lime grows wild in many West Indian islands, but only in Montserrat is it used commercially. That island is one vast garden of lime trees, and nowhere in the world is there a finer sight than its thirty miles of orchards, laden with the fruit of the lime or fragrant with its blossoms. The fruit is gathered by negro women, who carry it down the hills to the shipping port in big baskets on their heads. Like all West Indians, they are remarkable for their ability to carry heavy weights in this manner. Once the company which controls the lime juice industry sought to lighten the burden of its laborers by introducing wheelbarrows. The negroes filled the wheelbarrows readily enough, and then carried them on their heads as they had been used to carry the baskets. Many a negro woman will carry a hundredweight of limes on her head for a distance of a mile or more.—Indianapolis News.

Naming the House.

The custom of naming a ship when it is launched with the breaking of a bottle of wine on the prow is a survival of an ancient practice which had many forms. In early times, when the bottle of wine was broken on the ridgepole. The usage is mentioned in McLellan's "History of Gorham, Maine." It was the custom at a raising to break a bottle of spirit on the ridgepole and to repeat some rhymes, "naming the frame," as it was called. When, in 1839, Jacob H. Clement of West Gorham raised a stable, John Phinney, an old Revolutionary soldier who was present, repeated the following lines, which he said were used in naming the frame of Captain John Stephenson's house and barn, which were raised about 1775:

FOR THE HOUSE FRAME.
Cursed is the Tory's heart
Which from the congress laws depart:
If the laws they do not fear
I hope they will not prosper here,
And if the laws they do obey
I hope they will prosper in corn and hay

Chair Postures.

It is one thing to have a chair and another to know how to sit on it. The ideal of a graceful sitting posture has varied in the different ages of the world. The Egyptian sat bolt upright; the knees and feet closely pressed together. It was the ceremonial attitude. The Greeks and Romans, when they were at liberty to forget their dignity, sat stooping, with one or both elbows supported by the arms of the chair.

The Chinese ideal was with the knees and feet wide apart. They have maintained that attitude in sitting for 400 years. The Saxons and early Norman kings are represented in old manuscript and on coins in the same position. Down to a date comparatively recent, kings and queens received sitting stiffly on their thrones, any marked change of posture being thought to derogate from the royal dignity. They now receive standing.

A Legend of February.

Here is the pretty legend which tells why February has only twenty-eight or twenty-nine days. Long ago, they say, February was a gambler, and he was so unlucky that he soon lost all his money. Like other gamblers, he tried to recover it, and he said to his companion that if they would lend him some money he would give them as security one of his days. January and March, who were naturally associated with him more often than any of the other months, accepted his offer, and as poor February soon lost the money which he had borrowed each of them acquired one of his days. That is why January and March have each thirty-one days and February has only twenty-eight in ordinary and twenty-nine in leap years.
