### DID NOT BOYCOTT.

#### Merchants Association Expresses Sympathy for Farmers.

The Retail Merchants and Grocers Association of Pitt county met in the court house Thursday night, Vice-President H. L. Carr presiding, and discussed several matters of interest.

The first was in reference to the low price of tobacco and the proposed boycott against the American Tobacco Company. A communication was read from Kinston urging the adoption of the resolutions passed by the association in that town declaring a boycott against the tobacco trust.

The association did not take any action on the Kinston resolutions, thinking it unwise just at this time, but did endorse the idea advanced in resolutions adopted by the Raleigh association that the best plan to pursue is to refer the matter to the president and executive committee of the state association with the request to make such recommendations to each local association as they deem necessary. In this way the whole state will be working together instead of each local association acting individually in the matter.

At the same time the association expressed sympathy for the farmers in the present low price of tobacco and declared readiness to cooperate with them in any way to relieve and better existing conditions.

Another matter claiming the attention of the association was a communication from the authorities of the Atlantic Coast Line in response to the petition from the association for a double daily train on this branch of the road. The attitude of the railroad as expressed in this letter was to decline to put on additional service of any kind.

A motion was adopted to petition and secure the services of Senator Simmons and Congressman Small in procuring mail facilities seven days in the week.

Several new names were added to the membership of the association.

### Another Wreck on Southern.

Asheville, N. C., August 13.—A freight train was wrecked on Saluda mountain on the Asheville and Spartanburg road shortly after noon today under circumstances which were destructive in loss of property attended by deaths in frightful form. The train started down the southern side of the mountain and had only run a short distance, when the crew lost control of the train on one of the most treacherous grades, and thus uncontrolled, it swept on down the mountain until it came to a cut near Melrose, where the great landslides occurred a few months ago. Here the engine left the track and the cars carried forward by the mad mountain piled on top, filling the cut. Beneath this heap of wreckage the engineer and fireman were buried. A message received here tonight from Melrose reported that the bodies had not been recovered.

### Base Ball By Electric Light.

Richmond, Va., Aug. 13.—Manager Donati, the Richmond baseball magnate has arranged for ball games in this city by electric light. The first game will be played between the Richmond team and the Sioux Indian team next week.

There will be no good sidewalks or streets either if the rains keep up much longer.

### ROBBINS AGAIN.

#### The Old Man Came Near Losing His Job.

Washington, D. C., Aug. 13.—First-Assistant Postmaster General Wynne today received a letter from Postmaster Robbins, at Rocky Mount, N. C., in reply to a recent request from Mr. Wynne for an explanation of why he had recommended four members of his immediate family for positions under him in defiance of the civil service regulations. This case is the one which called forth the now well known poetical effusion.

In his letter Mr. Robbins says that the four members of his family named in the letter of recommendation have been employed in the Rocky Mount office for sometime, their compensation having been paid out of the postmaster's salary, and that he did not know it was a violation of the law to have more than two members of the same family working in the same place at the same time. He naively remarks "I thought it was in accordance with the policy of the administration to have employes of the postoffice of the same political belief and the Rocky Mount postoffice as conducted by me certainly meets with all the requirements of this standard."

Mr. Wynne has informed Postmaster Robbins that he may appoint the assistant postmaster and one of the clerks from his immediate family, but that the other subordinate positions under him must be filled by some other residents of the town of Rocky Mount. A postoffice inspector would have been sent to Rocky Mount Monday, but it was thought best to await a reply from Mr. Robbins to the letter of the postmaster general.

Mr. Wynne stated today that an inspector would be sent immediately to make an official investigation of the facts in the case. The humble letter of the postmaster has probably saved him his job. The postoffice authorities are disposed to let him hold on his lease of official life, but they will require him to drop off members of the Robbins family from the government employ. Only two of them will be allowed to continue in the service. At first there was a disposition to fire the postmaster himself for housing so many members of the Robbins family under the government roof. This decision has been abandoned, but it will be up to Mr. Robbins to select other republicans for clerical aids. It is said that there are no other white republicans in the town. This is of little consequence to the administration. The powers that be would prefer to see the negroes recognized and there may be a movement upon the part of Tarheel colored men to have members of their race appointed to positions in the Rocky Mount office.

### Jail Delivery at Washington.

Washington, N. C., Aug. 14.—A wholesale jail delivery occurred here last night, 15 prisoners making their escape. All of the prisoners were colored, two were under the charge of murder, one was a federal prisoner and the others were in for petty offences. The sheriff has offered a reward for the capture of the murderers. One of the county prisoners has returned and given himself up.

The prisoners had outside assistance in making their escape. A hole was cut through the brick wall and they crawled out. One prisoner remained in the jail, he being so large in size that he could not get through the hole.

J. WILEY SHOOK SLANDERED.

The Norfolk Landmark thinks the man who wrote the quatrain about the Robbinses in the Rocky Mount postoffice "must have studied the Junius business under the Hon. J. Wiley Shook." Why slander the statesman of Pigeon River like this? We have been painfully forced to oppose J. Wiley's political views, but we resent the insinuation that a study of his life or writings could produce anything as wretched as the quatrain referred to. J. Wiley has done some bad things, but never anything as bad as that.

The postoffice officials at Washington seems to have less talent in writing poetry than in getting rich at public expense. Nothing poorer than the Robbins poetry has appeared since the poem of Pension Commissioner Ware. That ran like this:

"Oh Dewey was the morning  
Upon the first of May,  
And Dewey was the Admiral  
Down on Manila Bay;  
And Dewey are the Regent eyes—  
Them orbs of royal blue:  
And Dewey feel discouraged?  
I do not think we do."

One of our noted humorists asked once: "Why will a grown man write poetry?" No answer to that inquiry has yet been vouchsafed. Even if any grown man should write poetry, it is certain that public officials should be prohibited from inflicting the public with their rhymes under severe penalties.—News and Observer.

Capt. E. M. Pace, a well known tobacco man of Wilson, writing in the Wilson News of the tobacco situation, says:

"So soon as the flurry is over and the money market resumes its wonted place, tobacco is going to sell well, and this will come about inside of about sixty days. I take it upon myself to say that you will get remunerative prices for your crop.

"Do you think these people have invested their hundreds of thousands of dollars in buildings to handle tobacco here in Wilson for pastime and play horses? Oh, no.

"The tobacco raised in Eastern Carolina cannot be duplicated anywhere on earth, and I still adhere to the proposition that our tobacco is in greater demand than any other raised—so there is no necessity for a 'scare.'

"Tobacco properly cared for at home is improving every day, and is equal to drawing interest upon a government bond. So you are not the loser by holding it for a reasonable time."

NEW RAILWAY AGGREGATION.

The arrangement by the Rock Island Railroad Company with the Seaboard Air Line, in addition to the "Frisco," brings into existence a monster aggregation which extends from Chicago to Denver and Fort Worth in one direction, from Washington city to Tampa and Birmingham in another direction, and from St. Louis to Oklahoma City, to Kansas City and the Rio Grande river, to Memphis and Birmingham in a third direction. It vies with the Gould, or Wabash system in the breadth of its aspirations, having connections with all the chief Atlantic ports and extending through the Gulf States to the Mississippi and far beyond. It may be said to approach the status of an east and west trunk line. In 1902 the Chicago, Rock Island, and Pacific Railway owned 3,219 miles and, with leased lines, operated 3,909 miles of road. The acquisition of the St. Louis and San Francisco gave in 3,095 miles more and the Seaboard Air Line has a mileage of over 2,600 miles, so that with recent building, purchases, etc., the Rock Island aggregation controls about 14,000 miles. It will doubtless be a pushing and aggressive element in the Southern field.—Baltimore Sun.

The Baltimore Sun says:

"Our excellent contemporary, the Edinburgh Scotsman, has been investigating recently the 'tobacco habit' from a medical and scientific standpoint. After reviewing the evidence, pro and con, it concludes that the temperate use of the fragrant weed in the form of a good cigar or a pipe is not injurious to the average man. Intemperance in the use of tobacco is undoubtedly harmful. The reason why cigarette smoking is worse than either the cigar or the pipe is that 'the smoker almost universally inhales the tobacco fumes, and, becoming habituated to this quick toxic action, he will not smoke without inhaling, for the same reason that the morphine habitue, accustomed to the hypodermic method, will not be satisfied with the drug through the mouth. Both victims want quick action.' On the whole, however, our learned Scotch contemporary concludes that, in the great majority of cases, if a man does not indulge excessively in tobacco he will suffer no injury from its use either mentally or physically."

Most any advanced school boy could have told you that. It takes a long time for people to appreciate the difference between use and abuse. A person can drink enough water to kill himself, but it is not argued that the use of water is harmful. "Temperance in all things" would go a long way toward solving some of the most vexing problems of the age.

The close relations that have existed between the president and Mr. Littauer will lead the public to mark the progress of this particular case with vigilant and unrelaxing interest, because his position in reference to it may furnish a fair index of the sincerity he feels in his professed wish to break up official corruption.—New Orleans Times-Democrat.

**Shot Him, Stole His Wife**

Charlotte, N. C., August 12.—Not satisfied with shooting Sam Huey in the breast, nearly ending his life, Will Harris, the negro desperado, who successfully evaded the guards at the penitentiary in Raleigh, last night succeeded in making away with Henry's wife. It seems that Harris has been in hiding in Mallard Creek section for several days. As was stated yesterday he went to the home of Sam Huey Monday night and had a talk with Sam's wife. Huey appeared on the scene and he received a bullet in his breast for his intrusion. Last night about dark Harris again went to the home of Huey and called his wife out. They held a hurried conversation and Harris departed. Later he returned and the woman left with him.

The neighborhood was aroused and Sheriff Wallace, with his deputy, Mr. E. O. Johnston, went out to Mallard Creek. They, with a posse of citizens of that section, went in search of Harris and Huey's wife. Nothing was seen or heard from either.

**The Registers Convicted.**

Wilmington, N. C., August 12.—Jabel Register and his father, H. B. Register, were convicted at Whiteville, Columbus county, today, of the murder of Jessie Sales and Jim Stally last March, and burning their houses down upon their bodies after robbing the premises of something over \$1,000. The younger Register was sentenced to be hanged on October 9th, and the father was sentenced to the penitentiary for life. Cross Edmunds, whose confession implicated the Registers and secured their conviction, was sentenced to six years. Register's counsel gave notice of an appeal to the Supreme court.

**A Hundred and Fifty Killed.**

Constantinople, August 12.—One hundred and fifty revolutionists were killed in the fighting at Sorovitch, August 9, according to official Turkish reports. The same dispatches, which have been communicated to the Russian and Austrian embassies, state that the insurrectionary movement is increasing daily.

Telegrams received today from Monastic announce that the town of Krushevo is still occupied by the insurgents. Four hundred Turkish troops with artillery surround the town and are preparing to attack and, if possible, re-take the position.

**Reported Destruction of Village.**

Salonica, Aug. 12.—It is reported that the Turkish troops on Monday bombarded and destroyed the village of Ekshisu, 28 miles south of Monastir.

According to another rumor the insurgents who have occupied Krushevo, after repulsing two assaults by the Turkish troops, offered a conditional surrender. Instructions were asked from Constantinople and in reply the Turkish commander received orders to give no quarter.

That attempt to assassinate M. Lombes in Marseilles is more of an international episode than was at first suspected. It was Italians who shot at the French minister and they used an American pistol.—Atlanta Journal.
