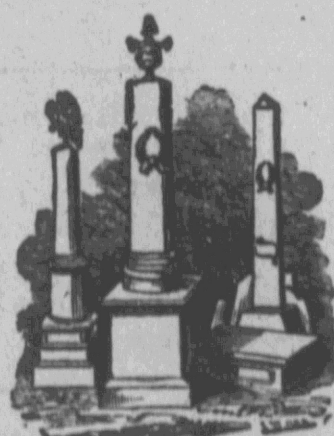

ASKED FOR BREAD AND WERE GIVEN A STONE.

Are the authorities of the Atlantic Coast Line practicing duplicity? It really looks that way from the lights at hand. Last December THE REFLECTOR printed articles on the congested condition of traffic on the Weldon-Kinston branch of the Coast Line and pointed out the need of double daily trains. These articles were endorsed by the Tobacco Board of Trade and had the approval of all business interest of this section. The result was that petitions signed by nearly every business man in Greenville, Winterville, Ayden and Grifton were sent to the officials of the Coast Line asking for improved transportation facilities along the line suggested.

Soon after these petitions were sent in Capt. W. H. Newell, division superintendent, came here to see about the matter. He called on THE REFLECTOR and talked over the matter in detail. He even went so far as to show us a rough diagram or schedule he had prepared to show how the suggestions made in THE REFLECTOR coincided with his ideas, and said he had for sometime been of the opinion that such a schedule as asked for should be inaugurated. He said further that while he could then make no definite promise as to time, owing to the disadvantage railroads were having in getting rolling stock, the additional train would be put on, yet he was sure it would be done as soon as the conditions would justify, which would probably be by the beginning of the fall season. There the matter rested for a time.

One day in June while waiting between trains at Parmele, we again met Capt. Newell there and asked him about the additional train. He replied that his recommendation had already been sent in to the company and he thought it would be put on by the first of October. We suggested then that the busy season would be on before October, but he said he thought that would be time enough for the train to be put on and had so recommended.

In order to hurry the railroad people if possible, the Retail Merchants and Grocers' association of Pitt county recently took hold of the matter and sent in another petition, asking in addition to the additional daily train that a Sunday train be run and that better depot facilities be provided at Greenville. This last petition seemed to show the position of the railroad officials and their reply indicates that nothing asked for will be granted.

This looks like flatly sitting down on the patrons of the road and riding rough shod over their petitions. The people may submit to such treatment, but THE REFLECTOR has doubts about their doing so without a protest.

That big Washington meeting "declaring that William R. Hearst, by reason of his attitude towards the trusts, is a man preeminently worthy to be the people's choice as president of the United States," does not make a bad outlook for the editor candidate.

THE COLOR LINE IN THE NAVY.

The drawing of a color line in the navy may have serious results. A few weeks ago open warfare took place between the white and negro sailors on a United States war vessel. The fracas took place not on the ship, but ashore at Bar Harbor, where the white sailors chased the negro sailors belonging to the same ship and beat many of them severely. On one of the ships a colored seaman was made petty officer and the other petty officers refused to mess with him. The Navy Department will not, of course recognize the right of white sailors to prescribe the colored ones. The President is bent upon keeping all the doors of hope wide open to the negro man. But nevertheless, the President will find this a different proposition from closing a Southern, postoffice or appointing negroes to high official position in the South. The inducements held out to get men to enlist in the navy are not brilliant nor alluring, and there has been from time to time difficulty in obtaining the requisite number of bluejackets. There is no law in this country for the impressment of sailors, and it is not likely that Congress would ever enact such a law in time of peace, even if it has the power to do so. Therefore the navy is dependent upon voluntary enlistments, and if the race feeling is to continue white men finding that they have to associate upon equal social terms with negroes in the close quarters of a ship at sea may refuse to enlist. Then, in such a case, the President may find himself face to face with this proposition—either to close the door of hope in the navy to the negro, or else to undertake have the sailors and marines of the navy an exclusively negro force. With such an alternative, it seems more than probable that the "doors of hope" would close.

There are now, and have been all along for many years, negro sailors in the navy, but no petty officers, we believe, until now. In the fore-castle there has never been any acute trouble between the races except, perhaps, a fracas from time to time. But the sudden flaming out of a fierce race feeling all over the country at this time has caused this serious condition, and it is just possible that the administration may before long have to exclude the negro race from the ships or else be reduced to negro sailors altogether. Under certain conditions negroes make good fighters, but that a navy, with all the complicated machinery

which has to be handled, having its entire force of enlisted men and petty officers negroes could be obtained. The proposition is it certain that a sufficient number of negroes could be obtained. The proposition may therefore be regarded as entirely impracticable, and if the race feeling becomes much more pronounced it may be that the negro will have to be excluded. Australia has gone so far as to refuse any contract to ships which employ lascars, and serious complications with the Imperial Postoffice arrangements are threatened. But the Australian Government stands firm and is determined to keep Australia a white man's country, free from race problems and race riots.

In the United States Army negro soldiers are put in regiments to to themselves and are kept entirely separate from the white soldiers. But in the naval service this is plainly impracticable. You cannot have white ships and negro ships, and white sailors and negro sailors must come together within the narrow confines of the forecabin upon terms of absolute equality, both social and otherwise. In the wardroom it has been the policy of the Administration, or, rather, the officials, to protect the naval officers from negro association. There is no admission to the ranks of the line of the navy except through the Naval Academy, and although several negro boys have in the past been appointed to the Academy not one of them ever graduated. Nor has a negro, as far as we are aware, ever been appointed to a staff position, such as paymaster, surgeon or chaplain. This is a wise policy, if it is policy, because there is at present a great demand for naval officers and the number would probably be sadly diminished by the introduction of a negro in the wardroom.—Baltimore Sun.

The question has arisen in New York: "Should ministers ride in automobiles?" Certainly not, unless they provide for their families beforehand with a generous life insurance policy.—Atlanta Journal.
