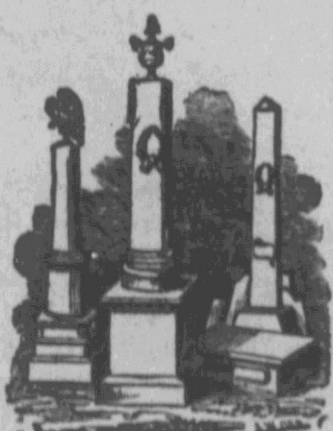

#### Deadly Murohy Branch.

Asheville, N. C. Aug. 24.—Five Sundays ago there was one fatal and one very serious accident on the Murphy branch of the Southern railway. Yesterday another fatal accident occurred. John Chambers, a young bra'eman, was killed at Addie, a small station in Jackson county. He was thrown beneath one of the cars and killed. His head was entirely severed from his body and he was otherwise mangled.

#### Dropped Dead in Choir.

Wilmington, N. C. Aug. 24.—Oscar Fulford, colored, member of a church choir, dropped dead last night during a meeting and the congregation was thrown into a great commotion. When the preacher announced the hymn the choir stood up to sing and Fulford fell back dead. The choir loft was the scene of much excitement and several of its occupants made a hasty retreat. The excitement was so great the parson was forced to dismiss the congregation.

#### Richmond Strike Declared off.

Richmond, Va. August 24.—The street car strike in this city which began June 17th was declared at an end today at a meeting of the union. When the strike commenced there were 650 men in the union. Of this number 150 have returned to work or have applied for reinstatement, 200 have left the city and many have gotten other positions, leaving about 300 who retain their membership in the union which is practically disrupted with the decision to call the strike off.

#### Train Wrecker Caught.

Charlotte, Aug. 24.—The man who changed the switch at Catawba Siding last Wednesday night which caused the wreck of a Southern railway freight is under arrest. His name is John Turner. He is a negro and is thought to be insane. Turner was arrested at Fort Mill and is in jail there. He made a full confession of his crime voluntarily.

#### Big Crowd Along.

Hatch Bros. are excursionists right. Their excursion from Kingston to Norfolk passed through this morning, and when the train pulled out from Greenville it did not look like there was room for another person to get on board. A large number of ladies went.

#### Still Baiting Negroes.

Des Moines, Iowa, Aug. 24.—Supposed white caps posted notices at Clive, a town on the Milwaukee railroad six miles west of here, warning the colored population to leave the community and threatening all white men who employed colored help in any way. Isaac Anderson, a colored man employed by the Milwaukee railroad, has been particularly harassed. An effort was made two nights ago to blow up his house with dynamite. The chimney and part of the wall were shattered, the family barely escaping alive. Two weeks ago an effort was made to burn him in his home. The colored population, numbering several hundred, is terror-stricken.

INFORMATION WANTED.

Our learned friend of the Statesville Landmark thinks, with THE REFLECTOR, that the salaries of our judges should be subject to an income tax.

In this case on one side is the constitutional provision prohibiting the diminishing of judges salaries standing out clear, brief and to the point; on the other side the purely theoretical argument that judges salaries OUGHT to be taxed. The Landmark says that some very able lawyers view the matter differently from the opinion given the Supreme Court by Attorney General Gilmer, citing the constitution and deciding that the judges salaries cannot be taxed. Will the Landmark kindly present the views of these able lawyers who disagree with the attorney general? So far we have been unable to find one single point which could in anyway have an effect contrary to the constitutional provision referred to. We believe that as a matter of right and justice the salaries of judges should be taxed, if other incomes are to be taxed, but our argument rests upon nothing but a matter of personal opinion as to what is right or wrong.

We quote the Landmark:

"The Landmark respects the opinions of the judges and lawyers who hold that the salaries of the officials mentioned are not liable to the income tax. But there is ample reason and good reason for believing that the constitution never contemplated such an exemption and the doubt should be resolved in favor of the state."

For the good of the cause, will our contemporary present the "good and ample reason" for believing that the constitution never contemplated such an exemption? Who shall say what the constitution MEANS when it SAYS as plainly as can be said:

Art. IV.—Sec. 18.—The general assembly shall prescribe and regulate the fees, salaries and emoluments of all officers provided for in this article; but the salaries of the judges shall not be diminished during their continuance in office.

"Lynching does not stop the crime but does stop the criminal," says the Morning Post. There never has been a law in all the world which prevented the commission of crime. The first two people in the world were the first law breakers and their descendants have broken every law enacted since that time. It is not laws we need, but lawful people.

By an order of the Board of Aldermen of the Town of Greenville adopted on Thursday the 6th day of August, 1903, notice is hereby given that there will be an election held in the Town of Greenville, Pitt County, N. C., on Tuesday, the 22nd day of September, 1903, according to the law and regulations provided for the election of members of the General Assembly at which the question of "subscription" or "no subscription" to the second mortgage bonds of the Raleigh & Pamlico Sound Railroad Company by the town of Greenville to an amount, which has been fixed, of \$15,000 will be submitted to the qualified electors of said Town that the Charter of the Raleigh & Pamlico Sound Railroad Company provides that the said Company may issue second mortgage bonds to an amount not exceeding \$3,000 per mile for the purpose of aiding in the construction of said Railroad the said bonds to bear interest at the rate of six per cent. and the principle to be due thirty years from the time issued. The Charter of said Raleigh & Pamlico Sound Railroad Company further makes it lawful for any county, township, city or town in or through which the said road and its branches may be located or which may be interested in its construction to subscribe to the second mortgage bonds of the said Railroad Company in such sums as a majority of the qualified electors of any other county, township, city or town may authorize. Such subscriptions shall be made in coupon bonds bearing interest at five per cent. the principle of said bonds to be due and payable thirty years from the date of issue. The election to be held on the said 22nd day of September, 1903, in the town of Greenville is to ascertain whether a majority of the qualified electors of said township favor the said subscription of \$15,000 of five per cent. bonds to the said second mortgage bonds of the said Railroad Company.

Notice is hereby further given that by order of the said Board of Aldermen of the town of Greenville, Pitt County, N. C., adopted on Thursday the 6th day of August, 1903, registration books for said election will be open for registration in the various precincts or wards of the said town of Greenville, Pitt County, N. More About Tobacco Willt.

Dr. F. L. Stevens, biologist of our state experiment station, is still at work on the tobacco wilt disease. Nothing has ever yet been published in agricultural or scientific publications about it, nor does it appear that the disease is known outside of North Carolina. Some of the farmers in the infected region have attributed it to insects some to the fertilizers, some to continuous cropping in tobacco, but it is due to none of these things. The cause is a microscopic germ found in the soil. These germs are so small that millions

of them could be put into 1 teaspoon. They multiply rapidly and may be carried by the plow or by ditches or on the horse's hoof to soil previously uninfested, there to increase in great numbers. No way to destroy the germs is yet known, but Dr. Stevens will experiment with different chemicals in the hope of finding a remedy. At present the only thing left for the farmer to do is to plant no tobacco on diseased fields until the germs die, probably in six or seven years—unless in the meantime a remedy is found.

This disease must not be confounded with the "sore shin," which causes the tobacco plant to fall over. With wilt the plant stands erect, while the leaves wilt as if the roots had been cut off. After making a full investigation Dr. Stevens will discuss this matter more authoritatively in our columns.

Just now he wishes very much to learn in what section of the state the disease exists or is supposed to exist. We earnestly urge every reader of the Progressive Farmer who knows of a probable case of wilt to write at once to Dr. F. L. Stevens, West Raleigh, N. C. He is employed by the state to investigate this matter, and should have the fullest co-operation of our tobacco growers. The profit will be theirs.

On July 22, the Tobacco Trust raised the price of American cigarettes in England fifty per cent. Two weeks later it reduced the price of its raw material in North Carolina more than fifty per cent—for later reports more than confirm our last week's conjecture as to this. The Tobacco Trust is powerful, but in America there is yet a mightier power. One of these days the trust, by its greed and oppression, is to bring itself into deadly and unequal combat with the people.—Asheville Citizen.

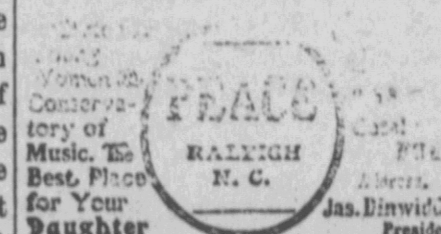
