BALKED AT TECHNICALITY

Governor Pennypacker Had His Law Clothes on When Sheriff Tucker Saw Him.

Deputy Sheriff L. W. Tucker returned Thursday night from Harrisburg, Pa., where he had gone with a requisition from the governor of North Carolina to the governor of Pennsylvania for the negro, Essex Staton, who is in custody in Philadelphia and is wanted in this county for murder. Mr. Tucker says that the reason given by Governor Pennypacker for not honoring Governor Aycock's requisition was that the crime had been committed over twelve months, and that no indictment had been found against Staton before the grand jury of Pitt county. On the other hand it looks like a state warrant for the apprehension of Staton ought to have been sufficient.

To Ginners and Cotton Planters.

The Southeastern Cotton Buyers Association last year sent out circulars stating that on account of excessive amount of bagging which had previously been put on cotton at the gins, and the fact that spinners had been billing back to the cotton merchants amount of excess bagging and ties above six yards of bagging and six ties to the bale; that all of the firms belonging to the Association would hereafter put a penalty of not less than 50c. per bale upon any bale which had upon it above six yards of bagging and six bands. This penalty to be increased according to the amount of excess bagging there may be six yards and six bands so allowed.

This action on the part of the members of the Association, which was participated in by practically all the buyers and cotton mills in the Southeastern States, had the effect of practically stopping the placing of excess tare upon cotton at the gins, as where bales were offered for sale showing excess tare, it was penalized in accordance with the resolution of the Southeastern Cotton Buyers Association.

Many other firms have joined the Association, and at the last annual meeting, a resolution was passed renewing the penalizing of bales showing excess tare in accordance with the above, and to send out circulars to that effect.

Farmers and ginners are, also, urged to protect cotton from the weather, as where it has been exposed to rain, and become damaged, the damaged cotton will have to be picked off or very heavy allowance made before the bale will be marketable.

FACTS ABOUT NEW RAILROAD

Letter from Officers of Raleigh & Pamlico Sound to Hon. Larry I. Moore.

As there seemed to be some misunderstanding about the disposition of the bonds to be voted for the second mortgage bonds of the Raleigh & Pamlico Sound railroad—at least some people thinking the town and township bonds would be delivered to the railroad company as soon as voted and the road might not be built—the following letter was sent to Hon. L. I. Moore to explain the matter and it is published that all may understand it.

HON. L. I. MOORE,
Greenville, N. C.

Raleigh, N. C. Aug. 29, 1903

DEAR SIR:—We authorize you to say to the people of the towns of Greenville and Grimesland and the townships of Beaver Dam and Farmville, if they shall vote to subscribe as follows: Greenville \$15,000, Grimesland \$2,500, Farmville \$7,000, Beaver Dam, \$2,500, the second mortgage bonds of the Raleigh & Pamlico Sound Railroad Company, it will be with the distinct understanding that the Greenville bonds will not be called for until the road shall reach to Greenville, that the Grimesland bonds shall not be called for until the road shall reach to Grimesland, and that the Farmville township bonds shall not be called for until the said road shall reach the town of Farmville, and that the Beaver Dam township bonds shall not be called for until the said railroad has been built in that township. It being fully understood that this instrument is based upon the understanding that the said railroad is at liberty to construct its line either via Farmville and Beaver Dam township and will then only accept the township bonds through such township said road will run. The Commissioners of Pitt county and the Commissioners of the towns of Greenville and Grimesland can hold the said bonds until the above is complied with. Or if the people of Beaver Dam, Farmville, Greenville and Grimesland shall prefer, the Raleigh & Pamlico Sound Railroad Company is willing that the said bonds should be placed in the hands of three trustees, one to be selected by the Railroad Company and the other two by the Commissioners of the town of Greenville, to be delivered to the railroad as soon as the above is complied with.

There is no question but that the interest on the railroad's 6 per cent second mortgage bonds must be paid by the railroad, which will more than take care of the interest on the town and township 5 per cent bonds. This being the case the railroad bonds will be more valuable after the construction of the road than the municipal bonds, and at maturity can be readily used to retire the latter. Hence it will not be necessary to levy any extra tax to pay interest on the municipal bonds or even arrange a sinking fund for the purpose of refunding them at maturity. The railroad will be about 110

miles in length, and if taxed at about \$8,000 per mile at one per cent will amount in revenue to \$8,800, which is more than the entire interest on all municipal bonds to be exchanged for railroad bonds. This amount of taxable property would be permanently on the tax list with a probable increase from year to year as the country develops and business of the road increases, and it should only be a few years before the railroad tax after paying the interest on the bonds, must leave a considerable surplus to the towns and townships subscribing to these bonds. This tax runs forever while the bonds are only for 30 years.

It looks like the towns and townships have nothing to lose but much to gain by subscribing to the second mortgage bonds of the railroad.

Fatal Renewal of Old Feud.

Suffolk, Va., Sept., 17.—Peter Odom, a white man 38 years old, was called out of his house near Newsoms, early this morning, and shot to death almost in the presence of his wife and children. Odom was awakened and called to the door. Shortly after Mrs. Odom heard two shots Odom was found in his yard unconscious and dying, one charge having taken effect in the head another in the breast. There is suspicion attached to two persons, one a resident of Southampton county, the other a man who recently escaped from the North Carolina penitentiary, where he was sent on the charge of shooting Odom six years ago. Blood hounds have been taken to the scene.

Woman's Betrayer Killed.

Salisbury, N. C., Sept. 17—Russell Sherrill, a member of a prominent family in western Rowan, was shot this morning by Calvin and Thomas White, both of whom are well known and leading citizens of Concord. The shooting was in consequence of the seduction of their niece, Miss Mamie White, a young woman socially well connected. The Whites received a letter yesterday from the mother of girl, whose father is dead, telling them of her ruin and imploring them to come at once. They left Concord yesterday and spent the night with Miss White and her mother, both of whom were distracted. They called at the home of Sherrill, who is 22 years old, at 6 o'clock this morning and insisted that he marry their niece.

Refusing to do so, he made a threatening move toward the Whites, who fired upon him, death resulting. The Whites are in jail.

Ruined a Horse.

After reaching home on Thursday evening's train Deputy Sheriff L. W. Tucker borrowed Mr. J. L. Mooring's horse and drove out to Mrs. J. J. Nobles', six miles from town, where Mrs. Tucker was staying with her mother during his absence. After reaching there Mr. Tucker started the horse back to town by his driver. It was quite dark, and along the road the driver met two other parties and they ran into his team. The shaft of the other buggy pierced the breast of Mr. Mooring's horse to a depth of 6 or 8 inches and practically ruined the animal.

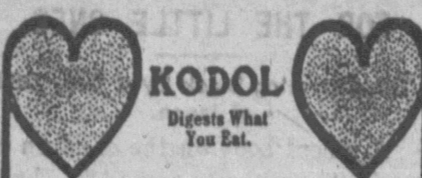

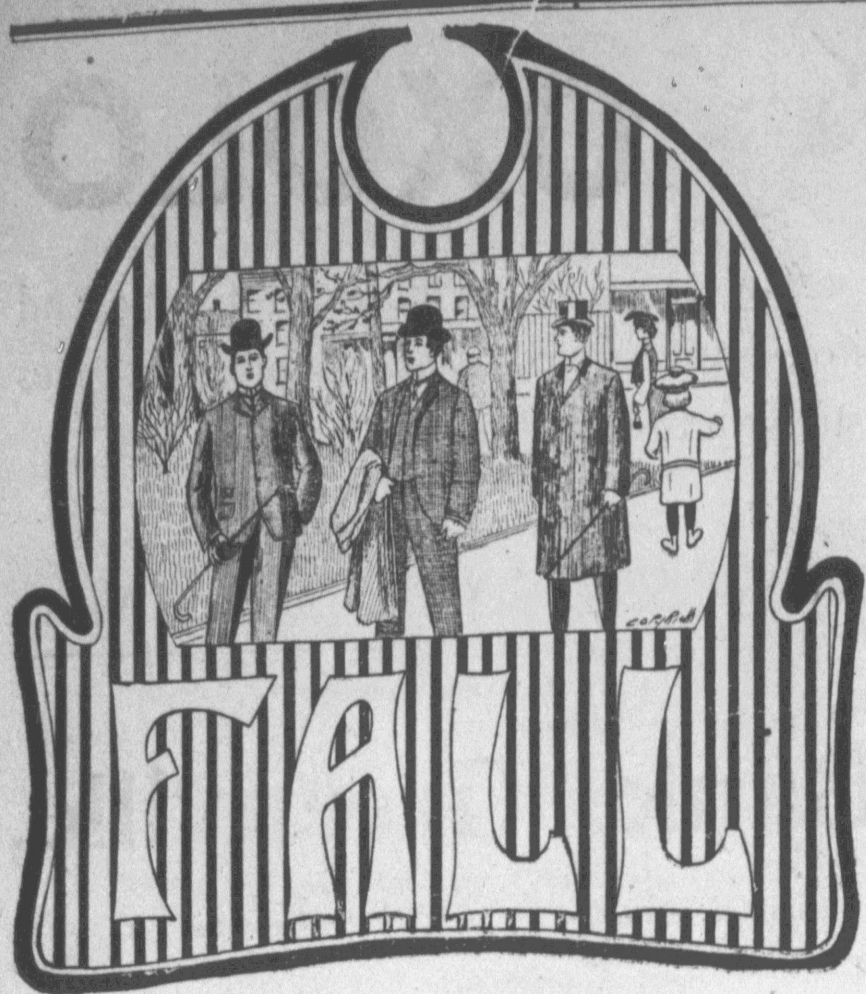
