A Very Large Opening.

The first session of the colored graded school convened at the colored graded school building Wednesday, with an attendance of 167. This school promises to open up a new future for our colored citizens. The principal, Chas. M. Eppes, has the reputation of being just the man to manage the education of colored at this crisis of our national life. He is polite, courteous and ready to give aid to the right men who are paying the great burden of the taxes by which the negro is schooled.

The faculty is as follows:

1st Grade—Annie Lee Enos.
2nd Grade—Annie L. Blackwell.
3rd Grade—J. H. Fleming.
4th, 5th, 6th and 7th Grade—Principal and Annie Enos.

Prof. W. B. Dove supervises the work done at the colored school, lectured to the colored pupils and emphasized the fact that the state, county and town was looking for the very best citizenship as a result of these schools, that they might be more useful to the city and state, to themselves and to the white people.

Prof. Eppes urged the necessity of showing gratitude to our friends for giving such an opportunity for development. Moreover, to show that the results of this work will laure to the uplift of our people and a help to this town. He assured, as did the assistants, that they were here to meet conditions as they exist among the races, laboring to make work and improved characters the chief aim, in seeking to build up the colored people of the county and cause the whites to feel that their taxes are well spent.

Another White House Crank.

Washington, D. C. Oct. 7.—John Decker, of Norwich, Conn., who is evidently about 44 years old, entered the White House soon after the doors were opened today. The officials thought from his actions that he was a crank and arrested him. He was not armed and made no resistance when placed under arrest. He was turned over to the police authorities.

Tillman Trial Goes On.

Lexington, S. C. Oct. 7.—Juryman Sharpe, though still a sick man, was able to serve today and the trial of J. H. Tillman proceeded, the state announcing it rested and the defense introduced witnesses. In general these testified to alleged threats against Tillman made by Gonzales.

Boy Scalded to Death.

Charlotte, N. C. Oct. 7.—The 3 year old son of James Robbins was fatally scalded by the overturning of a bucket of boiling water. The lad was playing in the porch and attempted to lift the bucket with the result that his head and shoulders were frightfully burned. He will die.

That the temperance sentiment is rapidly gaining ground in North Carolina is evidenced by the fact that since the legislature adjourned ten towns in the state have voted out saloons, while only four other towns in which election were held voted in favor of saloons and these by very small majorities. Several more towns will soon vote on the question. The whiskey business in this state is doomed just as surely as day follows night and may the time speedily come when there is not a saloon in our borders. The advocates of temperance have cause to feel encouraged in their efforts.

The coming on of another foot ball season makes the dealer in sticking plaster and bandages smile over the prospective increase of business. As a limb breaker and skin scraper foot ball is a great success.

It matters not what disposition the juries make of Tillman and Haywood—they are murderers, just the same, and the fact cannot be blotted out.

Some farmers are holding their cotton for the price to go back to 10 cents. It may or may not go back there.

We thought they were about to get enough of it, but New Bern is up against a street fair for next week.

The race is now on to see which fair will be the biggest. They are all big fakes.

Buchtel College, at Akron, O., is an obscure institution of learning, but the faculty has developed a case of nerve which entitles it to distinction. Every student in the college except three, who arrived too late, having violated the rules and participated in some of the customary opening rowdyism in the very teeth of the faculty, every student except the three has been suspended and sent home. Now if all the other colleges and universities in the country will refuse admission to these suspended students and if a few other institutions will follow the Buchtel example, we may have hope of bringing up a generation of young men with decent manners and reasonable respect for law, order and authority. Some vigorous home discipline might help toward the same good end.

Nobody wants to see a generation of milksops. It is necessary that our youth should have ample opportunity to exercise itself to work off its superfluous energy and endure a certain amount of danger and roughness to harden and develop it; but all this can be done without direct violation of the orders of the proper authorities or disregard of the proprieties and of the law.—Charlotte Chronicle.

An editorial in the Morning Post refers to Hon Joseph G. Cannon's home as in the state of Ohio. Uncle Joe hales from Illinois. He is too busy, or has lost sense of one of the tenderest emotions, to spend one day in his native county, Guilford, at the reunion of North Carolinians next week. Although born among Southern people, he seldom, if ever comes among the Southern people. His environments at least have taught him to train with another section and if he has a kind spot in his heart for his former home and the traditions of his people we have never heard of his expressing it.—Asheboro Courier.

Our contemporary, the Winston Sentinel, has information that a ten million dollar anti-trust tobacco trust is being organized to lend this amount to the Kentucky tobacco growers with which to buy this year's crop. We anxiously hope our Winston contemporary is correctly informed, and that the field of operation will be extended to other states than Kentucky. And we want to see this new candidate for popular favor not only elected but deserve to be elected by paying high prices to the grower regardless of what others pay or offer to pay. These people at least cannot afford, we must think, to take the farmers' tobacco at prices "fixed by the trust," and acknowledging to having "millions of capital" can have no excuse whatever for not raising prices at once. If the trust is getting the product too cheap—for less than it is really worth, judged by quality and supply—then this new anti-trust trust should at least set the example of paying the "full cash value" and thus shame the — trust.

We are not as optimistic with respect to these anti-trust trusts as our friend, the Greenville REFLECTOR, is pleased to consider us on things in general. We have had at least two, perhaps another or so, to blaze athwart the heavings with absolute certainty of permanency, with not only ten but twenty-five millions of capital just burning to get into the contest, and notwithstanding all the enthusiastic support the Post could give each as it appeared the prime promoter would get an office before he could draw his check and then the "demand" for the anti-trust trust would, like the Arab of an office-seeker, quietly fold its tent and silently steal away. We have thought this "dropping into office" was but another wicked trick of the more wicked trust to destroy the "people" to establish "competition that would compete." However the landing of the office generally ended in stopping the bunghole through which the anti-trust millions were just about to escape.

Now we hope that our Winston contemporary is not misled as to the deliberate and sticking purposes of the New York "syndicate" and that the promoters thereof or therein will not get office before the tobacco growers can get their cash.—Morning Post.

Mr. Carmack, the junior Senator from Tennessee, has decided not to introduce in the Senate this winter he proposed bill for the abolition of the Fifteenth Amendment to the Constitution of the United States. He does not retract anything he has said concerning the infamy and illegality of that part of the Constitution, but he simply thinks it is unwise to make an effort at this time to undo the great wrong that was perpetrated when that amendment was illegally tacked on to the Constitution. The Tennessee Senator is right. The time will come when the movement for the repeal of the Fifteenth Amendment will come from the North, where the infamy originated and in the meantime it is not hurting the South. That is one of the evils of the reconstruction era that we have succeeded in whipping around the stump. We can very well afford to let our Northern friends look to its repeal.—Greensboro Record.

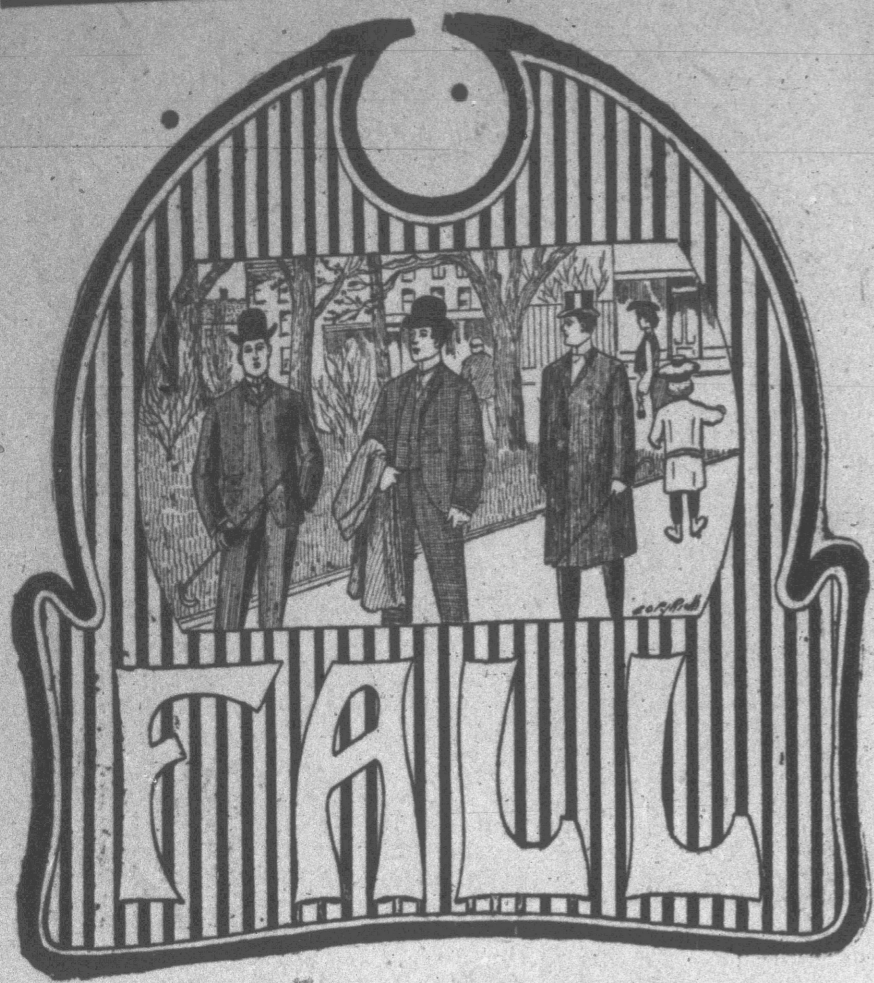
