### COUNTY MATTERS.

Proceedings of the Commissioners.

The board of county commissioners were in regular monthly session on the 5th, all the members being present.

The following payments were made from the treasury: For paupers \$175.75; county home \$178.65; elections \$59.15; conveying prisoners \$11.20; officer grand jury \$11, jury tickets \$451.95, boarding jurors \$32.25, court crier \$21; court costs \$190.35; court house \$7.95; witness tickets \$267.47; jail \$186.90; solicitor \$74; clerk Superior court \$204.47; attorneys \$50; pension board \$4; bridges and ferries \$136.15; road notices \$2.42; stationery and record books \$34, Register of Deeds \$29.22, commissioners \$66.80; stock law territory \$29.06.

L. Dancekik was licensed to peddle with one horse for one year.

G. O. Kosky was licensed to peddle on foot for one year.

M. mbs. of Greenville Volunteer fire company, of Red Hawk fire company and Rough and Ready fire company were exempted from poll tax for 1903.

The Greenville graded school was allowed use of the court house temporarily.

Monthly reports of the county treasurer and superintendent of health were examined and approved.

Green Patrick was added to pauper list to receive \$1 per month.

G. M. Mooring was ordered refunded the tax on \$148 personal property erroneously charged.

J. S. Clark was exempted from poll tax for 1903.

John Baker was hired out to Glasgow Baker at \$4 per month.

On the question of establishing a bridge across Tar river at Bensboro or Pillsboro, near Falkland, there was considerable discussion by representatives of each location. The board decided to locate the bridge at Pillsboro. Commissioners Spier and Horne for bridge and Commissioners Barnhill and Page against bridge. The vote being a tie Chairman Elks cast the deciding vote for bridge.

As a rule, farmers and their wives are happy in their comfortable homes, and have no desire to exchange lots or habitations with anyone.

### Anti-Saloon League.

New Bern, N. C., Oct. 6.—At a regular meeting of the city board of aldermen tonight Mr. A. D. Ward appeared before the board with a petition of over 300 qualified voters of this city, to ask the said board to call an election in the said city after due notice to vote whether New Bern should have saloons or no saloons.

They want prohibition and no dispensary. The petition was accepted by the board upon motion. The mayor appointed H. H. Bangert, B. S. Guion and C. J. McCarthy a committee to investigate the petition, look over the registration books and report to the board Friday night, when they will take action.

### THIS IS ABSURD.

Passenger and Mail Train Required to do the Work of Excursion Train.

From a hand bill issued by the Atlantic Coast Line advertising rates to the Weldon fair, from the 27th to 30th inst., we notice that on the four days of the fair train No. 59, running from Weldon to Kinston, will be held at Weldon until 5 o'clock p. m.

This strikes us as a very absurd and unjust arrangement, but we will give the railroad officials credit for making it without thinking of the inconvenience that will result. Here on a branch line where the numerous towns have the benefit of only one train a day, passengers, mail and express for these towns are to be delayed several hours just for a little country fair in which no one outside of Halifax county, unless it is the fakers, feels any special interest. Not only will the towns on this road suffer, but those on the Washington and Plymouth branches dependent upon connections at Parmele, will be subjected to the same inconvenience and delay.

There is another very serious trouble holding train No. 59 at Weldon during the fair will cause. At the same time the fair is in progress the North Carolina Christian Missionary convention, a body composed of people from all over the state, will be in session at Greenville. These trains being held late at Weldon will delay delegates to this convention several hours, which will badly disarrange the program of the sessions as well as be a great trouble to the people of the town who will entertain the delegates.

Surely the railroad officials must not have taken these things into consideration in making up the schedules for the fair. If they must have excursion trains for the benefit of the fair, we hope they will change their plans and handle the fair crowd on other trains and not interfere with the schedule of the one train a day on this road.

We notice also from the Weldon News that on the main line of the road special trains will be run, so that the schedule of none of the many passenger trains on the main line will be interfered with.

Goldsboro, Oct. 8.—The dead lock between the clergy and laity in the convention called to elect a bishop coadjutor still continues. It is probable that there will be no election until the council meets in regular session next May.

### Goldsboro's Glorious Victory.

Goldsboro, Oct. 8.—The prohibition election today resulted in a great victory for the Anti-Saloon League. The election was carried for prohibition by a majority of 249.

## MEMORY.

The task of all others that is most hopeless in this world is, to forget what we wish to forget. Is there a man or a woman in the world today who has not carefully buried a skeleton of the past—planted it away out of sight, heart and mind, and bade it stay, only to wake up from a dream of pleasant things and hear the dead and buried past knocking at the door, wandering up and down the chambers of the mind?

Some of you will call it conscience, but it is not necessary to have done wrong to be visited by memories of other days. A snatch of song, a word, a name, a book or flower—these bring trooping to the mind and heart scenes and incidents of other days that you would keep forever laid away. Vain desire, oh! mortal man! A man may hide from law, from justice, from men, but a man may not hide from himself. Memory serves us, guides us, and preserves to us the consciousness of pleasant things, but never does memory prove unfaithful to the darker thought. Perhaps it is best thus; surely none of us may say that we would give up our pleasant memories in order to escape the unpleasant ones.

The following from the Morning Post of Thursday we take as a good sign of good times coming on:

"Editor John A. Oates, of the North Carolina Baptist, passed through Raleigh yesterday afternoon on his way to the Mt. Zion Baptist association, which convened at Hillsboro Tuesday afternoon. He expressed gratification at the result of the dispensary election here Monday. Speaking of the general anti-saloon campaign in various parts of the state, Mr. Oates said he has just returned from several points in eastern Carolina where he was agreeably surprised at the growth of temperance sentiment, especially for prohibition. Especially was this the case in Kinston and Goldsboro. He was in high spirits over the general outlook."

In the death of General Bradley T. Johnson, C. S. A., which occurred this week at his home in Goochland county, Va., the South loses one of its best beloved sons. He was a true Southerner, a brave soldier and courteous, kindly gentleman. There are not many of the old Confederates left. Their ranks are melting away before a foe they never did fear, but who shall claim all in the end. But death does not conquer the brave, the good and true—it conquers for them.

We believe Boston is the port where the young women refuse to promise in the marriage service to obey their husbands. If a woman truly loves it is no hardship for her to obey. If she does not truly love, it doesn't make much difference whether the word is in the service or not; it will not have much to do with her conscience.

Washington is in the midst of a campaign against saloons. At public meetings there a number of the business men have arrayed themselves on the side of the saloons. Their argument seems to be based entirely on the dollar, while manhood and morality are left out of it altogether.

## A PIE CRUST PROMISE.

Mayor Smyth, of Charleston, S. C., was recently asked if the South had any preference for the presidential nomination. After expressing a personal preference for Mr. Cleveland, Mr. Smyth said:

"Mr. Gorman has no personal acquaintance with our people, and you know the personality of a man means a great deal with us. It is the same with Judge Gray of Delaware. The South has no candidate. It is anybody to beat Roosevelt, who is most cordially disliked on account of his attitude on the race question. Formerly he was popular with us. When he was in Charleston during the exposition he promised me in the presence of two other gentlemen that no colored man would be appointed to office in our state. He had hardly returned to Washington before he did the very thing he promised he would not do."

But doesn't it make you tired to read the above after reading of one of Theodore's high and noble speeches to the youth of the land?

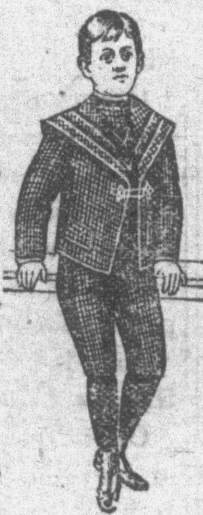
