#### Reunion of Mahone's Brigade.

Petersburg, Va., Nov. 6.—The parade in honor of the reunion of the survivors of Mahone's Brigade, which took place this afternoon on the Crater Battlefield, was a grand pageant and was witnessed by several thousand people. Those who took part in the parade were four hundred survivors, camps of Confederate veterans from all parts of the state, several companies of the 70th and 71st regiments of Virginia volunteers, Richmond Light Infantry Blues, Richmond Howitzers; Norfolk Light Artillery Blues, school children and fire department. Governor Montague, Colonel Jo Luce Stern and Judge George L. Christian, the latter grand commander of the grand camp of Confederate Veterans of Virginia, rode in a carriage in the parade. The banks and public and private schools were closed and business was practically suspended.

Passing up Market the four hundred survivors of Mahone's Brigade dropped out of line to be received and entertained by Mrs. Mahone and her daughter, Mrs. Wm. McGill, both of whom pinned badges on the lapels of the coats of each of the survivors.

At the Crater prayer was offered by First Lieutenant Commander John T. West, chaplain general of the Order Legion, which was followed by an address of Col. Wm. H. Stewart, commander of the Order of Legion.

It was a clear case of infringement of copyright, for, upon examining the photograph, there was found on it in almost unrecognizable print the copyright mark which gave the disputant title of ownership."

"How did it end?"

"Why, the company had to pay a royalty on every copy of the sheet that was sold and the legitimate owner scooped up a pretty good price for the firm's overlooking of a small but very important part of its business."

## DEDICATION DAY

### GREENVILLE'S GRADED SCHOOL DEDICATED THIS MORNING

#### REMARKS BY EX-GOV. JARVIS.

### The Entire Roster of the School Marched to the Building to Music by Osceola Band.

This was an eventful day in the history of Greenville. It marked the dedication of our splendid graded school building, an occasion that had been for weeks looked forward to with pleasure, and which will for years to come be looked back upon with pride.

This dedication today was the culmination of a determination on the part of our people to have a graded school, and it shows what can be accomplished when differences are put aside and the people unite in their efforts.

In February of the present year the legislature of the state passed a law giving Greenville the privilege of voting on the question of issuing bonds to the amount of \$10,000 to establish graded schools in the town. This election was held on the 9th day of April and was carried by a good majority in favor of the bond issue. At the same time a board of trustees was elected to take charge of the work of establishing and conducting the school.

These trustees went to work at once to carry out the wishes of the people. By the middle of the year plans had been matured and on the 20th of July ground was broken for the splendid building that was dedicated today, the entire work of construction being done in less than four months.

That the children might begin receiving the benefit of the school as early as possible, the school was opened in temporary quarters on the 7th of October, and today moved to the new building.

At 9 o'clock this morning the superintendent, teachers and pupils of the school met at the court house, and headed by the Osceola band, marched to the school building. It was an imposing procession, 270 bright, happy, children accompanied by their teachers, and the street was thronged with people to see them pass. At Five Points the procession was stopped long enough for Photographer R. T. Evans to take a picture of them.

At the building the pupils and people of the town filled the large assembly room in which the exercises were held.

After a selection by the board the audience sang "All Hail the Power of Jesus' Name." A selection of Scripture was read and prayer offered by Rev. A. T. King.

The pupils of the first grade sang a flag song, when ex-Gov. T. J. Jarvis, president of the board of trustees, made some interesting statements covering the progress of the work in getting the building and establishing the school. He pointed out the obstacles which the trustees had met and how each of them had been overcome. He emphasized the noble part taken by Mr. B. J. Cobb, one of the trustees, and the mention of this was greeted with loud applause by the audience. It was thought

that a sale of the \$10,000 bonds had been made and the trustees ordered the executive committee to go ahead with contracts for material and erection of the building.

After this was under way, owing to the stringency in financial centers the northern firm which had contracted for the bonds withdrew its offer. It was here that Mr. Cobb showed his magnanimity in taking the bonds himself and declaring that the work should not stop. Gov. Jarvis paid a splendid tribute to what Mr. Cobb had done. He also gave some figures showing the cost of construction. This building complete and furnished cost about \$12,750 and the enlargement of the building for the colored school \$750. After paying out the \$10,000 arising from the bonds the following indebtedness remains: To Biddick & House, contractors, \$800; architect \$200; balance on heating outfit \$600; desks \$500, chairs \$165; windows \$235; sundries \$375; making a total of \$3,475. To meet this arrangement had been made to borrow \$2,000 from the state school loan fund and the town aldermen had agreed to pay \$1,750 for the street that crosses the school property, and these sums will clear the property from all debt.

Mayor H. W. Whedbee followed in a splendid address, congratulating the town upon having such an excellent school and urging the cooperation of all parents with the teachers in making it a success.

"Ho, for Carolina" was sung by the children of the second grade, and County Superintendent W. H. Ragsdale made a most timely address. He said that not only Greenville but the entire county felt an interest in this school, for already an influence had gone out from it that was awakening educational interest throughout the county.

The entire audience joined the school in singing the "Old North State" and at the close of this Col. I. A. Sugg made a few happy remarks, telling the children that another feast, two barrels of apples, awaited them in the hall at the conclusion of the exercises.

Prof. Dove expressed his appreciation at the interest manifested by the people in the school, and after another splendid selection by the band the exercises closed with singing the doxology and benediction by Rev. W. E. Powell.

#### Teachers' Association.

In addition to the report of the Teachers' Association on Saturday, as published that day, a most interesting paper was read on "The Indian Massacre of 1711," by Miss Wylie, of the Greenville graded school. Prof. King, superintendent of the Ayden school, delivered a splendid address on "The teacher's duty toward the moral development of the child." Gov. Jarvis also spoke a few minutes on the relation of town and rural schools.

The next meeting will be held on Saturday before the second Sunday in December in the graded school building.

#### Money in Sweet Potatoes.

The following from the Williamston Enterprise show what a farmer in Martin county realized from one acre planted in sweet potatoes.

Mr. W. R. White has sold 60 barrels of yam potatoes at \$1.50 per barrel from one acre, and says that he will have at least 40 barrels more. To cultivate, fertilize and house the crop from this acre cost him not to exceed \$50; this leaves him a net profit of \$100.

THE DAY OF RECKONING.

Among other comments upon Judge Peebles and the Haywood case THE REFLECTOR recently printed the following:

"Judge Peebles is probably figuring on getting into some other kind of business when his present term expires."

Whereupon the Charlotte Observer comes back at us as follows:

"Having been for a number of years an interested spectator of the stage of life, and having noted with some care how the actors play their parts, The Observer makes bold to prophesy that if Judge Peebles lives until the expiration of his present term and desires a re-nomination he will get it and will not run fifty votes behind the ticket."

There are considerably more than fifty democrats of unquestioned loyalty in this county who have said that they would not vote to return Judge Peebles to the bench under any circumstances. These men are not liars or weaklings. They meant what they said, they mean it now, and having seen the last party lash put out of business, they will mean it on election day. There are thousands in North Carolina who hold the same views and have the courage of their convictions.

The Observer is in a position to know that Judge Peebles has been denounced and flayed to a frazzle by nearly every decent paper in the state. For all our contemporary's observations of the figures and characters that cross the stage of life, will it say that all this spirit of the press amounts to nothing? Will it say that the whole thing will be forgotten ere next election day?

If Judge Peebles can be nominated and elected again on the democratic ticket, then the power of the press of North Carolina is a delusion and a snare, and principles and convictions are no more. Will the Observer support Judge Peebles for re-election? Will our contemporary consent to smooth over the greatest outrage perpetrated upon justice in this state since the day of the Yankee carpet-bagger? Will it help to palliate a fault so grievous it brings the blush of shame to the cheek of a North Carolinian who loves justice and his country? Surely the Observer will do no such thing.

If it were advisable to keep the matter stirred up, we would contract to give the names of 100 good and true democrats in Pitt county who would scratch Judge Peebles if he were on a ticket nominated by the prophet Moses. But the vile thing is done now. Let it slumber till the day of reckoning, which, in this case, is election day. Then we shall see what we shall see.

The music of the earlier song books, only a few of which are now in existence, was written by a system of notation originating with the Shakers, and undecipherable by ordinary musicians. It consists of vertical lines and letters denoting various musical notes, placed in different positions beside the line.—Boston Herald.
