Kills Himself in Jail.

Wilmington, N. C. Feb. 3.—S.
Hill Terry, charged with the
murder of his son-in-law, George
Tate Bland, at the latter's home
in this city last October, put an
abrupt ending to his trial in pro-
gress in the Superior court here
this afternoon shortly after one
o'clock by committing suicide in
his cell in the county jail.

The weapon used was an old
case knife which had evidently
been sent him with his breakfast
from home this morning. The
blade was dull and gapped and
physicians who reached him soon
after the tragedy say that he
must have slashed his throat
several times. Death ensued in
fifteen minutes after the deed and
a few minutes after the surgeon
reached him.

An ugly wound three inches
long and two inches deep was
found on the right side of the
throat, the external jugular vein
and carotid artery having been
entirely severed.

THE WHISKEY QUESTION.

The temperance people of Greenville have set to work to deal with the whiskey question in a practical way and not after the dream of an ideal.

We can hope and preach and pray that the day may come when intoxicating liquor will not be drunk as a beverage at all, and that it will only be used by the sick and only be sold at the drug store as castor oil, quinine, morphine or any other drug or as poison is sold. That is the ideal dream and some day, let us pray, it will be a reality.

As sensible people we must deal with human nature as it is, and conditions as we find them. There are in our midst a large number of people who are in the habit of using stimulants and who are going to continue to do so. If they cannot get it at one place and in a lawful way they will get it at another and in a way forbidden by the law. Wisdom dictates that in dealing with these conditions we do it in a way to lessen the evil growing out of them as much as possible. Experience has taught us that a well regulated dispensary is the best method yet devised to meet and deal with these conditions. Hence we shall as best we can earnestly advocate the dispensary. THE REFLECTOR has always stood for the best interest of the town and has supported those things which make for the betterment of its people. Believing that the open bar room is the worst possible solution of the whiskey question and that a dispensary will be a vast improvement on the eleven open bar rooms in town, THE REFLECTOR will work for closing the bar rooms and opening the dispensary. In doing this we are continuing our good work for Greenville.

There are many views in which the dispensary may be presented. We shall from time to time present two views of it—the moral view and the money view. There is much that may be said in support of the moral view and we invite others to help us present this great question to the voters. We shall often be heard on it.

It is our purpose today to make a brief presentation of the money view. Section 16 chapter 233 laws of 1903 (commonly known as the Watts Law) reads as follows "that said dispensary commissioners shall make quarterly settlements with the governing body of said city or town, and that said governing body shall within ten days after such settlement, pay one half of the net profits of said dispensary into the treasury of said city or town, and the other half into the treasury of the county in which said city or town is located, for the benefit of the public schools of said county."

If a dispensary is established in Greenville and its management is placed in the hands of practical business men who are favorable to it, we think we can demonstrate that the net profits cannot be less than \$30,000 a year. One half of this amount will go into the town treasury to run the town government, to aid in the improvement of the streets

and meet its other current expenses. That will wipe out entirely town taxation, for there has never been collected from all sources, any one year, anything like \$15,000. We will continue the presentation of this view.

Now the farmers had better look before they leap. Cotton jumping up with such bounds since the middle of December has led most of the Southern planters to the intention of putting in for big crops of it the coming season—in fact not a few have absorbed the idea of planting nothing but cotton. But they had better think again. The decline of two cents a pound in two days shows that the high price of cotton is not a fixture, and that the bottom is liable to drop out at any time. Just so sure as an unusually large crop of cotton is made next season, this writer believes there will be trouble ahead of those planters who place their entire dependence on that one crop. The price of cotton is subject to too many whims, and experience teaches that the worst whim usually strikes when there is a large lot of it in the hands of the farmers.

As long as it is other people's money that is paid out, congress goes at the appropriation business with a slack hand. The senate was about to dish out \$4,600,000 to the St. Louis exposition without even a word of discussion, but almost at the last point Senator Bailey put in a protest. A few others of the members took sides with him and the proposition got a severe jolt. It will pass all the same.

Dr. Venable, president of the University, declined to join the literary societies in an invitation to W. J. Bryan to speak before the students at Chapel Hill. His reason for this is that "it was bad policy for the University to invite any prominent politician or candidate in election year." We are inclined to the belief that the doctor is right.

Things do seem to be gradually working around right. A Cleveland, Ohio, embezzler of bank funds has been given a sentence to the full penalty of the law—ten years in the penitentiary. Maybe it will be told some day of a verdict for murder being found by a jury.

The cartoon in the Charlotte Chronicle showing the effect the slump in cotton had on the Charlotte exchange created much merriment on the Greenville exchange. The boys declared the cartoon was a "true bill."

As a general thing, the people who are indifferent about what other people think of their worldly possessions do not lack for the comforts of this life.

There is room for improvement even in the best people, and it is just as well to contemplate the future hopefully.

The cotton exchange wanted some excuse for knocking down prices, so said war had been declared.

NOTICE OF A DISPENSARY AND DISTILLERY ELECTION.

Notice is hereby given to the voters of the town of Greenville that an election will be held in said town on Wednesday, March 2nd, 1904, in accordance with an ordinance adopted by the board of aldermen of said town at two special meetings of said board one held on Friday, January 29th, and the other on Saturday, January 30th, 1904. The ordinance so adopted is in the following language:

Whereas, a petition has been filed with this board, at a special meeting held on this the 29th day of January, 1904, signed by 104 citizens of the town of Greenville, asking that an election be ordered in said town to determine whether a dispensary shall be established therein, and whether the manufacture of liquors shall be allowed in said town.

And Whereas, it has been found after a careful investigation and verification of said petition with the registration books of the town, that said petition contains the names of one third of the registered voters of the town of Greenville who were registered for the preceding municipal election.

And Whereas, the law having been complied with, it has become the duty of this board to order an election and to fix the time thereof, therefore

The board of aldermen of the town of Greenville, in the state of North Carolina, do ordain,

Section 1. That an election shall be held in the several wards of the town, at the usual places therein on Wednesday, the 2nd, day of March 1904, at which the qualified voters of said town may, if they desire, vote upon the two questions set out in said petition, to-wit: First, shall there be established in said town a dispensary, Second, shall the manufacture of liquors be allowed within the corporate limits of said town. At said election those who favor the establishing a dispensary will vote a written or printed ticket upon which shall be written or printed the words "For Dispensaries." Those who are opposed to establishing a dispensary shall vote a written or printed ticket upon which shall be written or printed the words "Against Dispensaries." Those who are in favor of allowing the manufacture of liquors in said town shall vote a written or printed ticket upon which shall be written or printed the words "For Distilleries," and those who are opposed to allowing the manufacture of liquors in said town shall vote a written or printed ticket upon which shall be written or printed the words "Against Distilleries."

Section 2. That it shall be the duty of the registrar and judges of election at each voting place to provide a separate box for the voters on the question of dispensaries and a separate box for the voters upon the question of the manufacture of liquors, and the votes upon each shall be deposited in the appropriate box.

Section 3 That there shall be appointed for each ward in the town one registrar and two judges of election, who shall attend at their respective voting places on said 2nd day of March, 1904, and open and conduct said election according to law, and they shall make returns of said election to this board at its regular meeting on Thursday the 3rd day of March, 1904.

Section 4. That the registrars appointed for said election shall attend the usual voting place of their respective wards three days immediately preceding the Saturday next preceding the election. They shall remain at said voting place from nine o'clock a. m. to five o'clock p. m. during said three days with their books of registration, to register such persons as may be entitled to register.

Section 5. That the registrars appointed to conduct said election shall give at least ten days notice, of the time and place of registration, in one or more newspapers published in the town and at some public place in their respective wards.

Section 6. That the following named persons are hereby appointed as registrars and judges of election for these several wards of the town to hold and conduct said election, to-wit:

- First Ward—E. M. McGowan registrar and B. T. Bailey and B. H. Hearne judges of election.
- Second Ward.—K. Hyma, registrar and Allen Warren and Josiah Dixon, judges of election.
- Third Ward—L. W. Lawrence, registrar and W. S. Atkins and W. H. Smith judges of election.
- Fourth Ward.—J. G. Bowling, registrar and R. W. King and Z.

V. Hooker judges of election.

Fifth Ward.—C. D. Roundtree, registrar and Jesse L. Sugg and R. A. Nichols, judges of election. That the said election be held at the following places to-wit:

- First Ward—At Mrs. Nana T. Brown's residence on corner of Second and Pitt streets.
- Second Ward—At Mrs. V. H. Whichard's school house on Pitt street.
- Third Ward—At the court house.
- Fourth Ward—At W. J. Thigpen's store at Five Points.
- Fifth Ward—At the Centre Brick Warehouse on Dickinson Avenue.

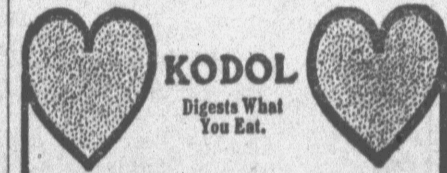

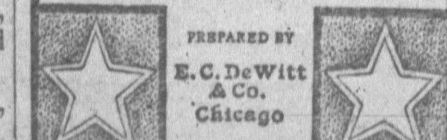
