The Money Side of the Question.

We recur once more to the
money side of the dispensary
question, and now present some
features of it not heretofore
touched upon.

We lay down this proposition
as absolutely true. A low rate of
taxation in a town encourages
the investment of capital, and
invites labor and business enter-
prises into that town. On the
other hand a high rate of taxation
sends these things away. We need
not argue these proposition. Every
sensible man will admit
both to be true.

Now let us look at the future
of Greenville and see how a dis-
pensary will affect the rate of
taxation. There has been issued
school bonds, \$10,000. The town
is now offering for sale improve-
ment bonds \$65,000. The town
has subscribed to Railroad Co.,
\$15,000. We hear the board of
aldermen are now considering the
question of issuing bonds for
building market house, \$10,000.
Probable total bonded debt \$100,-
600.

To raise a sufficient sum to pay
the interest on this debt including
expense of collecting and paying
out, will require a tax of about
55 cents on the \$100 worth of
property in the town. Then it
will require at least 30 cents on
the \$100 worth of property to run
the graded school. The present
rate of taxation for town purposes
is 66 1/2 cents, on the \$100 worth
of property. This cannot be
reduced if our streets are to be
kept even in a passable condition.
This gives us a rate of 15 1/2
cents, on the \$100 worth of prop-
erty, which is one and one-half
per cent. This is a heavy burden
of taxation, and one that is more
likely to repel than invite busi-
ness. It also means over four
dollars and a half on each taxable
poll. This will not be very in-
viting to the laboring man. Un-
less this rate can, in some way,
be reduced, we need not be greatly
surprised if, in the next few years,
we see some vacant stores and
dwellings in Greenville.

Now what effect would establish-
ing a dispensary have upon this
rate of taxation. We answer, it
would greatly reduce it if it does
not entirely wipe it out. We have
shown in a former issue of this
paper that one half of the net pro-
ceeds of a dispensary goes to the
town and in the same paper we
showed by facts and figures that
this sum will likely amount to
\$15,000. We confidently assert
that the receipts from the dispen-
sary with a very low rate of tax on
the \$100 worth of property will
meet all the town's obligations and
give, annually, a large fund for
improvements. A low rate of
taxation, electric lights, water
works, good streets and other im-
provements will certainly invite
capital, labor and a healthy,
steady progress. With a dispen-
sary we can have them all. With-
out a dispensary we cannot have
the low rate of taxation. Now
what say those who fear that a
dispensary will hurt the town in a
business point of view,

Elon college has just come in
possession of \$10,000 from the will
of Hon. F. A. Palmer, of New
York. This goes to the endow-
ment fund of the college. Elon
is one of the youngest colleges in
the state, yet it is constantly gain-
ing strength financially and
otherwise.

Dear Bro:

Your favor to hand. I am too
busy just now to write an article for
publication in regard to the effects
of prohibition in Durham. I have
only time to say that the man who
says that prohibition is killing Dur-
ham is either a knave or a fool. He
is either telling a lie of his own
making, or peddling one made by
other people. As for the man who
came to Durham looking for work
and found the town dead because
the saloons were gone; I think it
more than probable that no such
man has been here, and if such a
man has been here he was evidently
more anxious to get whiskey than he
was work. He found the saloons
dead and not Durham, and Durham
doesn't want any man as a citizen
who can't tell the difference between
a dead saloon and a dead town.
Durham is today the livest dead town
in North Carolina and if prohibition
has killed it, then it would be a
good thing from a business stand-
point to kill every other town in the
state in the same way, and at the
earliest possible moment. Really,
that old lie about prohibition kill-
ing a town is on its last legs, it can't
do duty much longer. Any man

who would believe it seriously now
ought not to be allowed to run at
large; he hasn't sense enough to take
care of himself, and keep out of
trouble.

Write to such men as Capt. J. F.
Freeland, Mayor of Durham, J. D.
Pridgen, S. R. Perry, W. H. Proctor,
three of the aldermen, and large
business men, if you would learn
whether Durham is dead or not as
the result of closing the saloons, or
write to R. H. Rigsbee, W. H. Mc-
Cabe, also business men. In fact you
might write to almost any one in the
town who believes in sobriety as
against drunkenness, the home as
against the saloon, and get practical-
ly the same answer.

THY KINGDOM COME

EXTRACT FROM SERMON BY REV. A. T. KING.

Few words are more familiar than those which you have just read. We learned them at our mother's knee in the long ago, and they are often upon our lips today. We all accept them as a vital, essential part of our creed.

Yet it is possible that there are few familiar sentences whose full import is less clearly apprehended by the average reader, for it has breadth and fulness of meaning that is world embracing, and that demands for its realization the exercise of all the churches of God on earth.

When we offer this second petition of the Lord's prayer, "we pray, that Satan's kingdom may be destroyed and that the kingdom of grace may be advanced, and ourselves and others brought into it and kept in it, and that the kingdom of glory may be hastened."

Even with an earthly kingdom, resistance must be overcome before full authority can be established, opposition broken before dominion can be extended and power enlarged.

So with the kingdom of God on earth, all the powers that oppose its progress must be just restrained, then reduced and then removed altogether before our kingdom can accomplish His lofty purpose and establish His dominion over all his foes.

Therefore, in order that "the kingdom of grace may be advanced," and "the kingdom of glory hastened" we pray first of all "that Satan's kingdom may be destroyed."

"Satan's kingdom"—an ominous term, betokening a still more terrible reality. Its resources are great, its agencies as varied as they are vicious and virulent and all these are jointly and severally attempting to stay the progress and thwart the gracious purpose of the kingdom of God.

First and worst among those agencies of Satan, and therefore chief among the foes of the kingdom of God in America, is the licensed liquor traffic. No other one thing has done so much to blight the home, and wreck the life, to hinder the gospel and destroy the souls of men as has the saloon.

Rum and ruin are synonymous terms, for the saloon causes man who supports it, and the community who permits it to exist.

There is no public question that claims the attention of our people at this time which can compare with this in far reaching importance and influence Wednesday March 2nd our people will be called to decide at the ballot box whether we shall have saloons in our midst.

The continuance of saloons, with all their corrupting and debasing influence, is the giant evil that threatens our country today. It is a question that affects every community that touches vitally the interest of every home in town and country, and therefore we offer no apology for discussing it.

We believe that the great interests of the kingdom of God, as well as the best interests of town and

country, demand that the saloons be forever banished from this community.

We oppose the saloon, first of all as a citizen on political grounds.

We do not use the term in any narrow partisan sense. Men of all parties and of no party all unite in declaring that this is not a question of party politics. We use the term "political" therefore in a broader and higher sense than that of mere party, and apply it to the character of the government under which we live.

The worst enemy of clean and representative government is the saloon. All of us have seen something of its corrupting influence. Many have felt its brutal tyranny and experienced its coarse and ribald abuse of all who dare oppose its power. Its whole personal and political creed may be summed up as selfish and insatiable greed; it "knows but one party and that is the one which will favor the saloon." "but one platform and that is immunity to the trade."

Mr. Jno. Worley, in a recent speech in the Baptist Parliament, brings a crushing indictment against the saloon, arraiging it "as a disturber of honest politics." Mr. Worley says in brief: "No condition of the day so seriously threatens every party and every policy as this traffic, which throws its weight of millions upon millions to this or that side solely with reference to its own perpetuity and profit. He is either expansionist or contractionist as are the legislative friends of the saloon. He will vote for the flag or its rival as the interest of his rum barrel may dictate. He has but one country, it is his saloon. But one standard, it is his license to sell. He knows but one policy, and that is to sell more liquor."

That picture is as true of America as it is of England. This is not an idle dream. We speak by the book. We state a grim and terrible fact and the saloon itself shall testify to its truth and accuracy.

Just a few years ago the North Carolina liquor dealers association passed this resolution. "Resolved, that this association will watch with the greatest vigilance the action of our representatives in the halls of legislature, holding them to a strict account for every vote, upon all the laws respecting our liberties and just rights and that we will use our united power and that of our friends to prevent the election of men of any party who are too cowardly to resist the allurements of our enemy, or too stupid to comprehend the vicious effects of sumptuary legislation."

In line with that resolution they have been for months past raising a campaign fund to be used this year in dictating nominations and determining elections in North Carolina. We have seen their circular, imposing a tax or assessment upon every wholesale dealer who sells within the state, upon every saloon, and upon every employee who stands behind the bar, declaring that they must "use their united power to prevent the election of men of any party" who will not submit to their dominations.

In other words they are cowardly seeking to control the government, to

NOTICE OF A DISPENSARY AND DISTILLERY ELECTION.

Notice is hereby given to the voters of the town of Greenville that an election will be held in said town on Wednesday, March 2nd, 1904, in accordance with an ordinance adopted by the board of aldermen of said town at two special meetings of said board one held on Friday, January 29th, and the other on Saturday, January 30th, 1904. The ordinance so adopted is in the following language:

Whereas, a petition has been filed with this board, at a special meeting held on this the 29th day of January, 1904, signed by 104 citizens of the town of Greenville, asking that an election be ordered in said town to determine whether a dispensary shall be established therein, and whether the manufacture of liquors shall be allowed in said town.

And Whereas, it has been found after a careful investigation and verification of said petition with the registration books of the town, that said petition contains the names of one third of the registered voters of the town of Greenville who were registered for the preceding municipal election.

And Whereas, the law having been complied with, it has become the duty of this board to order an election and to fix the time thereof, therefore

The board of aldermen of the town of Greenville, in the state of North Carolina, do ordain,

Section 1. That an election shall be held in the several wards of the town, at the usual places therein on Wednesday, the 2nd, day of March 1904, at which the qualified voters of said town may, if they desire, vote upon the two questions set out in said petition, to-wit: First, shall there be established in said town a dispensary, Second, shall the manufacture of liquors be allowed within the corporate limits of said town. At said election those who favor the establishing a dispensary will vote a written or printed ticket upon which shall be written or printed the words "For Dispensaries." Those who are opposed to establishing a dispensary shall vote a written or printed ticket upon which shall be written or printed the words "Against Dispensaries." Those who are in favor of allowing the manufacture of liquors in said town shall vote a written or printed ticket upon which shall be written or printed the words "For Distilleries," and those who are opposed to allowing the manufacture of liquors in said town shall vote a written or printed ticket upon which shall be written or printed the words "Against Distilleries."

Section 2. That it shall be the duty of the registrar and judges of election at each voting place to provide a separate box for the voters on the question of dispensaries and a separate box for the voters upon the question of the manufacture of liquors, and the votes upon each shall be deposited in the appropriate box.

Section 3. That there shall be appointed for each ward in the town one registrar and two judges of election, who shall attend at their respective voting places on said 2nd day of March, 1904, and open and conduct said election according to law, and they shall make returns of said election to this board at its regular meeting on Thursday the 3rd day of March, 1904.

Section 4. That the registrars appointed for said election shall attend the usual voting place of their respective wards three days immediately preceding the Saturday next preceding the election. They shall remain at said voting place from nine o'clock a. m. to five o'clock p. m. during said three days with their books of registration, to register such persons as may be entitled to register.

Section 5. That the registrars appointed to conduct said election shall give at least ten days notice, of the time and place of registration, in one or more newspapers published in the town and at some public place in their respective wards.

Section 6. That the following named persons are hereby appointed as registrars and judges of election for theseveral wards of the town to hold and conduct said election, to-wit:

First Ward—E. M. McGowan registrar and B. T. Bailey and B. H. Hearne judges of election.
Second Ward—K. Hyman, registrar and Allen Warren and Josiah Dixon, judges of election.
Third Ward—L. W. Lawrence, registrar and W. S. Atkins and W. H. Smith judges of election.
Fourth Ward—J. G. Bowling, registrar and R. W. King and Z.

Hooker, judges of election.
Fifth Ward.—C. D. Rountree, registrar and Jesse L. Sugg and R. A. Nichols, judges of election.
That the said election be held at the following places to-wit:
First Ward—At Mrs. Nana T. Brown's residence on corner of Second and Pitt streets.
Second Ward—At Mrs. V. H. Whichard's school house on Pitt street.
Third Ward—At the court house.
Fourth Ward—At W. J. Thigpen's store at Five Points,
Fifth Ward—At the Centre Brick Warehouse on Dickinson Avenue.
Section 7. That the mayor shall cause a copy of this order to be published in one or more newspapers published in the town.
