#### Sweeping Pension Ruling.

Washington, March 16.—Commissioner of Pensions Ware, with the approval of Secretary Hitchcock, today promulgated the most important pension ruling that has been issued in a long time. It directs that beginning April 13, next, if there is no contrary evidence and all other legal requirements have been met, claimants for pensions under the general act of June 27, 1890, who are over 62 years old shall be constituted as disabled one-half in ability to perform manual labor and shall be entitled to \$6 per month; over 66 years, \$8; over 68 years, \$10, and over 70 years, \$12; the usual allowances at higher rates continuing for disabilities other than age.

### MR. POWELL ANSWERS MR. PETREE.

#### The Greenville Minister Strongly Shows That the People of the Town Are Right.

Editor Watch Tower,  
LaGrange, N. C.

Dear Brother:—In last week's issue of the Watch Tower was an editorial on the dispensary question, in which the editor saw fit to anathematize all Christians who voted for the dispensary against the saloon. He sets himself up as a judge over his brethren, without according to them the right of freedom to act as they may believe.

In the first place, he begs the question, and uses the arguments that are not applicable to the situation existing here. He overlooks the fact that the saloon already exists here, and is not now seeking admission. His reasoning about the small-pox and the cholera goes wide of the mark. If the dispensary and the saloon both were out of the town, no one would think of trying to get either; but when the saloon, with all its attendant evils, is here running night and day, seven days in the week, what can be done to put an end to this matter? One is to banish it entirely, but when an attempt is made by temperance advocates they find it can't be done, as people have been educated to think it can't be done away with and look upon it as not so bad. Then what must be done? Leave the saloon to continue its work? No: do the next best thing—control it. If the small-pox existed in a town, what would be done? Not bother with it, but let it continue to spread until the whole town should be infected?

The first thing to do is to quarantine the person who has the pest; place a guard there to see that the patient is kept from spreading the disease, or establish a pest house. Then vaccinate those who are subject to the disease. But these are all bad things and we must not submit to the pest house or to vaccination, which are the less of two evils. This is what his reasoning leads to.

I should not notice this but for the fact that it has a vital connection with the issue which has recently been decided here in Greenville. In his editorial of March 11th, he speaks of the people of a certain town (meaning Greenville) taking exceptions to the editorial of last week. I want to say that no one cared anything about the editorial when that appeared. It was the same article mailed here to be used by the saloon advocates two days prior to the election and four days before the lower appeared, and circulated all over town by the saloon men that we complain of. Why Brother Petree should make himself so officious at such a time and in behalf of the saloon men of Greenville, perhaps can best be answered by himself.

He would leave the impression on the minds of the Tower readers that the brethren in Greenville are a set of drunken beer-guzzlers, and didn't want to get whiskey away from town, while nothing is further from the truth. I do not believe, if the question of dispensary or absolute prohibition should be before the people tomorrow, there would be a one who would not vote against the dispensary. As to his question about whether Jesus would have voted for the dispensary or not. I am certain He would not have voted for the saloon or aided and abetted to secure a victory for them against the dispensary.

I would like to ask of what ground a man can abuse others for doing something which he considers

There is one thing certain, that no one is answerable to any other than to the Judge of all the earth, and whether Brother P. would vote for the dispensary or the saloon is a question for him to answer, and accord to others the same right that he would enjoy himself.

## IN THE DARKNESS

As to fear in battle, we all had an attack of "nerves" now and then, even up to the colonels, but as for being downright scared I had a couple of experiences I will tell you about. If I hadn't been alone at the time I should have probably been drummed out of the army for cowardice. There was one thing I dreaded more than a battle, and that was standing on picket alone at night.

On the night I have in mind I was stationed about twenty rods north of a log cabin occupied by a farmer's family, and the Confederate picket was supposed to be about the same distance on the other side. I was not on the highway, but in a fringe of bushes along one line of an old field. It was a darkish night in autumn, with a breeze kicking up a shindy all around, and when I was told to fall out at Post No. 6 and keep my eyes and ears open I got homesick at once.

The first thing I did was to move along the fringe about thirty feet and then lie flat down. I could see out across the field in the direction of the house and the Confederate picket, though but dimly. There was no light in the house, and no sounds came from it.

I hadn't been on post thirty minutes when I had a regular attack of "nerves." I didn't realize it until I found myself chattering and trembling and half crying, and then I got up and kicked myself and did some tall swearing. I fully realized that I had to break the spell or bolt, and there was a hard fight before I got the better of my nerves. I was feeling much easier and was thinking of going back to the spot where I was first posted when I suddenly caught a sound which jumped my heart into my mouth and shook me from head to foot with a chill.

I saw a figure and knew that some one had stood within arm's length of me, but had my life depended on it I could not have raised a finger. I choked up and gasped for breath, and it seemed as if I waited for hours to be attacked. It slowly dawned upon me as I waited for a blow that it was a woman's figure, and after making half a dozen efforts to do so I managed to ask who was there and what was wanted.

It was well for that woman—for woman it was—that I was unnerved by my fears. There was a spring within a few feet of me, though I had not been told of it, and she had come down from the house for water for one of her sick children. She did not know the exact location of the post, and instead of making her presence known and escaping all peril she had come silently along and escaped death simply because I was unnerved. When I came to discover who it was in front of me I was that weak that I had to sit down on the ground, and the woman went back to the house trembling in every limb. I never should have got over the remorse of it if I had shot her down in the darkness, nor could I have hoped that her children would ever have forgiven me.

At another time, about a year later, I had a post in an old cotton field. It wasn't open ground as much as it was bushes, and along the south front of it was a fallen tree. Here was the post, and crouched down behind the tree, with my head just above it, I could scan the ground between the Confederates and my burrow.

After I had been on post about half an hour the night thickened up with a sort of mist until I could not have seen a man ten feet away. Then I rose up and took a seat on the log and lighted my pipe, and I had worn away an hour of my time when my heart suddenly gave a jump and I began to tremble.

I had neither seen nor heard anything to alarm me, and I couldn't make out why I should be knocked over that way all at once. I didn't stop there very long to think the matter over, however. On the contrary, I slipped backward off the log into a tangle of bushes and briars, and there I meant to remain until I heard the tramp of the relief.
