Free Delivery Carriers Have the Right of Way.

The Rural Free Delivery News has the following interesting piece of information:

It would be well for drivers of wagons to remember that all United States mail carriers have the right of way in public highway when on duty. They cannot be driven into the ditches by heavy loaded wagons without violation of the United States mail law, and if a collision is made by so doing and the mail delayed it will not be long thereafter until a deputy United States marshal will be looking for certain parties who will answer to roll call at a U. S. court. This law applies not only when meeting a vehicle, but applies to those in front of the mail as well, when the mail makes an effort to pass.

The Helpful Spirit of Co-operation.

Few people in Kinston realize the value to the community of the mills that have been established in our midst. They give employment to a large number of people and are a source of much revenue to the town.

The truth of these statements is forcibly impressed by a reference to the cotton and knitting mills in our town. It is stated on good authority that these mills are paying an average of \$52.00 a day interest and dividends on preferred stock and bonds on every week day in the year. Not only this but these two industries afford employment to 425 employees who are paid an average of \$215.00 a day for every day in the year.

This statement makes very satisfactory reading to Kinstonians, and the satisfaction is heightened by a recollection of the fact that the industries in question are fostered entirely by local capital. While foreign capital is welcomed here with the glad hand, we feel a peculiar pride in those prosperous industries that have been built up and sustained by our own citizens.

Nothing shows a healthier spirit, one making more surely for progress and development, than the willingness and even eagerness of our people to co-operate in local enterprises. It is much better for our people to invest their savings at home than to send them abroad. The returns from a safe investment at home are surer, and the whole community is uplifted by the success of invested capital in its borders.

This spirit of co-operation is to be nourished diligently. And it is to be hoped that our people will of themselves from time to time establish several new industries that would flourish if once established in this community.—Kinston Free Press.

There are thoughts in the above that Greenville might well consider with profit. More co-operation enterprise would be a good thing for town.

The American Red Cross Society is rent in twain. Definite charges of mismanagement have been filed against Clara Barton and her coterie of friends by a large majority of the directors,—an eminent and honorable body of citizens. They found that not less than \$715,000 have been collected and that no part of it was ever received or disbursed by the treasurer, and that the accounts, if accounts were kept, have never

been audited. There have been no public reports of receipts or expenditures. Money paid in has been used for anything that the President wished to use it for, without consultation with the directors. It is charged that the charter of the society has been grossly and repeatedly violated.

USE LETTUCE DAILY.

Then, Says a Medical Journal, You Are Proof Against Smallpox.

Don't forget that lettuce is a preventive of smallpox.
So far as it is possible for a human being to be protected from catching smallpox lettuce is a protection.
No need for vaccination whatever. Any person who eats a small quantity of lettuce twice a day, morning and evening, is as well protected against smallpox as it is possible for any one to be.

To be sure, one ought to be clean, ought to live in ventilated rooms and avoid dirt of all sorts; also avoid contact with people who have smallpox. Foolish exposure to the contagion of smallpox is not to be thought of. But there is no need for vaccination.

Go calmly on about your business. Provide a small quantity of lettuce morning and evening, and you can feel sure that you have protected yourself and your family in the best possible way against smallpox.

Lettuce is one of the oldest vegetable remedies known to the medical profession. Long before it was used as food it was used as medicine. Many times it has been claimed that it has magical or miraculous powers to prevent contagious disease. We believe this is carrying matters altogether too far. But lettuce does furnish to the system exactly what is needed to protect it against the poison of smallpox.

We defy any one to produce a case of smallpox that has been contracted by any person who made daily use of lettuce as a food. If there is any such case on record we would be glad to hear of it.—Medical Talk.

Got His Desserts.

Mr. Jones had just taken a high degree in a secret society to which he belongs and which carries on its meetings in the still hours of the late night and early mornings. It was 3 a. m. when he reached home and found Mrs. Jones, contrary to custom, sound asleep.

"Jephthah," she said in a voice that chilled him like a Manitoba cold wave in January, "when a man comes home at this hour of the morning and says he is a prince of Jerusalem, there is something the matter with him, and he should be treated accordingly."

And he was.

Results of Inquiry Into the Antiquity of Agriculture.

Few persons realize what a wealth of interest is to be found in the study of the history of cultivated plants. Agriculture must have been one of the first steps in civilization, when man began to give up the nomadic habit and claim a permanent residence as "home." Horticulture would follow at no very distant date, still as an adjunct of home, so it is no wonder that the two arts are invariably associated with that most expressive monosyllable so suggestive of peace, rest and affection. One eminent botanist, Alphonse de Candolle, spent years of incredible labor and research in this study, and one of his monuments is his work on the "Origin of Cultivated Plants."

As a single instance of the interest to be found in this study just glance for a moment at one of our cereals. The cultivation of wheat is lost in the mysterious past. Ancient Egyptian monuments, far older than the Hebrew Scriptures, show that the Egyptians had grown this plant for so long a time that the cultivation was thoroughly established. They ascribed the gift of wheat to their goddess Isis. Rice was grown in China so long ago as twenty-eight centuries before the Christian era, for in a ceremony instituted at that period the emperor had to sow rice once a year with religious rites. Barley and millet also go back to the distant past of the early men who built the lake dwellings of Europe. Oats followed later, and later still came the cultivation of rye. Maize was grown to such an extent that varieties were recognized when Aztec monuments were raised. 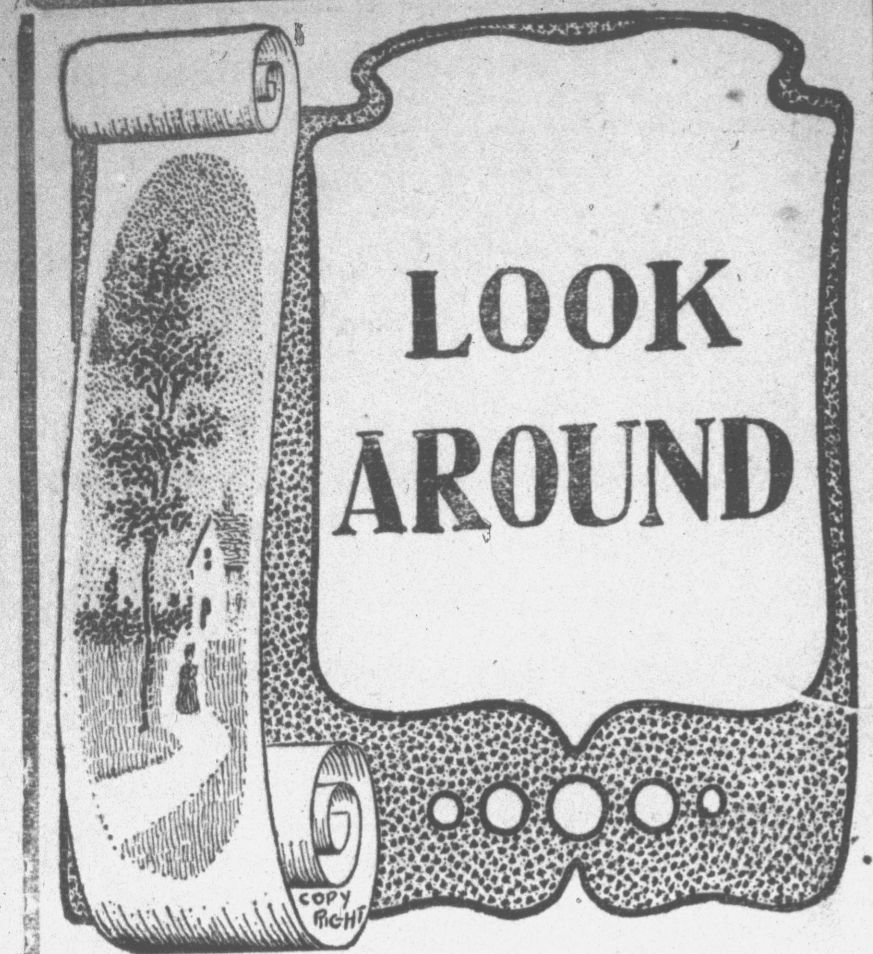
