MONDAY AFTERNOON, MAY 2, 1904.

This is the month for town politics. Election first Monday in June.

Weather prophet Hicks marks May as a stormy month with many sudden changes.

Durham now has hopes of getting that union depot, since the laying of brick has begun.

If you did not pay your poll tax the grandfather clause will be no help to you in voting this year.

The world's fair at St. Louis opening just after congress adjourned did not leave the public long with nothing to fix its attention upon.

A writer in The Scientific American gives what he claims is said to be an effective remedy for banishing the boll weevil. It is simple enough:

"The boll weevil, the pest of the cotton plantation, can be positively eradicated by planting cow peas broadcast over the lands where they existed last year. It is stated that they cannot live where the peas are growing, and if such is the case, and as the remedy is so cheap, every cotton planter should provide himself at once, because, it is worth trying, and in addition there is no better fertilizer in the world than cow peas."

Important, if true. The Dallas News says the foregoing was submitted to L. O. Howard, chief of the United States department of agriculture, who replied:

"The cotton boll weevil will not breed in cow peas. Therefore, land planted one year in cow peas, if examined the second year, the boll weevil will not be found. If cotton is grown in an adjoining field, the weevil will be found in its usual numbers. The cow peas exert no deterrent effect against the cotton. They are probably not as valuable for rotation purposes as other crops."

Satisfied With the Watts Law.

Just now certain newspapers and a few small calibre politicians are trying to stir up discontent about the Watts liquor law. The little politicians are trying to make an impression that the country people are dissatisfied about it, saying that the law as it is disfranchises the country people in the matter of regulating the liquor traffic.

We do not believe that the country people are dissatisfied with the Watts law. It takes the country groggeries and distilleries away from their doors and puts them all in the towns where they can be governed by police force. The people in the country districts have too much sense and enjoy quiet and security too much to raise objection to the removal from their homes the many evil influences that cluster about the open distilleries and the ungoverned dram shops.

It is a weak attempt to start a stir just before the time for nominating men for the General Assembly, and the good people of the state, in the towns and in the country, who love order and favor temperance should pay no attention to such a racket except to keep their eyes open and be ready to meet every unfair turn the whiskey interest may take.—Scotland Neck Commonwealth.

DEMOCRATIC PLAN OF ORGANIZATION.

1. The unit of county organization shall be the voting precincts. In each precinct there shall be an executive committee, to consist of five active democrats, who shall be elected by the democratic voters at the several precincts in the meeting first called by the county executive committee. And said committee so elected shall elect one of its members as chairman, who shall preside at all committee meetings.

2. The chairman of the several precinct committees shall compose the county executive committee, which shall meet at the same time and place as the county convention first held in each election year, and elect a chairman of said county committee, who need not be a member of the committee, and he shall preside at all meetings of said committee, and shall hold his place until his successor shall be elected. A majority of said precinct chairmen, in person or by proxy, shall constitute a quorum. The county committee shall likewise appoint a central committee of five, who shall act in its stead when the county committee is not in session.

3. In case there shall be a failure on the part of any precinct to elect its executive committee for a period of thirty days, the county executive committee shall appoint said committee from the democratic voters of said precinct.

4. The members of the precinct committee shall elect to any vacancy occurring in said committee.

5. The county executive committee shall call all necessary conventions by giving at least ten days' notice by public advertisement in three public places in each precinct, at the court house door, and in any democratic newspapers that may be published in said county, requesting all democrats of the county to meet in their respective precincts on a common day therein stated, which said day shall not be less than three days before the meeting of the county conventions, for the purpose of electing their delegates to the county conventions. Thereupon the meeting so held shall elect their delegates to represent the precincts in the county convention from the voters of the respective voting precincts, which delegates, or such of them as shall attend, shall vote the full democratic strength of their respective voting precincts on all questions that may come before said county conventions. In case no meeting shall be held in any precinct in pursuance of said call, or no election shall be made, the precinct executive committee shall appoint such delegates.

PRIMARYS.

6. At every precinct meeting there shall (before the delegates to the county convention are elected) be a vote taken for the different candidates office, whose names may be presented and the delegates shall vote in the county convention of their respective districts in accordance with this vote; that is to say, each candidate shall receive in the county convention that proportion of the vote to which he received in the precinct meeting. The chairman and secretary of the precinct meeting shall certify to the county convention the vote received by each candidate at the precinct meeting.

7. Each precinct shall be entitled to cast in the county convention one vote for every twenty-five democratic votes, and one vote for fractions of thirteen democratic votes cast by the township at the last preceding gubernatorial election: Provided, that every voting

precinct shall be entitled to cast one vote, and each precinct may send as many delegates as it may see fit.

8. The chairman of the precinct committees shall preside at all precinct meetings. In their absence any other member of said committees may preside.

COUNTY AND DISTRICT CONVENTIONS.

1. The several county conventions shall be entitled to elect to their senatorial, judicial and congressional conventions one delegate and one alternate for every fifty democratic votes, and one delegate for fractions of over twenty-five democratic votes cast at the last preceding gubernatorial election in their respective counties; and none but delegates or alternates so elected shall be entitled to a seat in said conventions. Provided further, that in all county conventions in which delegates shall be selected to attend any state, congressional, judicial or other convention, a vote shall be taken in accordance with the plan of organization as to the candidates whose names may be presented to such county convention. The delegates shall be selected from the friends and supporters of each candidate voted for, in proportion to the number of votes he shall receive in such county convention, and no other instruction shall be given: Provided further that when only one candidate is presented and voted for at such county convention, it shall be lawful to instruct such candidate.

2. At every county convention (before delegates to state, congressional, judicial, senatorial or other conventions are chosen) there shall be a vote taken for the different candidates for office whose names may be presented, and the delegates shall vote for their respective counties in accordance with this vote; that is to say, each candidate shall receive in the state, congressional, judicial, senatorial or other convention the proportion of the vote to which he received in the county convention. The chairman and secretary of the county convention shall certify to each convention the vote received by each candidate: Provided, that where only one candidate is presented it shall be lawful to instruct for him. At all state district conventions the delegates from the different counties may disregard the vote of their respective counties as to any candidate; Provided, that a two-thirds majority of all his votes from the county consent.

3. The chairman, or in his absence any member of the county senatorial, judicial and congressional convention, shall call to order their respective conventions and hold chairmanship thereof until the convention shall elect its chairman.

4. The executive committees of the senatorial, congressional and judicial districts, respectively, shall, at the call of their respective chairman, meet at some time and place in their respective districts, and the chairman of said respective committees shall immediately notify the chairman of the different county executive committees of the appointment, and the said county executive committee shall forthwith call conventions of their respective counties in conformity to said notice to send delegates to said respective district conventions.

STATE CONVENTIONS.

The state convention shall be composed of delegates appointed by the several county conventions. Each county shall be entitled to elect one delegate and one alternate for every one hundred and fifty democratic votes and one delegate for fractions over seventy-five democratic votes cast therein at the last preceding gubernatorial election;

and none but delegates or alternates so elected shall be entitled to seats in said convention: Provided, that every county shall have at least one vote in said convention.

GENERAL RULES.

1. At all conventions the delegates shall be selected as near as may be from the friends and supporters of the candidates voted for.

2. Such delegates—or alternates of absent delegates—as may be present at any democratic convention shall be allowed to cast the whole vote to which their precinct or county may be entitled.

3. In all conventions provided for by this system, after a vote is cast, there shall be no change in such vote until the final result of the ballot shall be announced by the chairman of said convention.

4. All democratic executive committees shall have the power to fill any vacancies occurring in their respective bodies.

5. The chairman of the different county conventions shall certify the list of delegates and alternates of the different district and state conventions, and a certified list of said delegates and alternates to the secretary of the state central committee.

6. It shall be the duty of the county committee and its chairman to furnish such information and make such reports to the chairman of the state committee as he may desire.

At a meeting of the executive committee held on March 17, 1904, the following rule was adopted:

"In all conventions a nomination may be made by any majority, even though it be a fraction of a vote."

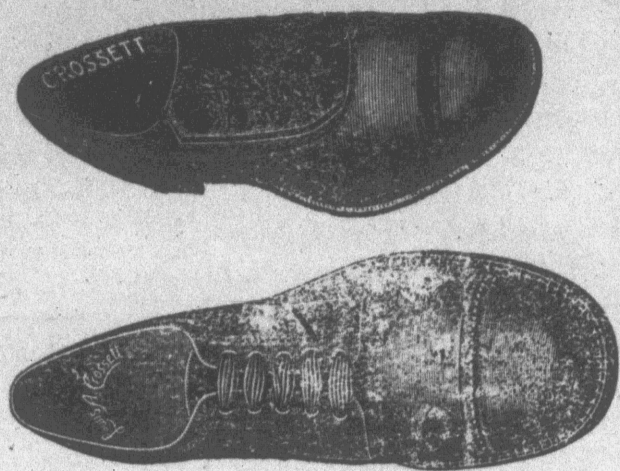

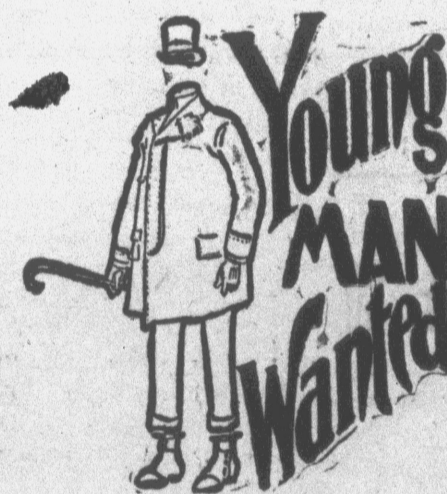
