Weekly Crop Report.

The North Carolina section of the climate and crop service issues through the weather bureau, the following crop bulletin for the past week:

In most of the counties along the coast, as well as in those west of the Blue Ridge mountains and also in a few central ones the weather during the past week was favorable because these sections received considerable rain which greatly benefitted crops. The precipitation, however, was very irregularly distributed in the central portion of the State, where drought is quite severe in many interior counties.

The temperature was again below normal this week especially in the eastern portion of the state, with a general deficiency of nearly 2 degrees; warmer weather set in on the 6th. Low temperatures and dry weather have prevented rapid germination, crops are coming up irregularly and growing slowly. The week was very favorable for farm work, which is well up nearly everywhere; more and better plowing than usual was accomplished.

Cotton has all been planted in many counties, in others planting is still in progress; comparatively little cotton is up yet.

Corn planting is approaching completion except on lowlands and in extreme northern and western counties.

A few complaints of damage by cut worms have been received. Tobacco plants are growing slowly, and some damage by the fly is reported; farmers took advantage of the showers on the 6th to set out many plants though they are small. Some peanuts have been planted. Wheat, oats and rye continue backward in growth and need rain badly; a number of correspondents report that these crops appear to be heading low. Grass and clover are poor in the drier sections of the state. Irish potatoes are generally in good condition; truck crops, especially beans, peas and cabbages, are doing fairly well. Shipments of strawberries and vegetables continue. A large crop of melons is being planted. It appears that more fruit escaped injury by frost than anticipated, and it is setting well.

IGNORE THE OFFICE SEEKERS.

EDITOR REFLECTOR:

Just at this moment times politically are a little critical. Having eliminated from the political arena the negro vote to a very great extent, the issues that shall agitate the political atmosphere will be confined strictly to the good sense and sound judgment of the white man.

At this crisis, the most important in the epoch of our history, we deem it the greatest caution should be observed. I am opposed to conferring upon any individual the high honors of our party who come begging and crying for the same. It is not a safe policy, to say the least.

A beggar in any phase of life is an object perhaps worthy of charity, but in no wise entitled to special honors.

Just now with many questions upon which there is a vast difference of opinion, requires a thought worthy of the deepest and most penetrating mind, and to encumber our party with chronic office seekers and those who know not the trials of an honest day's work, will only tend to embarrass the situation and bring about a state of affairs not only deplorable, but possibly be the means of defeat in the coming election.

DISEASES OF METALS.

The Way Steel and Copper Become Impregnated With Poison.

Many metals show symptoms of poisoning, rendering them unfit for use. Thus steel can, by means of small quantities of hydrogen and under certain circumstances, be very seriously affected. Let us take two steel bars of the same material, both heated to a red heat, one surrounded by air, the other exposed to the influences of hydrogen or hydrogen gas, chilling both bars in water after heating. We shall find the bar heated in hydrogen to be brittle, whereas the other bar, heated in air, will turn out to be far superior. The hydrogen has in this instance acted like poison upon the heated steel, and very small quantities of such poisonous matter will suffice to produce very violent effects. The disease in question can be radically cured, it only being necessary to anneal the poisoned bar, repeating the process by heating exposed to air. The poisoned steel, by being allowed to lie for a long time, will, without any further expert treatment, show signs of improvement to a certain degree, the poison gradually leaving it. A better treatment still is boiling in water or oil, which process may be compared to using warm compresses in the case of human beings.

Similar symptoms of poisoning, caused by hydrogen or gases containing hydrogen, as gas for lighting purposes, are apparent in copper when exposed to red heat. Not every kind of copper is susceptible to this poisoning in equal degree.

Metals can become diseased from improper treatment, as, for instance, copper and steel when exposed a certain length of time to temperatures exceeding fixed limits. The copper in consequence loses a great part of its ductility and bending qualities. In steel the disease can become so virulent that a steel bar so infected can on falling on the ground break to pieces. The technical expert calls such disease "overheating."—Professor E. Heyn in Harper's Magazine.

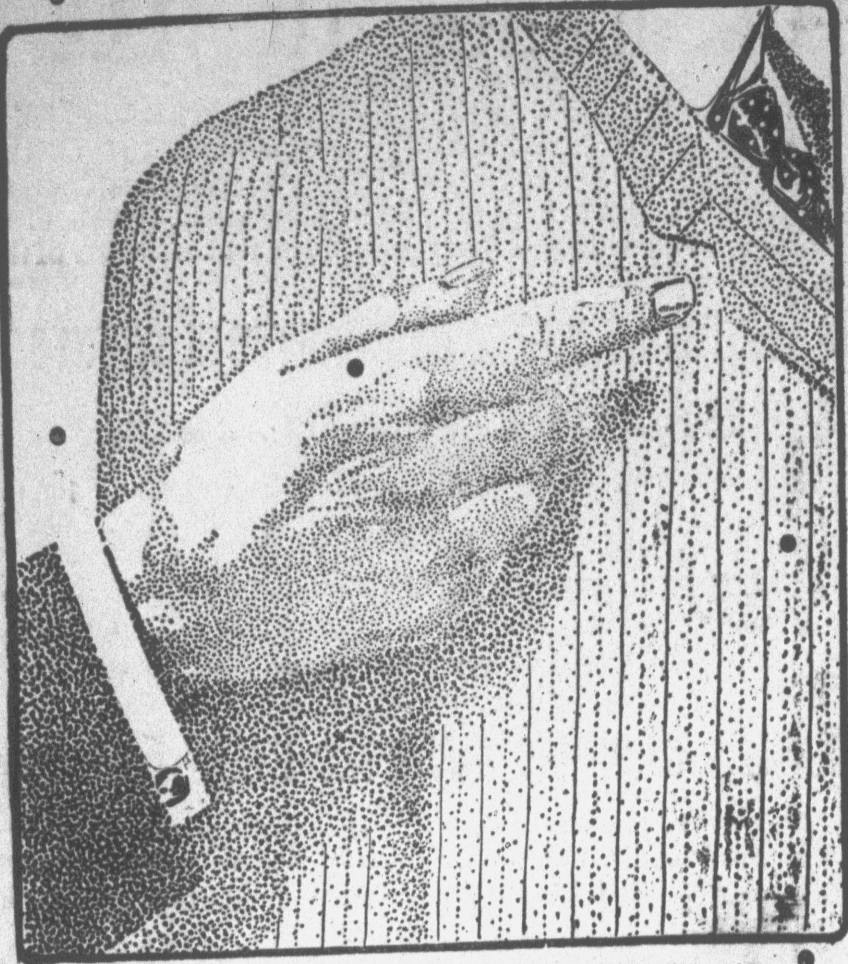

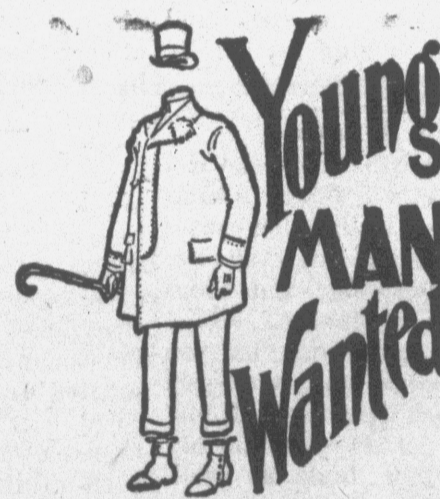
