COMMITTEE REPORT.

Rather Adverse to Management of A. & N. C. Road.

RALEIGH, N. C. May 24th.

The report of the special committee which has been investigating the condition and management of the Atlantic & North Carolina railroad was placed in the hands of the governor last Thursday and was released to the press for publication today.

It is an adverse report and criticises unfavorably the management of the road. The system in use of keeping accounts was crude and unsatisfactory. The committee does not think that the improvement of the property has been in keeping with the large amount of money expended, a total of \$324,499.62 having been available within the last 4 years and 9 months. While the service has been greatly improved in that time and much of the money wisely spent, some of it has been injudiciously used, in some cases approaching extravagance.

The committee stated that the spirit of the law prohibiting free transportation has been violated in furnishing free passes to persons who are not even stockholders. Free passes of all kinds have been generously distributed.

There are charges that contracts for supplies were made at too high figures, a notable one being the price paid for wood, the committee stating that the use of coal would have saved \$6,000 a year of the price paid for wood.

The committee declared that the road being in politics is not calculated to serve the best interests of the property.

There is some plain talk in the report about the purchase of the Atlantic Hotel property. It says the management bought trouble in this transaction and express the opinion that the purchase was not lawfully made and certainly was not wise.

The report concludes with the statement that it is clear that the best and most economical management of the property cannot be attained under state control, that it is equally clear that it is a very valuable property and its condition and earning capacity have been greatly improved during the last four years. At the same time the committee said there was nothing in the situation to call for great haste or extreme action in reference to any proposed change in the control or operation of the property.

FOUR GENERATIONS LIVING.

Mr. Jeremiah Wethington was in town today and says that he is now 78 years old. He has living nearly one hundred children, grand children and great grand children. Few people can say as much. Mr. Wethington is well preserved and works on the farm. He has been married twice but all these children, grand children and great grand children are of the first marriage. He has twelve great grand children in one family that of Mr. Cartis Corey, and in all there are more than forty great grand children.

There is probably not another family of such number living in the state that sprung from one marriage during the lifetime of the ancestor. Mr. Wethington married first in April, 1844.

THE WORLD'S FAIR.

St. Louis has done herself proud in the great exposition now in progress in that city in celebration of the centennial of the Louisiana Purchase. The exposition is in reality, as in name, a World's Fair, for almost all the world has been drawn together to help make the event both interesting and memorable. Every country of prominence on the globe is represented and the visitor gets a fair idea of the people of every nationality and the products of every land. Our own great country came up from every state and territory, and these supplemented with the best endeavors of the foreigners brings together in the magnificent buildings and spacious grounds a vast panorama and presents a miniature world at one view.

The writer left home on the 14th, his destination being this great World's Fair. Barring a tedious and patience-taxing delay of six hours at Weldon, the journey was most agreeable and enjoyable. As far as Richmond our travel was over the Atlantic Coast Line. From that city to Cincinnati the trip was over the Chesapeake and Ohio road that traverses a section rich in historic memory and resplendent with magnificent scenery. This road runs through the Blue Ridge mountains, following the course of sparkling rivers, the banks and mountain sides being dotted here and there with great mining plants, prosperous towns and flourishing cities.

From Cincinnati on the route was over the Big Four, and a little less than forty-eight hours after leaving home the distance to St. Louis had been safely and pleasantly passed. The fair being the objective point, little time was lost in getting out there.

After quartering at the Inside Inn, the largest hotel in the world, covering acres of land and embracing thousands of rooms, we were ready for sight seeing in earnest.

It was Press week at the fair, and besides the thousands of editors there from all sections of the United States, thirty or more foreign countries were represented.

The exposition is truly immense, so vast as to be at first bewildering, but with the use of some system and the aid of the transmural electric cars, visiting the various portions of the grounds and various buildings is made easy.

While there is a great deal to be seen, perhaps enough, yet the early visitor is impressed with its incompleteness. This is a fault, however of the exhibitors and not of the exposition management. What most impressed us is this particular, even to bringing a feeling of shame, was that North Carolina is so far behind her sister states in preparation of exhibits. As the representatives of other states could view with pride the splendid exhibits made by their commonwealths, those from North Carolina were pointed to a vacant space and told that is where it will be later on. The trouble is not that our state has not just as good exhibits as others, but because there

is tardiness and negligence in getting the exhibit arranged. Those supposed to have been there attending to this seem to have been giving their attention to other things. Just to think, for instance, that the fine exhibits of Pitt county tobacco sent there weeks ago by the Greenville board of trade, is yet stored away in some freight depository in the original packages as shipped.

It would take columns to tell of all we saw at the fair, and no attempt in that direction will be made. The Pike attractions also come in for their full share. They are numerous. Some of course are poor, but many stand high in point of merit and are worth seeing.

It is a great fair and must be seen to be properly appreciated. But it is best to wait until after the middle of June to go.
