#### C. C. Jones Guilty.

Releigh May 4.—In Federal court today Charles C. Jones of Goldsboro was convicted of having and concealing stolen postage stamps, knowing them to have been stolen. Judge Purnell finally remitted the imprisonment and increased the fine to \$3,500. The removal of Judge Purnell from the bench would be gratifying to many North Carolinians. If we are not mistaken his offense is similar to that for which the Florida judge is standing an impeachment trial before congress.

**Ex-Governor Jarvis' Opinion of Roosevelt.**

Washington, D. C., June 3.—"If they listen to me they will not go extensively into the platform business," said Gov. Jarvis yesterday when asked what sort of a platform the North Carolina Democrats would adopt at their convention in Greensboro. "They ought strongly to endorse the State administration because it deserves endorsement and because the Republicans have bitterly attacked it. They ought to stand by the temperance legislation enacted by the last Legislature, and that's about all there is to say.

"On national issues, we had better let the national convention make its own platform. Of course, in a general way we may condemn the Republicans for their extravagance in public expenditures and their refusal to lower taxation by revisions of such tariff schedules as are plainly obviously too high, protecting trusts and really hindering trade. Particularly we ought to condemn the administration for its assumption of legislative as well as judicial powers as displayed in the recent pension order and in some of the President's acts regarding the canal. Along with the postal frauds, the recently discovered revenue frauds in North Carolina are to be called to the attention of the people, with a demand that the guilty men be sought out and punished and first class officials be put in according to old Democratic usage. There we should stop. There ought to be no mention of the Kansas City platform or endorsement of any other platform whatever."

"What do you think will be the Democratic slogan in the national campaign?"

"Why, I think the Democrats can win with Roosevelt as the issue," he replied. "Therefore they ought to nominate the very antithesis of Roosevelt, so far as it is possible to select such a man, with due regard to fitness for the office. I'd be willing to make the fight on Parker and what he stands for against Roosevelt and what he stands for."

Gov. Jarvis thinks Parker will be the nominee, and for vice president "some good old style democrat from the middle West, preferably Indiana or Illinois," he said.—Frederic Merritt in News and Observer.

**She Wants Love.**

She had brought a doll for a little girl who had been placed in the institution, but before giving it to her asked the question: "Now, dear, what would you rather have than anything else?"

**They Draw Color Line At St. Louis.**

St. Louis, Mo., June 4.—President Francis and other officials of the World's Fair were greatly disturbed today by a color line which has been drawn firmly through the exposition. They are seriously considering the construction of a small building for the reception of negroes and the employment of Anna M. Curtis, a colored woman of education and address, as its hostess.

World's Fair restaurants are displaying anti negro signs. A prominent negro today complained to the World's Fair officials that a pike restaurant had posted conspicuously a big sign inscribed: "No colored people served in this restaurant."

Another complaint was received from a party of negroes who had been refused to drop a cent in the slot as white people do for a glass of fresh water. When questioned the water company officials stated that they could not sell water to colored people without ruining their trade with the white people. An exposition official today suggested that negroes be served from special tanks and glasses.

Interest in the senatorship made vacant by the death of Mr. Quay relates less to whether or not the governor of Pennsylvania may make an appointment covering the unexpired term than to the sort of man likely to be chosen by the legislature when the time comes for filling the new term. As that question is decided may we expect light on the question of whether a new order in the state has opened, or whether Mr. Quay is still ruling his party from his grave.—Washington Star.

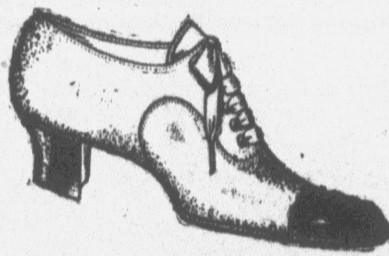
