Mrs. H. W. Martin has been gone for several days to Chapel Hill to take in the commencement. She returned last night with her brother, Theron.

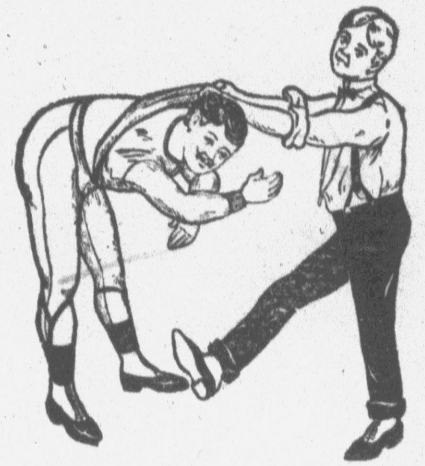
Robert Staton has purchased a \$250 horse for his son, John. Girls you may look out now.

Potatoes are bigger in the public eye than cotton just at this time.

The Japs do not seem to be coming out altogether so well in late encounters with the Russians.

The historic liberty bell is now at St. Louis on exhibition at the world's fair. The bell was escorted to the fair grounds by an immense parade of military and citizens. The old bell has taken many long journeys in its day.

H. F. Seawell, of Carthage, who was nominated by the republicans of his district as their candidate for congress, has declined the nomination. He thinks it is better to stick to his law practice than to make a run only to be defeated.

A New York letter to The Louisville Evening Post contains an interview with "a leader in the Hearst camp" in which the following statement is made: "The greatest danger to the democracy, in my judgment, is that some man with the power of oratory will get the floor at an opportune moment and stam pede the convention to Grover Cleveland."

No danger in that. It would be the best thing that could happen for the party and the country.

Many papers throughout the country are discussing the repeal of the two-thirds rule that prevails in the national convention. It is unreasonable that two-thirds of the delegates to a national convention should vote one way before a candidate for president can be nominated. The two-third rule was adopted nearly three-fourths of a century ago. State conventions have long since abolished it and are governed by a majority vote. National conventions should also change and let a majority of the vote be sufficient to nominate. A majority of the people should always rule.

Thinking over contempt proceedings, it's our deliberate judgment that there ought to be no such a law with its special and extraordinary proceedings with the offender. If an individual so behaves as to merit the contempt of the court, let him be arrested just as any other violator of the law, the proper process served upon him, and tried by a regular jury. The thought of any judge, it matters not who he is trying and passing judgment upon an offender against him and his court, does not set well with an American citizen. Such a proceeding smacks of royalty and tyranny.

Why not get in contempt of the governor of the state, or of the secretary, the treasurer, or the auditor, as well as of a judge? These are parts of the state, just as are the courts. Not one man in ten thousand will ever give a judge good cause for an action for contempt and that one ought to be tried, convicted if guilty, and punished by due process of law.—Raleigh Times.

The Populists will hold their national convention at Springfield, Ill. July 4th. It is quite appropriate for the Pops to be doing something on the day when the fire-crackers pops.—Wilmington Star.

A STRUGGLE FOR THE MASTERY

We will soon ascertain how much power a judge really possesses in this enlightened country and age. If a judge may throw a citizen into prison every time he feels that his dignity is assailed we are not freemen but slaves, and the most important work the next legislature has before it is to strip these autocrats of their unnatural and unbridled power. It has been generally held in this country that the people are invested with supreme power, but the present contention put the judges head over all. As we view it, this conflict is a struggle for the mastery between free citizens and lordly judges—and may the citizens win!—Charity and Children.

Visitors were allowed on board at all times, except Sunday morning, when inspection took place. One Sunday a well known American millionaire steamed out with a party of friends in his yacht and succeeded in getting on deck, where he was met by Captain Dewey, who asked him to leave. Mr. Money remonstrated and finally, exasperated by the cool firmness of the officer, he burst out: "No sir; I won't leave. I am an American citizen and have a perfect right on this vessel. I pay taxes in America. I am on my own property. Part of this ship belongs to me!" Calmly, Dewey opened his penknife, stooped down and split off a piece of the deck flooring. Handing it to the incensed American citizen, he replied: "There's about what you own, and there's the ladder. Now git." And he got.

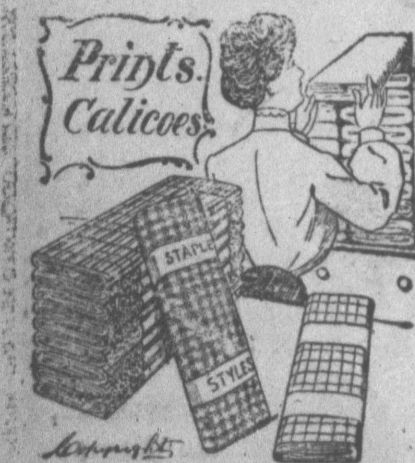
