C., June 16.—Lawrence Pulliam, convicted of defaulting while cashier of an Asheville bank some years ago, and who appealed and gave bond, was turned over to the court by his bondsmen and sentenced to five years in the Federal prison at Atlanta, where he was taken to-night. The case has been in court a number of years. Pulliam stood well before his conviction and many efforts were made to secure his freedom.

WILL NOT SERVE WITH ILLEGAL COMMISSIONERS.

Greenville, N. C., June 18, 1904.
HON. H. W. WHEEDBEE, Mayor.

DEAR SIR:—I have been notified that I was elected by the board of aldermen one of the dispensary commissioners for the town of Greenville. This is to notify you as the chairman of the board of aldermen, that I decline to accept the appointment and to qualify as a member of that board.

My reason for this action is this: The law requires that only those who voted for a dispensary shall be elected commissioners. I voted for it, and am willing to take my share of the responsibility when I can do so according to law. The other two persons chosen voted against the dispensary, and are therefore disqualified to act as commissioners.

I have nothing against either of these two gentlemen. They are my friends, but knowing them to be disqualified, I cannot act with them. Had it been the pleasure of the board of aldermen to have chosen men who were qualified under the law, I would have felt it my duty to co-operate with them, but I repeat, I cannot act with men whom I know to be disqualified under the law.

FIRE AT WASHINGTON.

Atlantic Coast Line Depot Burned. [Special to Reflector.]

Washington, N. C., June 20.—A little past 5 o'clock Sunday afternoon lightning struck the passenger and freight depot of the Atlantic Coast Line. Agent Barnes was in the office writing at the time. The lightning set fire to some tissue paper in the office and from this the building was quickly in flames.

After two hours hard fighting during which six or seven streams were playing on it, the fire was subdued, but not until the building had been gutted. There was a large quantity of freight in the depot and much of this was badly damaged. The loss on the building was covered by insurance. The loss to freight has not yet been estimated. More damage was done by water than by fire.

Much disappointment is expressed here over the inefficiency of the water works. It was thought that the city had a modern system of water works but at no time during yesterday's fire could a pressure of more than 50 pounds be reached.

Fortunately for all the Atlantic Coast Line has a new depot, a handsome brick building costing \$70,000, nearly completed and can move in without experiencing much inconvenience from the fire.

This is the third time the company has suffered by fire here.

How it Works in Union.

"There needs," said a gentleman, "to be a little clarification in the political methods existing in Union county. The use of money is getting so common in the employment of 'workers' that a man needn't start out for office unless he is prepared to spend a good deal. The primaries are practically open to everybody, qualified or unqualified voters, and the man who can send the most workers out to pull in the weakkneed, the indifferent and the don't-care-vote, is apt to lead the race. But, too, there is another thing for which the candidates themselves are responsible: that is, the systematic robbing of those who are running for office by the deadbeats who go to every one and say, 'Lend me \$2 and I'll help you.' Most of the candidates will hand over the money to such fellows, who in many cases can't even vote in the general election, and who go straightway and sell themselves to an opponent."—Monroe Journal.

Friends of the Toad.

The agricultural department comes to the front as the friend and defender of the toad. To show that these reptiles are friends of the farmer and gardener the department made post mortem examination of one hundred and fifty of them, to find out what was their chief food. It was found that two-thirds of what they had eaten was insects injurious to the plants. The department has issued a pamphlet on this subject.—Wilmington Messenger.

This week will tell who is in the lead.

With seventy negro delegates in the republican national convention Roosevelt ought to be very happy and feel at home.

The Raleigh Post has added Sanford L. Potter and Willis G. Biggs to its local staff. Both have had good experience as newspaper writers.

You can't down "Dixie." Playing that ever popular air in a crowded theatre at Americus, Ga., when a cry of fire had been raised outside the building, checked a stampede for the door and quieted a panic.

The real estate dealers of the state are to effect an organization for the purpose of encouraging immigration. A meeting with this object in view will be held in Greensboro this week. This is a move in the right direction to help the state.

What is the matter with Charlotte and Greensboro. From both comes the announcement that it is the quietest time in police circles ever known. And both cities are in the midst of an anti-whisky campaign. Is this unusual quietness for effect?

It takes such disasters as the Chicago theatre holocaust and the burning and drowning of six hundred people in New York harbor to arouse public officials to a sense of their duty. If vigilant inspections were always made disasters of this kind might not occur.

Every execution that takes place in the state strengthens the sentiment that they should be private. Too many disgraceful scenes have occurred around hangings and the state should discourage the display of such morbid tastes. Executions should be strictly private, and it would be better if all condemned criminals were taken to the penitentiary and the sentence of the law carried out there.

The cigarette smoker would do well to take warning while there is yet time for him to quit—while there is yet ground for him to stand upon. Evidences multiply that he is presently to be shut out of the ordinary avenues of business, the latest coming from Rock Hill, S. C. where the directors of the Union National Bank have adopted a resolution that no person who smokes cigarettes can find employment in that institution. Better quit, young man, or you will find soon that nobody wants you.—Charlotte Observer.

The report of the State board of health on smallpox shows that for the year ending May 1st there were 5,300 cases of the disease in North Carolina, the largest number in any year since the disease made its appearance in January, 1898. The number of deaths was the smallest during any season.

For the first time there were more cases among the whites than among the negroes, the number of whites cases being 2,800 against 2,500 colored. The total number of cases since the disease made its appearance in this state is nearly 15,000. It is thought the disease in all probability came in 1898 from Mexico, being brought from that country by railway employees.

What the Dispensary is not.

The whiskey business is getting warmed up in Charlotte. Wherever a campaign of this sort is conducted will be seen and heard a lot of impractical utterances. In all temperance movements the men least capable of leading are apt to get into the saddle. That is why sensible, conservative men have, for the most part, staid out of the fights. The dispensary, as conducted in Raleigh, is the proper and permanent solution of the liquor business. We say "as conducted in Raleigh," because we happen to know how the business is done here. The dispensary is no sickly, sentimental, temperance movement. It is rather a demonstration of how a bad business may be done in the least harmful manner possible. To make a dispensary successful, there are three things necessary. First, it must be in the hands of honest, upright men, who will see to it that the business is properly conducted. Second, it must keep a pure article of goods the best that can be had anywhere. Third, it must be a financial success, and tend to reduce the taxes of the property holders in the city and community where it exist. Whiskey is here, and here to stay. It will be sold in some form till the millennium dawn, and the dispensary is the medium through which it can be done with the least harm to all concerned. Prohibition for cities like Charlotte, Raleigh or Wilmington would, as it has always been, a delusion and a fraud; a breeder of "blind tigers," and a l sorts of back-door, dark-alley devilment. We have no thought the conservative business contingent of these places will favor it for a single minute.—Raleigh Times.

As an illustration of the uncertainties of speculation a striking story is related of an Atlanta man who made \$40,000 by dealing in cotton futures. When he had received the check, his wife suggested that it was an opportune time to buy the home they had been wanting for years. After a desirable residence had been selected, the husband decided that, since the purchase price would just about consume the amount he had made on cotton, it would be better to re-invest his money and make enough to furnish the place handsomely and live in grand style ever afterwards. He did so—and the next day cotton slumped and he was left penniless and homeless. Another case of a man not being able to let well enough alone.—Charlotte Chronicle.

Secretary Hay indignantly denies that he was overcharged by St. Louis hotel keepers on the occasion of his recent visit to the World's Fair city, insisting that the charges were only a little over \$100 a day for his party of six. The reading public will be relieved to know that Mr. Hay was not overcharged; also to learn the very modest price at which a party of six can visit the exposition.—Durham Sun.

It is said that seats in the Chicago Convention hall are being snapped up at \$100 a seat. The seating capacity of the Coliseum is 6,000. How many theatrical managers will sigh that the convention cannot be put upon the road!—Durham Sun.

The Greenville aldermen have named opponents of dispensary to conduct it. Raleigh tried that game but had to back down.—Raleigh News and Observer.

There will be some backing done here, too.

DABOIAS OF INDIA.

The Attack of These Superb Snakes is Instantaneous and Deadly.

A writer on India says: "The snakes that are most worthy of dread as inmates of Indian gardens are the terrible daboias, *Viperia russelli*. They are truly superb reptiles, for, while the coloring of their armor is relatively quiet, it would be hard to find any finer harmony than that presented by its tints of ochreous brown, on which a series of shining black rings with lighter margins are disposed in triple rows from the neck to within a short distance from the end of the tail. Daboias are sluggish and inert and often lie coiled up and motionless on footpaths until they are actually touched or trodden on by passers by, when they suddenly unfold like a released spring armed with terrible teeth. There is none of the warning and preparation here that there is where a cobra is about to strike, no sitting up and threatening, but an instantaneous and deadly assault. When they have laid hold, too, they hang on and worry in a sickening fashion while they strive to inject as much as possible of their tenacious yellow venom."

In India, says this same writer, it is held that the proper way to treat natives who do their best to die of pure "nervous depression" after imaginary-snake bites is to put a drop of croton oil into the patient's eye, which gives him something real to think about. He tells the story of an Indian cooly who, while walking across a courtyard after dark, trod on one end of a piece of iron hoop, with the result of bringing the other and jagged extremity sharply up and into contact with the back of his leg. Not unnaturally the man took for granted that he had been bitten by a snake and probably by a venomous one. He accordingly made up his mind to die and would rapidly have succeeded in doing so had not an experienced person been handy with a bottle of croton oil.

A Victim of Vacillating Conduct.

In an Indianapolis family, in which thirteen at the table is not allowed, an informal dinner of relatives recently was found to present the alarming number. Big Robert said he would stand up and dine from the sideboard to quiet the nervous women of the family, but a side table was speedily arranged for little Robert, who seemed thoroughly mystified and impatient with the entire disturbance. To balance the matter, little Robert was recalled from the side table and again seated in a rather tight place at the large table. As the thoroughly irritated and puzzled six-year-old boy resumed his dinner he offered a remark: "Well, if I was as grown up as all these people are I'd try to know my own mind." —Indianapolis Journal.

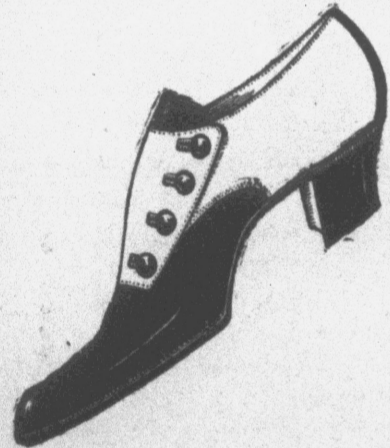
