#### To Cook Carp.

Many persons have been dubious hitherto about the food value of the carp, which is so abundant in the Columbia. As much of the flavor is lost through careless cooking, it is important, to enjoy the fish, that a good recipe be strictly adhered to. The following method, which is in use at a local restaurant, is the best—in fact, the only way to cook carp so that it will be appreciated.

Take a good sized carp and clean it well. Get some stiff clay, make a paste of it, and plaster around the carp to a thickness of two inches. Bake in oven until clay is very hard. Then get a hammer and knock off the clay. Throw the carp away and serve the clay.—Portland Oregonian.

#### Tribute to Judge Brown.

Wilmington, Sept. 30.—With the adjournment of Brunswick Superior court at Southport today, at noon, Judge George H. Brown closed a distinguished service of 16 years on the lower court bench in North Carolina, a fact which was adverted to by Hon. J. D. Bellamy in a pleasing and most complimentary speech as the final act of the term was about to transpire. Mr. Bellamy personally, and in behalf of the bar of the state, thanked Judge Brown for his uniform courtesy at all times during his long service as a Superior court judge, and referred in most complimentary terms to the urbanity and deference to others which had characterized his judicial course. His elevation to the Supreme Court bench of North Carolina was spoken of in gratifying terms, the remarks of Mr. Bellamy having been seconded by Mr. Iredell Meares and other members of the Wilmington and Southport bars in attendance, all of which was gracefully acknowledged. Judge Brown came up to the city this afternoon and is spending a short while with friends on the sound before going to his home in Washington.

Governor-to be Bob Glenn is conducting a great campaign in the state. His speeches not only attract attention over the state, but throughout the nation as well.

Senator George F. Hoar, of Massachusetts, has passed into the great beyond. He lived to a ripe old age and was a man of towering intellect and influence.

The Charlotte Observer has been caught on the Wilmington Messenger's error about resolutions purporting to have been adopted by the Democratic convention of Pitt county. Brethren, let us remind you that Pitt held a strictly resolutionless convention.

In Raleigh Friday morning Dr. Thomas D. Hogg, one of the oldest and best known men of that city, was run over and killed by a railroad shifting engine. By his age he had become enfeebled physically and mentally, and having a fascination for railroads he unconsciously wandered into dangar.

**Judge Parker on Red Hair.**

Judge Alton Brooks Parker, the democratic candidate for President, was recently chatting with an auburn-haired visitor on his veranda at Rosemount, New York. Naturally, the conversation turned to the subject of red hair, which is a characteristic of the Parker family.

"When I was your age," said the judge to his guest, "my hair was redder than yours—it was fiery red, in fact, and, in consequence, my fighting instinct were over-developed while I was in school. In the country district where I learned my 'three R's,' it happened that I was the only redhaired youth. When I first attended school the boys had a good deal of fun shouting 'sorrel' and 'red top.' It never failed to rouse my fighting blood and I lived a strenuous life."

"But you wouldn't have changed the color of your hair, would you?" asked the visitor, blandly.

"No, indeed," said the judge; "red hair is all right. My daughter has it, and my little grandson there is as red as he can be. They say it is a sign of high temper, but it is also a sign of numerous excellent qualities."

"We've had two red haired Presidents," said the visitor—Jefferson and Jackson, and they were both Democrats."

"That's true," said the judge, "and don't you think it's about time we had a third?"—October Success.

Referring to the fatal boiler explosion at the Erwin Mill at Durham, a few days ago, The Raleigh Times says it was the fault of an incompetent engineer, who let the water get too low and then turned cold water into a hot boiler. Our contemporary's comment is that "the next Legislature ought to make it a penitentiary offence for an engineer who has not stood an approved examination and obtained a license to run an engine." Undoubtedly a great many lives are lost and much valuable property destroyed by people who assume to fire boilers without knowing what they are doing. The wonder is, indeed, when one looks at some of these incompetents, and consider their earnings, that there are so few boiler explosions. The Wilmington Messenger suggests, in this connection, that the employers are criminally liable.—Charlotte Observer.

**The Two Letters.**

Judge Parker would be elected President by a hundred majority in the Electoral College if every voter in the United States would read with close attention and open-mindedness his letter of acceptance. We pity the dullness that does not see that it is a great paper, an eloquent, sobering, and saving appeal to the American people no longer to permit themselves to be fooled and misled; we think candid men will be moved to just anger and contempt for that stupid partisanship which denies its high merits.

President Roosevelt's letter was remarkable, it was astonishingly able. It was almost reckless in its brilliant way of putting the case for a dashing, smashing, high-handed administration of the Presidential office. We said when it appeared that the American people had never before been talked to in that way. It wasn't quite imperial; rather like a master, whip in hand, haranguing slaves muttering revolt. Half the male population of the country above the age of twenty-one was roundly insulted and berated, in a lump, as a vile herd, without convictions and without conscience. It was extraordinary, but its experienced and skillful author knew very well that it was taking, that crowds would like it, would "hoorah" mightily.

Now comes Alton B. Parker's letter. It is not of the kind to evoke the yells of crowds. It is addressed to men that think. It is a warning, a strong voice through the darkness, and storm telling of peril and how to escape it. The letter is, in fact, a first-rate test of the people.

Sometimes in a playhouse there may be seen a great actor whose fine mind and finished art wonderfully picture forth all the hidden things that lie in the soul of the character he personates while upon the same boards a robustious player to the galleries bestrides the stage and fills the whole house with his roaring passion. The comparison is unflattering—we use it because of its exactness. The taste and cultivation of the audience to which two such actors make their appeal are not more surely proved out than the judgment the common sense, and the capacity for sober reasoning of the American electorate will be proved out by the two letters of acceptance.—New York Times.

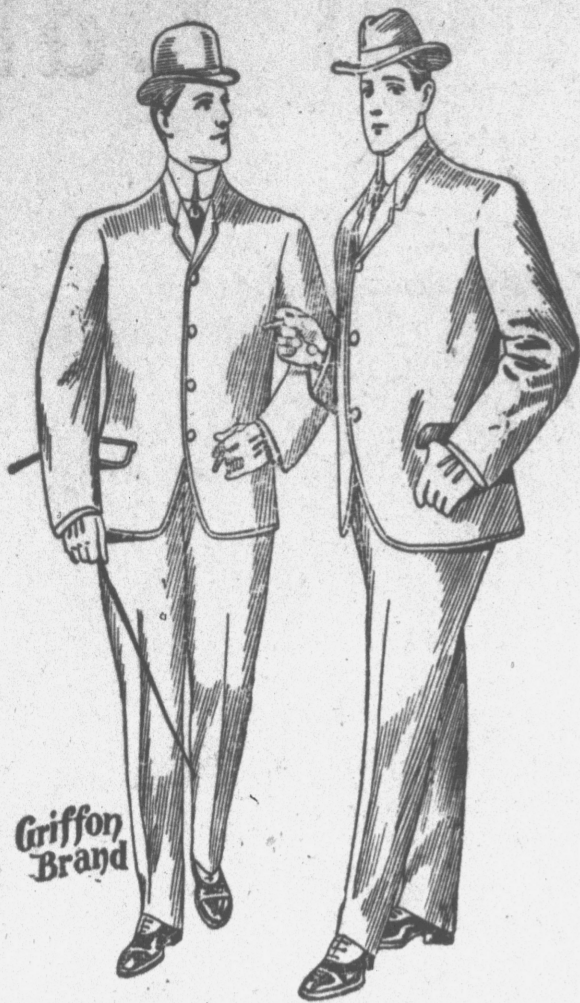
