THE YEAR 1904

Notable Events From January to December.

RECORD DAY BY DAY.

Chief Events of the Russo-Japanese War.

VISITS OF THE GRIM REAPER

Losses of Life and Treasure by Flame, Accident, Storm and Shipwreck. Personal Items, Political, Sporting and Miscellaneous Affairs—A Chronological Review.

Many events and features of 1904 make the year a notable one to date from. It opened with a winter the coldest out of twenty-three exceptionally cold winters recorded in the last eighty-seven years.

The year is a record maker for the United States in cotton growing, the yield being estimated by the government at 12,100,000 bales, the largest in the history of the country. The corn crop estimate of 2,453,000,000 bushels is the largest with the single exception of 1902.

Early in the year ominous reports from the far east indicated war between Russia and Japan unless the former should back down from her position in regard to Manchuria and Korea. On Jan. 14 the czar declared to the foreign diplomatic corps that he would do all in his power to preserve peace. Meanwhile the Japanese press was urging the mikado's government to begin hostilities, and advices from Tokyo stated that troops were ready to embark upon transports. It was therefore not a matter of surprise that Japan took the initiative in February. Her early operations on sea and land were marvelously energetic and successful.

The fighting on land has been exceptionally desperate, and the siege of Port Arthur, with the battles at Liaoyang and river Sha, will take rank in history as notable struggles. The war has developed an almost universal sentiment among nations for peace and arbitration.

During the year the United States has acquired from Panama the concessions desired for insuring the early completion of the Panama canal.

13. Obituary: Prof. Herman Edward von Holt, head of the department of history at the Chicago university, at Freiburg, Germany; aged 72.
14. Accident: 14 workmen killed and injured by an explosion in the Cambria Steel works at Johnsons, Pa.
15. Cyclone: 37 people killed and over 100 injured in a terrific storm at Moundville, Ala.
16. Fire: At Sour Lake, Tex., main business portion of the town destroyed; loss, \$200,000.
17. Accident: 16 gold miners killed by the falling of a cage at the Stratton Independence mine, Victor, Colo. 120 miners killed by fire during explosion in the Harwick shaft, Cheswick, Pa.
18. Fire: The University library at Turin, Italy, containing many rare volumes, partially destroyed; loss, \$1,000,000.
19. Obituary: Annie Chambers Ketchum, author of "The Bonnie Blue Flag," in New York city; aged 80.

9. Russo-Japanese War: Actual hostilities began by Japan. Japanese warships attacked the Russian cruiser Varang and the gunboat Korietz, outside the harbor of Chemulpo, the port of Seoul, Korea, and sunk them.
10. Russo-Japanese War: The Russian battleships Cosakovitch and Retvizan and the cruiser Pallada disabled in a night attack by the Japanese fleet at Port Arthur. Secretary Hay addressed an identical note to the powers suggesting that the neutrality and integrity of China be maintained by Russia and Japan.
11. Fire: At Oswego, N. Y.; loss of \$1,000,000 by the burning of the Corn Products starch factory.
12. Russo-Japanese War: President Roosevelt declared the neutrality of the United States.

13. South American Troubles: Spirited action at Santo Domingo between United States warships and marines and Dominican insurgents who fired upon an American vessel.
14. Russo-Japanese War: The mikado of Japan issued a formal declaration of war against Russia.
15. Fire: In Topeka, Kan.; properties in the business district valued at \$400,000 destroyed.
16. The Philippines: A detachment of Gen. Leonard Wood's command, under Maj. H. L. Scott, attacked a band of Moros, killing and capturing 600, with a loss of 7 men.
17. Fire: At Meriden, Conn., the town and city hall burned; loss, \$200,000.
18. Russo-Japanese War: The Russian cruiser Boyard—blown up in the harbor of Port Arthur by accidental collision with a Russian torpedo; 137 men lost.
19. Obituary: Senator Mark Hanna, in Washington; aged 65.
20. The Russo-Japanese War: Admiral Makarov appointed to succeed Admiral Stark in command of the Russian fleet at Port Arthur.
