While the farmers are holding their cotton against the low prices prevailing at present, they should do all possible toward squaring up their accounts for the past year. The merchants want to help the farmers get better prices for cotton, but at the same time they have obligations which they must meet. If all will work together and look out for each others' interest in such times as this no one will suffer loss or embarrassment.

The Oldest Woman Dead

Mrs. Lucy Parmenter, the oldest woman in Charlotte and probably the oldest in the State, died yesterday afternoon at 12:30 o'clock at her home near the Gingham Mills, northeast of the city. Mrs. Parmenter was nearly 104 years old and her death was due to a stroke of paralysis that she received about 12 months before she died. Mrs. Parmenter is survived by a husband, Mr. Henry Parmenter, who is 98 years old, and who is still a comparatively lively old man. She is also survived by three sons and several grand-children, most of whom are now living in South Carolina.

The story of the life of Mr. and Mrs. Parmenter is an interesting one, beginning in the early years of the last century. They were both natives of Anson county, where they lived until a few years ago.

More than 80 years ago in the thinly settled districts of Anson county Miss Lucy Caudle was teaching a school, her students being few and of all sizes. One of these students was Henry Parmenter, a young man just finishing his "country school" education before entering the arena of life. Here as student and teacher a love began which lasted through more than three-quarters of a century. Parmenter finished school and shortly afterwards persuaded his late teacher to become his bride. She consented and since that little country wedding in Anson, nearly four score years ago, these two people lived together, happy in their virgin love, until yesterday at noon. The only break of separation of the couple was during the civil war, when Mr. Parmenter served in the artillery, although he was passed the age limit fixed by law for service.—Charlotte Observer.

Secretary Wilson on the Cotton Situation

Secretary Wilson, of the Department of Agriculture, does not think much of the proposition to raise the price of cotton by burning a part of this year's crop. Speaking of this subject he said: "I don't think they are going to burn much cotton. They will see the wisdom of holding what they have of their crop over until another season in order to take advantage of a higher market, which will then have been probably created and next year will plant less acreage and instead of raising cotton as their entire crop will plant alfalfa and other cash producing commodities. The slump in the market was created principally by increased interest and in a decidedly heavier weight of the quality of cotton grown. The same bulk of cotton this year is materially heavier than that of last year, all of which features have a bearing on the present state of the market. In order to make their plan of raising the market price for cotton effective it would be necessary for them to burn at least two million of bales, the total crop being above twelve million bales. The average price of poor cotton to day is in the neighborhood of \$40 per bale so that the burning of two millions of bales would mean a loss to the Southern planters which they need not bring upon themselves, but could avert by holding for another season."

Chief Events of the Russo-Japanese War.

VISITS OF THE GRIM REAPER

Losses of Life and Treasure by Flame, Accident, Storm and Shipwreck. Personal Items, Political, Sporting and Miscellaneous Affairs - A Chronological Review.

- Obituary: King George of Saxony, in Dresden; aged 72.
- Russo-Japanese War: Heaviest fighting of the prolonged battle of the river; the Japanese right, center and left armies stacked the Russians, driving them north of the river.
- Shipwreck: British schooner Melrose wrecked off the Florida coast; 7 lives lost.
- Obituary: Brig. Gen. William Scott Worth, U. S. A., retired, son of the Mexican war hero and a veteran of the civil war and the Spanish-American war, in New York city; aged 84.
- Russo-Japanese War: The Japanese advance northward checked by the Russians at the river; the Russians captured many cannon.
