THE LEGISLATURE.

MONDAY.

In the senate a petition was presented asking that the marriage of girls under twenty years of age be made a misdemeanor on the part of the husband.

Senator Ward introduced a bill to give the corporation commission power to inspect the condition of each railroad in the state, in regard to public safety, and to require repairs to be made where found needed.

Senator Eller offered a bill to amend the general election law so as to allow more compensation to election officers.

Senator Stubbs introduced a bill to establish graded schools in Robersonville.

In the house there was a resolution requesting congress to enact a law to allow tobacco growers to sell tobacco in the leaf or pressed plug free from any tax.

There were many new bills but they were all of a local nature and of little importance.

Shot Through The Arm.

John Kinyan, a young white man who recently came the city as a horse trader, was shot through the arm Saturday night in a row on the streets in South Kinston, between him and two other young men named Barnett, who are said to live near Falling Creek.

Kinyan and one of the Barnetts, who has a crippled arm, were cursing each other and Kinyan struck Barnett. The latter's brother then pulled a gun and began shooting, one of the bullets striking Kinyan's arm and passing through lodged under the skin on the opposite side.

It will be remembered by Free Press readers that Kinyan's introduction here was rather "striking" he being the gentleman that ambulated through the precincts of "Dog Town" uttering the implied challenge that he was "a bad man, and always looking for trouble," and in response to this well understood invitation in that famous quarter received the same in the shape of a brick laid on the side of the head in the characteristic "Dog Town" style.

Kinyan says it looks like they are trying to put him out of commission, but he is dead game.—Kinston Free Press, 13th.

The Pay of School Teachers.

World's Work furnishes some striking figures on the pay of public school teachers.

They are more than striking. They touch on the injustice of a system that gets all it can and pays as little as possible for it.

It is not denied that teaching is hard work—hard and wearing. The teacher, a man or woman, who has served a long period in the schools is not worth much, for any other vocation, at the end of that service. And the job, or profession, calls for not only years of preparation, but tact, patience, the highest order of intelligence, and that something that has not been named, but is the ability to get along in the face of countless worries and obstacles.

Now how about the pay?

A coachman—an average, competent coachman, who can drive and who knows something about horses—is better paid than the average school teacher, for in the whole United States the average pay of women teachers is under \$40 a month.

It is pointed out that in a certain locality of North Carolina a man who trains puppies for quail hunting draws a better salary than any school teacher in the community.

In the state of Indiana 12,000 teachers receive less than \$500 per year each, and there are other states in which the showing would be worse.

Are the people of the United States in earnest about their desire for thorough education?

And, if they are, can not they realize that while some—perhaps many thousands of good teachers—will work for a pittance because they must, the highest talent will get out of the business when opportunity offers, and that there is and will continue to be a scarcity of the best teachers because of the scant salaries paid and offered?

Modern education will not progress as it should, or produce the results desired, until there is more justice displayed in dealings with those who do the work and bear the burdens.—Atlanta Journal.

Young Convicts.

Superintendent J. S. Mann of the State prison has furnished the joint committee on penal institutions some figures relative to young convicts in the penitentiary. The agitation now for a reformatory is based upon the fact that young criminals find their way to the penitentiary with more hardened criminals.

During the years 1903 and 1904, according to the superintendent's figures, the penitentiary received law breakers under 21, as follows:

1903 and 1904, to-wit: 20 white males, 0 white females; 73 negro males, 15 negro females and 1 Indian male, total 109. Of the white boys received during these two years, in 1903, 2 were 17, 3 were 18, 3 were 19, 3 were 20 and none were under 17; during 1904, 3 were 17, 3 were 18 and 3 were 20 and none under 17.—Kinston Free Press.

For your first experiment let the candle burn until the wick is quite long, having placed it where there is no draft. Now blow the candle out, and a stream of smoke will rise from it. This smoke is the gas, the burning of which makes the flame. To show that it is gas put a lighted match to it immediately after blowing out the candle, and it will ignite and run down and relight the candle. The match should be held about half an inch above the wick.

Again letting the candle burn until the wick is long and quickly blowing out the flame as before, hold a piece of wire gauze, such as is used for window screens, down over the wick so that the smoke will rise through the meshes. Apply a lighted match to the smoke half an inch above the gauze, and the gas of which the smoke is composed will at once ignite, but the flame will not go below the gauze, for the reason that has already been given.

Blind Prophet's Game.

The players stand in a row, one behind the other. The second one in the row lightly places her hands over the leader's eye and says:

"Prophet, how much of a prophet art thou?"

At the same time another prophet sneaks out of his or her place in the row and touches the prophet's hair or cheek. The prophet then inquires:

"Who disturbeth me?"

In reply the disturber must make some sound. She may cough or grunt or moan or make any other kind of sound she pleases.

The prophet must try to identify the sound and say who it is. If successful, the prophet is released and the captured one must take the place.

How to Make Spectral Lamp.

Mix common salt with spirits of wine in a metallic cup and set it over a spirit lamp. When the cup is heated and the spirit ignited it will burn with a strong yellow flame, which can be made more or less jaundiced by the greater or smaller quantity of salt added. All other lights being extinguished, this will give to everything a ghastly hue, changing the colors of dresses in a remarkable manner and giving to the rosy cheek of health the cadaverous appearance of death.

If salt of strontian be used instead of common salt, a red light is produced.

Eskimo Candy.

In Eskimo land there is a kind of waterfowl called dovekies. It is about the size of a duck and quite black, with webbed feet of a brilliant red color. When the men have killed the dovekies the women cut off their bright red feet and draw out the bones. Then by blowing into the skins they distend them as much as possible to form pouches. When these are thoroughly dried they are filled with reindeer tallow, and the bright red packages are regarded by the Eskimo children as their greatest treat.

ALL OVER THE HOUSE.

Some Don'ts to Remember in the Treatment of Colds.

A cold neglected is the first step in acquiring an acute and dangerous pulmonary or bronchial disease, and a cold half cured is the straight and narrow path which leads to pneumonia.

Here are a few "cold don'ts" which every homemaker will do well to hang in her medicine closet along with the directions for first-aid to the injured:

Don't dose yourself with quinine, phenacetin or other standard drugs without first consulting your family physician. Many of these drugs act directly on the heart and weaken it, so that there is not sufficient vitality left to fight the cold.

Don't pin your faith on the remedy which cured your next door neighbor. He may have had a tendency to pleurisy, while you may be headed for pneumonia.

Don't rub camphorated oil or similar lubricants on your chest unless you cover it over with a flannel protector. Lubricants of this sort open the pores and aggravate the cold unless the affected part is properly covered.

Don't experiment with the cold water cure unless you thoroughly understand it. This is sometimes efficacious, but if improperly administered it is dangerous.

The Art of Broiling.

A steak or chop properly broiled should have a thin, well browned crust. Beyond this crust the meat should be red and juicy, hardly a shade less done in the middle than near the surface. If the broiling is to be done in a range, have the fire very bright and clear. Open every draft, that smoke and flame may be drawn up the chimney. Place the piece of meat in the double broiler and hold it as near the coals as possible until the surface is brown, turning frequently. It will take three or four minutes for this now. Now raise the broiler several inches above the bed of coals and continue the cooking until the meat is done. A good rule is to count ten slowly, then turn the broiler. A steak or chop cut a little more than an inch thick will cook nicely in ten minutes. If liked well done, it should be cooked for twelve minutes.

Hand Instead of Sandwich Board.

A novel departure from the customary sandwich board has just been introduced into the London streets. It takes the form of a gigantic hand, upon the back of which are printed the advertiser's name and the nature of the articles that he desires to extol. The hand is mounted on a long pole and is carried by the sandwich man in such a fashion that the index finger is always pointing in the direction where the advertised shop, theater or restaurant is situated.

Civil and Domestic Service.

Not long ago the authorities at Washington were taking steps to secure some lighthouse keepers, and the civil service commission advertised an examination for candidates. The stenographer who typewrote the advertisement made it call for "light housekeepers."

So Washington had its jokes about the weight limit of applicants and a proposed "department of domestic economy" and all the other puns and jokes which the error inevitably suggests.

A Mark Twain Story.

Mark Twain tells a story that while traveling in Germany a man sitting next to him at a dinner in a hotel ordered a bottle of Johannesburg wine. When it was brought he saw on the bottle a label of Moselle and called to it the attention of the manager, who exclaimed: "Ach, what a stupid donkey! I distinctly told him to put on the Johannesburg label."

A One Piece Dinner.

A remarkable dinner was served recently by a farmer near Ault, Colo. The table was set for twelve, and the menu consisted of one five and a half pound potato, one fifteen pound cabbage, one ten pound chicken, one six pound turnip, one two pound onion and three pies made from a one and one-half pound apple.

Mrs. Disraeli's Economy.

Of the rigid economy practiced by Mrs. Disraeli there is one very good story told: Mrs. Disraeli and her husband had come down from London to spend the Easter vacation at Hughenden and had called on the various tradesmen at Weycombe to order the groceries and other requirements for their ten days' or fortnight's stay.
