WATER AND LIGHT COMMISSION.

To Have Charge of Water Works and Electric Light Plants.

A bill has been sent to the legislature to establish a water and light commission for Greenville. A copy of the bill has been furnished THE REFLECTOR for publication so that the citizens of the town may know what its provisions are. It is as follows:

AN ACT TO AMEND CHAPTER 122 PRIVATE LAWS OF 1903, BEING AN ACT TO AUTHORIZE THE TOWN OF GREENVILLE TO ISSUE BONDS, BEING AN ACT TO PROVIDE FOR A WATER AND LIGHT COMMISSION FOR THE TOWN OF GREENVILLE

The General Assembly of North Carolina do enact:

1. That for proper management of water, sewer and electric light systems of the town of Greenville, a commission to be known as the water and Light Commission is hereby established. The said commission to consist of three members, who shall hold their terms of office for four years, except that the first appointees shall hold their offices as follows: J. G. Moye is hereby appointed a commissioner until the second Monday in March 1906; R. J. Cobb is hereby appointed a commissioner until the second Monday in March 1907; J. L. Wooten is hereby appointed a commissioner until the second Monday in March, 1908. And in case of any vacancy occurring otherwise than by the expiration of the term the board of aldermen shall elect a member to fill out the unexpired term. At the expiration of the terms of said commissioners there shall be elected in the same manner that the Mayor of the said town of Greenville is now elected, a commissioner or commissioners to succeed the commissioners hereinafter appointed, for the term of four years from and after the date of said election. That said commissioners shall be elected from outside of the said board of aldermen and shall be residents of said town. At such election for said commissioners the Mayor of said town shall be allowed to vote only in case of a tie, and for the purpose of breaking the tie. That no alderman of said town shall be allowed to hold office as said commissioner.

2. Said commission shall organize by electing one of its members chairman, whose term of office shall be for one year. The compensation of said commissioners shall be fixed by the board of aldermen at not less than fifty dollars per annum, to be paid monthly by the treasurer of said town, and the said commissioner who shall be elected chairman aforesaid shall receive in addition thereto the sum of fifty dollars per annum to be paid monthly as aforesaid.

3. That said commission shall have entire supervision and control of the maintenance, extension, improvement and management of the systems, and shall fix such uniform rates for water, sewerage and lights as they think best; Provided, that any person may appeal from its decision as to rates, to the board of aldermen.

4. That said commission shall faithfully see that the said systems of water, sewerage and electric lights are orderly and properly conducted, and shall superintend and provide for the operation and management of all of said systems, and shall promptly furnish on request proper connections and service to all citizens and inhabitants who apply for the same, and shall in all respects provide for the proper service of said systems to the consumers thereof, and shall promptly attend to all complaints as to defective service, and shall

cause the same to be remedied, and otherwise control and manage said systems for the best interest of said town, and citizens thereof. That they shall provide for the prompt collection of all rentals for service to consumers and shall promptly and faithfully cause said rentals to be collected and received under such rules and regulations as said commission shall from time to time require, and in accordance with the ordinances of the said town in such cases made and provided.

5. That all monies arising from the rentals of said sewer, water and electric lights systems shall be paid to the treasurer of said town of Greenville, and the said treasurer shall keep a separate account of the same and make a monthly report thereof to the mayor and board of aldermen. That the said funds shall be paid out only on the order of the said commission. That the said commission shall at the end of each quarter make a report to said mayor and board of aldermen of its receipts and disbursements, and said commission shall pay out of the receipts thereof all cost and expenses of extending, improving, maintaining and operating said systems; Provided, That should the funds arising from the operation and rentals of said systems be insufficient to pay the necessary expenses for maintaining and operating said systems then and in that event the said board of aldermen of the town of Greenville shall provide and pay into the treasury for the account of the said commission a sum sufficient when added to the funds that have arisen from the said systems to pay all costs and expenses of extending, improving, maintaining and operating said systems.

6. That the clerk to the board of aldermen of said town shall collect all rents arising from the use of the water, sewerage and electric light systems, under the direction of the said commission, and pay the same into the treasury of the said town. That the said collector shall not be allowed to retain in his possession any sum of money collected by him, as collector for said commission, for a longer time than one week. Provided that said clerk shall be required, before entering upon his duties as said collector, to give bond, approved by said commission, in the sum of two thousand dollars conditioned upon the faithful performance of his duties as said collector. That said town clerk shall act as secretary to said commission and keep such books and records as it may require. That said commission shall elect all other officers, agents and employees necessary to the conduct of said systems, and fix their remuneration; provided, that such officer agent or employee shall be elected for a term to exceed twelve months at any time to discharge and remove any such officer, agent or employee.

7. That all laws and clauses of laws inconsistent with or in conflict with any of the provisions of this act are hereby repealed.

8. That this act shall take effect from and after the dates of its ratification, and the terms office herein provided for shall begin and take effect from and after the ratification of this act.

On account of the break up of the ice gorge on the Ohio river at Cincinnati Sunday a half million dollars worth of river property was placed in jeopardy, one steamer was crushed and carried down with the ice, 150 coal barges, 30 of them loaded, were torn to pieces and several steamers were damaged.

Where a town already has prohibition it takes a step backward to establish a dispensary.

It must be said to the credit of the weather man that of late he has been plumbing the track with his predictions.

"The president and the senate at outs" is the way some of the newspapers head the rupture. But they will not be out long.

A few winters like this will convince telegraph and telephone companies that the best place for their wires is underground, even in the South.

After their tirade against each other in congress, Mr. Sullivan, of Massachusetts and Mr. Hearst, of New York, might consider honors even.

It looks like enough local bills will be introduced to keep the legislature busy as long as the pay lasts. There will hardly be an early adjournment.

Durham pulled off a wedding at 2 o'clock a. m. If it had been previously announced for that hour the bride's maids would not have been ready until 2:30.

We heard a man say that some people in the towns through which it passes are doing lots of kicking, but lessee Howland is certainly improving the A. & N. C. road.

J. B. Duke, president of the American Tobacco Co., who is on a visit to his aged father in Durham, made a donation of \$5,000 to the hospital for colored people in that city.

The Raleigh Times raises the point that it is cruel to allow the little daughter of McCue to go before the governor and plead for his life when her plea could avail naught. The point is well taken.

The whiskey folks are making about as hard a fight against the Ward bill as they did against the Watts law two years ago. It has already passed in the senate and its opponents are doing all in their power to defeat it in the house.

Vice President Fairbanks having found that he cannot attend the banquet of the Tar Heel Club, a Republican organization at Greensboro on the 22nd, the banquet has been called off for the time being. That must be very disappointing to E. Spencer Blackburn.

The speech of President Roosevelt at the Lincoln birthday dinner in New York was quite a strong plea for closer friendship between the North and the South. He seems to be coming around to the realization that we all make up one great country. It was a speech on the race problem, and if the principles he advanced were put into practice it would be better for the whole country.

The Republican party of New York is fixing to burst itself. A bill has been drawn to submit to the general assembly of that state placing a tax of two cents on every \$100

worth of stocks sold or transferred. It is said this tax will add \$5,000,000 annually to the state treasury. The tax is all right and would fall on those most able to pay it, but just think of the kicking Wall street would do over it. If the money sharks deserted the Republican party it could not get enough funds together to run another campaign.

EXTRACTS FROM THE SPEECH.

Delivered by President Roosevelt At Lincoln Birthday Dinner in New York.

The great civil war in which Lincoln towered as the loftiest figure left us not only a reunited country, but a country which has the proud right to claim as its own the glory won alike by those who wore the blue and by those who wore the gray, by those who followed Grant and by those who followed Lee; for both fought with equal bravery and with equal sincerity of conviction, each striving for the light as it was given him to see the light; though it is now clear to all that the triumph of the cause of freedom and of the Union was essential to the welfare of mankind. We are now one people, a people with failings at which we must not blink, but a people with great qualities in which we have the right to feel just pride.

All good Americans who dwell in the North must, because they are good Americans, feel the most earnest friendship for their fellow-countrymen who dwell in the South, a friendship all the greater because it is in the South that we find in its most acute phase one of the gravest problems before our people: the problem of so dealing with the man of one color as to secure him the rights that no one would grudge him if he were of another color. To solve this problem it is, of course, necessary to educate him to perform the duties, a failure to perform which will render him a curse to himself and to all around him.

Most certainly all clear sighted and and generous men in the North appreciate the difficulty and perplexity of this problem, sympathize with the South in the embarrassment of conditions for which she is not alone responsible, feel an honest wish to help her where help is practicable, and have the heartiest respect for those brave and earnest men of the South who, in the face of fearful difficulties, are doing all that men can do for the betterment alike of white and of black. The attitude of the North toward the negro is far from what it should be and there is need that the North also should act in good faith upon the principle of giving each man what is justly due him, of treating him on his worth as a man, granting him no special favors, but denying him no proper opportunity for labor and the reward of labor. But the peculiar circumstances of the South render the problem there far greater and far more acute.

Laziness and shiftlessness, these and above all, vice and criminality of every kind, are evils more potent for harm to the black race than all acts of oppression of white men put together. The colored man who fails to condemn crime in another colored man, who fails to cooperate in all lawful ways in bringing colored criminals to justice, is the worst enemy of his own people, as well as an enemy to all the people. Law abiding black men should for the sake of their race, be foremost in relentless and unceasing warfare against law-breaking black men. If the standards of private morality and industrial efficiency can be raised high enough among the black race then its future on this continent is secure. The stability and purity of the home is vital to the welfare of the black race, as it is to the welfare of every race.

In the next place the white man, who, if only he is willing, can help the colored man more than all other white men put together, is the white man who is his neighbor, North or South. Each of us must do his whole duty without flinch, and if that duty is national it must be done in accordance with the principles above laid down. But in endeavoring each to be his brother's keeper it is wise to remember that each can normally do most for the brother who is his immediate neighbor. If we are sincere friends of the negro let us each in his own locality show it by his action therein, and let us each show

it also by upholding the hands of the white man, in whatever locality, who is striving to do justice to the poor and the helpless to be a shield to those whose need for such a shield is great.

The Southern States face difficult problems; and so do the Northern States. Some of the problems are the same for the entire country. Others exist in greater intensity in one section; and yet others exist in greater intensity in another section. But in the future they will all be solved; for fundamentally our people are the same throughout this land; the same in qualities of heart and brain and hand which have made this republic what it is in the great today; which will make it what it is to be in the infinitely greater tomorrow. I admire and respect and believe in and have faith in the men and women of the South as I admire and respect and believe in and have faith in the men and women of the North. All of us alike, Northerners and Southerners, Easterners and Westerners, can best prove our fealty to the nation's past by the way in which we do the nation's work in the present; for only thus can we be sure that our children's children shall inherit Abraham Lincoln's single-hearted devotion to the great unchanging creed that "righteousness exalteth a nation."

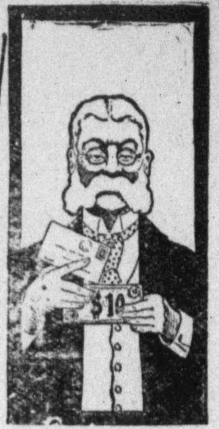

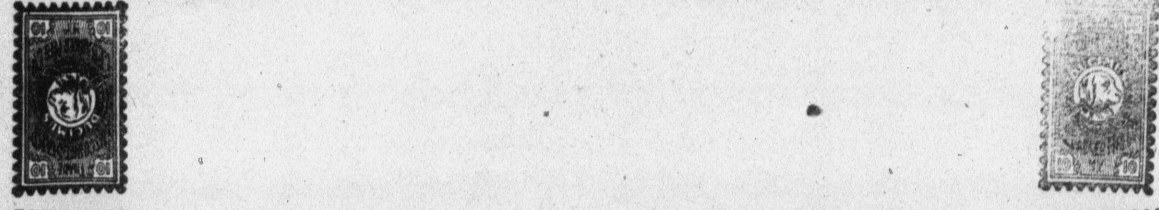

The Snow Storm of 1804.

One hundred years today there was a great snow in this part of the country. The Monroe Enquirer, of several years ago, published the following story.

"Mr. D. D. Rogers, an old citizen of South Monroe township, asks us to 'put on paper,' the big snow storm of 1804, an account of which his mother, who was at that time ten years old, has left him. Mrs. Rogers was living in the Providence section, in Mecklenburg county, when the snow fell. The storm commenced on the 14th of February and for four days and three nights there was a constant fall of snow. On level land the snow was six feet deep, and in many places was rifted to the eaves of one-story houses. Two carpenters from Wadesboro, who were at work in the Providence neighborhood, started home the day the snow began to fall, and several days afterwards their frozen bodies were found near Richardson's creek, on the old Three Notch road. Mrs. Rogers' record says that there was great suffering, as the weather was unusually cold, and a great many head of cattle and other stock were caught in the snow and frozen."

A Charlotte man who had this record pasted in a clock was kind enough to give The Observer a copy of it.—Charlotte Observer.
