### THE LEGISLATURE.

SATURDAY.

In the senator there was another day of nothing but local bills. One bill introduced provides that the power of governing boards of any municipality to contract indebtedness for expenses shall be restricted to the term of the incumbents and not bind any future board.

The house had a heavy day's work. There were a large number of new bills and many already on the calendar were acted upon. None of the new bills were of special importance and it begins to look like the more important matters are to be crowded into the last few days of the session.

One of the bills introduced was to divide the state into two judicial districts to be known as the Eastern and Western districts.

### Society Gambling.

Superior Court Judge John H. Martin, of Georgia, has created something of a sensation by his charge to the grand jury, at Hawkinsville Monday, which contained the following:

"I charge you that society people, be they male or female, who form social clubs and meet from time to time at the homes of the members and play whist, progressive cuche, fiuch, trail, bunco or any other game with cards or like devices for valuable prizes purchased with funds to which the players have contributed, are as much guilty of violating the law against gambling as the veriest plebeians who hoyer round a light-wood knot fire and play seven up, or poker, or skin for the paltry pennies and nickles, and the person knowingly permitting such playing at his or her house is as guilty of the offense of keeping and maintaining a gambling house, as is the proprietor of the den in some back alley where gambling is practiced.

Quit you like men, be strong, and when weighed in the balance of duty be found not wanting. Strike at this evil in high places as well as in low places with all your might. It is not less criminal to play for a silver card case than for a plain silver dollar as it comes from the mint."

### The Report False.

Elizabeth City, Feb. 18.—The report that reached here last night of the finding in an abandoned lumber camp of little Kenneth, the son of State Senator Beasley, has been thoroughly investigated and found to be untrue. There seems to have been no foundation for the story. It was merely one of those wild rumors that spring up from some irresponsible and often untraceable source when the nerves of a community are on the rack of suspense.

Though no clue to the whereabouts of the lost child has been discovered, the search continues. The people will not give up the quest, even though "Hurricane" Branch has admitted defeat and has returned to Suffolk, carrying his bloodhound with him.—Raleigh News and Observer.

### TO PROVIDE FOR SEWERAGE

Town Must Borrow Ten Thousand Dollars.

A bill to authorize the board of aldermen of the town of Greenville, in Pitt county, to borrow money not to exceed ten thousand dollars, for the purpose of establishing a sewerage system for said town.

The General Assembly of North Carolina do enact:

SECTION 1. That the board of aldermen, of the town of Greenville, North Carolina, are authorized and are hereby empowered to borrow a sum of money not to exceed ten thousand dollars to be used for the purpose of establishing a sewerage system for the town of Greenville.

SEC. 2. That all laws in conflict herewith are hereby repealed.

SEC. 3. That this act shall be in force from and after its ratification.

The foregoing is a copy of a bill which has been forwarded to our representatives at Raleigh, authorizing the board of aldermen of the town of Greenville to borrow ten thousand dollars to be used for the purpose of establishing a sewerage system for the town of Greenville. The authorities of the town desire to have this bill passed in order that there may be no question as to the authority of the board of aldermen to borrow money for this purpose.

The town needs a sewerage system and this is the most opportune time for providing the same.

### End of War Seems in Sight.

St. Petersburg, Feb. 18.—In diplomatic circles the opinion is quite generally expressed that yesterday's tragedy may be followed by the decision of the government to conclude peace. For some time despite the official attitude maintained by the government, there has been a growing appreciation of the difficulties of prosecuting the war in the midst of increasing complications at home, and, as announced yesterday, the matter was actually the subject of formal consideration by Emperor and his Ministers February 17. Strong influences, which, it is understood in spite of denials, are headed by Witte, president of the committee of Ministers, have been working quietly in this direction. Gen. Gripenberg's revelations, followed by the murder of Grand Duke Sergius, in the opinion of some of the ablest diplomats are not unlikely to lead the Emperor definitely to decide upon peace. In this connection the War Office is considerably alarmed by the new danger threatening the Manchurian army from the systematic making by Japanese and Chinese bandits to cut the line of communications back of the army. According to reports, about 10,000 men split up into bands of several hundred each, are separating from Mongolia and are striking at the railroads. A Russian detachment following up the Japanese band which cut the road below Harbin fell into an ambush of two regularly organized Japanese regiments and was almost cut to pieces, losing half its men and one gun. The fear is that if the bands move further north or west they might interrupt communication to such an extent as to make it impossible to supply the army. This danger has already compelled the triple re-enforcement of the railroad below Harbin.

This week is one in which the legislature will probably make history.

The state lost a good citizen in the death of Hon. Augustus Leazer, which occurred last week.

Some legislator might introduce a bill to incorporate the ground hog's hole, or to make it a stock law territory.

No doubt we will hear something on both sides of the question from the meeting of the state executive committee.

As might have been expected, the legislature killed the proposed dog tax. The dog is by far the freest and most privileged citizen in North Carolina.

Here are some figures to think over. The pension appropriation passed by congress calls for \$138,250,100. And the war has been over about forty years.

The statue of Francis Willard, the distinguished temperance advocate, has been placed in statuary hall of the capitol at Washington. This is the first statue of a woman to be given a place in the hall.

The Bank of Fayetteville was closed Saturday by the state bank examiner, a shortage of \$28,000 being found in the accounts of the cashier and teller. R. T. Gray, of Raleigh, was appointed receiver of the bank.

Representatives of South Dakota say that state will not become a collecting agency to help other holders to collect for the bonds they have against the state of North Carolina. All the same she wants pay for the bonds she holds.

Greensboro has captured the next meeting of the state teachers assembly. That city offered \$1,000 for the assembly to meet there and the offer was accepted. That is a good way—when you want a thing reach down in your pocket and pay for it.

The legislators should leave enough in the treasury so that they will have no trouble in drawing their pay.—Durham Herald.

No cause for uneasiness along that score. They will draw their pay all right, and for the full sixty days time.

In order to keep us in the straight and narrow path the legislature might make it compulsory upon us to attend church once on Sunday and prayer meeting every Wednesday night.—Durham Herald.

And then make it a misdemeanor to go to sleep in church or to write in the hymn books.

The bosh about the Democratic party being ruined by anti-whiskey legislation is being reshaped. If the party cannot be held together except by whiskey it does not deserve an existence. But there is little danger of it being ruined by this scare. The sooner every place in the whole country where liquor is made or sold is closed, the better it will be for the country.

## The Religious Awakening

Coming events cast their shadows before them, and often impending sorrows are foreshadowed by dark hints of ill. May it not be true that their opposites are sometimes foreseen and that the hopes entertained by the Christian churches that America is on the eve of a great religious awakening may be realized? The Chronicle several weeks ago told of the great revival in Wales, of which the somewhat slower papers are now giving details. But, following out the thought just expressed as to the religious awakening in America, we find a statement in The New York Christian Intelligencer, which supports the belief that it is to be widespread. According to The Intelligencer, there seems to be clouds forming in the spiritual heavens, like Elijah's little cloud that arose out of the sea, which promise a downpour of blessing. Already from some quarters "there is a sound of abundance of rain." From England and Wales and Australia across the sea, the good news of salvation to thousands greets our ears; and we hear of "showers of blessing" here and there in our own country—for instance, Binghamton, Ogdensburg, Pittsburg, Denver and notably at the present time, Schenectady, not to mention places of less note, and some single churches which have enjoyed a revival just as real and no less wonderful. As pebbles cast upon the placid bosom of a lake, each pebble starting its own set of circling waves, soon agitate the lake's entire surface, so may these revival centres in our land and Europe send forth their waves of gracious influence unto the uttermost borders. For this let Christians everywhere earnestly pray and diligently labor, for it is by both prayer and effort, with implicit reliance on the convicting and regenerating power of the Holy Spirit, that this blessing is to be realized.—Charlotte Chronicle.

C., life-saving crew conquered a heavy sea piling over the shoals and succeeding in taking ashore from the standard four-masted schooner, Sarah Derossen, her captain and five of her crew. One man was washed overboard Wednesday and drowned.

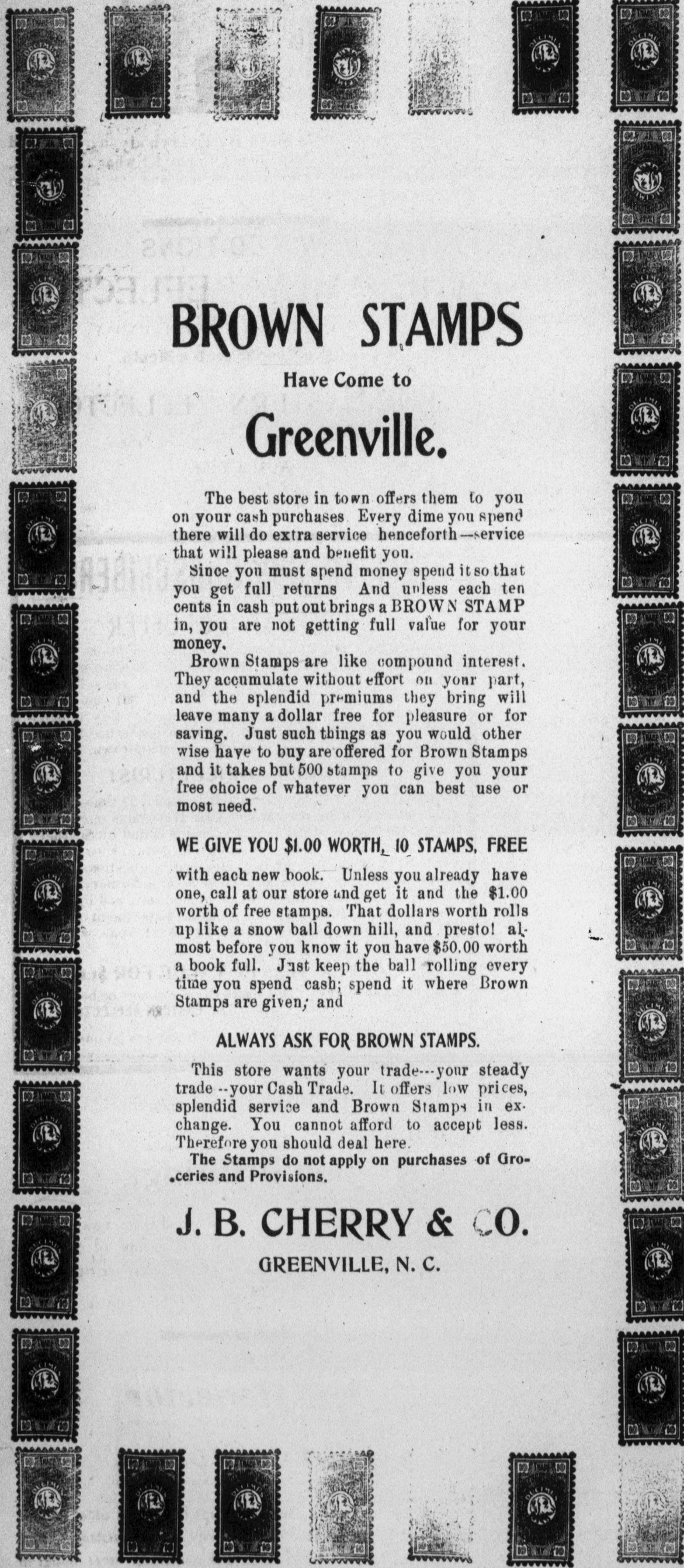

### LETTER TO GREENE & HOOKER.

Greenville, N. C.

Dear Sirs: You understand grinding wheat, buckwheat, rye, oats and corn. We understand grinding white-lead and white-zinc. The two sorts of grinding are not much alike. Very likely oats and wheat behave very differently in the mill, and you manage them differently—we know very little about your work; don't need to; we'd rather depend on you.

But we paint your house and mill, and out-buildings; perhaps you'd be glad to know about grinding paint; for some people mix their paint with a stick in a tub.

We use lead-zinc—nothing else. And our zinc is as tough as your oats. Tub mixers imagine they mix it. They don't; they can't. Takes grinding to mix lead and zinc.

They are both white; when are they thoroughly mixed? Tub-mixers don't know it; but tub-mixed lead-and-zinc is a streak of one alongside of a streak of the other.

We grind as you grind; and our paint is lead-and-zinc ground together, mixed intimately; it is neither lead nor zinc, but lead-and-zinc; the lead is lost, and the zinc is lost; each lost in the other; both lost in the mixture. Lead chalks and zinc peels; lead-and-zinc ground together hang on and protect each other.

We take care of your mill outside; you take care of it inside.
