THE LEGISLATURE.

FRIDAY.

Senator Fleming introduced the bill to authorize the town of Greenville to borrow a sum not to exceed \$10,000 to establish a sewerage system. He also offered an amendment to the law conferring power to foreclose a mortgage.

The bill to provide for the appointment of a court stenographer for Pitt county passed third reading.

In the house Representative Laughinghouse introduced a bill to prevent muddying the waters of Little Contentnea creek, and Representative Little one to amend the charter of the town of Pactolus.

The bill to amend the charter of the town of Falkland passed third reading. The Laughinghouse bill regulating passenger fares on railroads passed third reading. The bill was amended so as to make first class fares not over 3 cents per mile and second-class fares not over 2 1/2 cents.

SATURDAY.

The senate by a vote of 24 to 16 defeated the bill to authorize an issue of bonds in the amount of \$100,000 for the purpose of constructing a hall of records.

A joint resolution was offered providing for an appropriation of \$50,000 for a North Carolina exhibit at the Jamestown exposition, the sum to be paid in three equal amounts out of the taxes of 1905, 1906 and 1907.

Among the new bills introduced were: To prevent fire insurance companies from limiting the commissions agents receive from other fire insurance companies; to provide for the annotation of the statute laws of North Carolina.

Three bills relative to Pitt county passed third reading. These were for the betterment of the public roads of the county; to add to the present stock law territory; to provide for turning into the general fund one-third of the dispensary profits.

Among the new bills in the house were: To amend the law relating to the sale of cotton seed by adding peanuts; to exempt pullman car conductors from jury duty; to make carrying concealed weapons a felony; to settle the debt of the University to the late Governor Swain; to amend the code relative to the service of process on insurance companies.

The bill to provide for a permanent light and water commission for Greenville passed third reading.

THE MEETING.

Dr. Black and Mr. Burr Here for Eight Days.

Dr. William Black, state evangelist of the Presbyterian church, accompanied by Andrew Burr to lead the singing, reached Greenville Saturday evening to hold an eight days meeting here. Dr. Black held three services on Sunday, at 11 a. m., in the Presbyterian church; at 3:30 p. m. in the Methodist church and again at night in the Presbyterian church. The Baptist and Methodist churches were both closed Sunday night, all the congregations joining together in the service in the Presbyterian church, filling the building to its utmost capacity.

Dr. Black held a splendid meeting here in 1897 and is most pleasantly remembered by the people of the town, who gladly welcome him here again.

His former meeting resulted in much good, and the interest shown at the very beginning of the present meeting indicates that a great blessing is to come out of it. Every Christian in the community should labor and work earnestly for the salvation of souls. In no other way can the blessing Greenville needs be secured. Dr. Black is a strong, earnest speaker who declares the truth of God's Word plainly. He and the local ministers will do their duty fully, and if the Christians and people of the community generally cooperate earnestly with them the blessing is certain.

There will be two services each day, at 10 a. m. and 7:30 p. m. All are cordially invited to attend and participate in the services.

Captured Flags to be Returned.

The phrase, "No North, No South," may henceforth possess axiomatic strength, for the senate today passed the house bill directing the secretary of war to return all captured Confederate flags. Heretofore efforts to secure passage of such a bill has availed nothing. Senator Overman called the attention of the writer, immediately after the bill passed, to the fact that President Cleveland called down upon his head the maledictions of the G. A. R. by recommending in a message to congress the passage of a bill of this character. Opposition also came from other sources, but today the senate took favorable action on the bill, which is of decided historical interest. As a matter of course, it is assumed that President Roosevelt will promptly affix his signature to the bill, and that the secretary of war, will then communicate with Governor Glenn regarding the delivery of flags that will go to North Carolina.—Washington Cor. Charlotte Observer.

MONDAY, FEB. 27, 1905.

This is the big week in Washington. The president will be inaugurated Saturday.

After this week Raleigh can take a back seat for a time, as the legislature will be over.

The Durham Herald says it is Mrs. Davis' next move. We hope Mrs. Davis will not move. She has paid as much attention to Miles as there is any necessity for.

The Swaine impeachment matter is about to come to a vote in the senate and will soon reach its end. There will be a sigh of relief throughout the country when it is over.

Andrew Carnegie is going to put a roll of his surplus money in the University of Virginia. He has offered to give that institution a half million dollars on condition that the authorities raise a like sum from other sources. It is reported that the offer will be accepted.

The matter of recovering property in the heart of New York city, estimated in value at \$300,000,000, being embraced in 160 acres of land that was leased to the city a hundred years ago, is again being agitated. The names of several North Carolinians are mentioned among the heirs to the property.

A Rockingham farmer suggests that while the farmers are "resoluting" about cotton, if they would add one more section to the effect that they would wear no goods except such as are made of cotton, it would help materially in advancing the price. If the farmers would make such a resolution and stick to it, the demand for cotton goods would greatly increase.

"Cider"

One thing that always follows prohibition is more or less of a flood of a decoction ordinarily called "cider" and the word "cider" seems to cover a multitude of drugs. One chap in a dry town in Virginia, the other day, got too much of it and died. The coroner's jury that "set" on the case found that the man "came" to his death indirectly by the continued drinking of so-called cider, which from the evidence before us, we believe contained some poisonous drug, and which is being sold in Williamsburg and vicinity." In Charlotte, since prohibition came in, several patriots have been hauled up drunk from drinking "cider." Dealing with the Virginia case, The Times-Dispatch says what is known to be a truth, that for years preparations called cider, and sometimes called "pure apple cider," have been sold promiscuously, when in point of fact the miserable stuff even saw a cider mill, but was manufactured by processes known to latter day chemists. Every such preparation should be analyzed by the authorities, and if found to contain poisonous drugs, should, of course, be prohibited. Moreover, it should be made a misdemeanor for any person to offer for sale under an assumed name any fake preparation masquerading as apple cider. The cider that is spiked and offered to the thirsty as a substitute for whiskey is a dangerous thing and should be avoided. Better still municipal authorities should prohibit its sale. The purely chemical cider is a thing that kills.—Charlotte Chronicle.

The Monroe Doctrine And Santo Domingo.

The Monroe Doctrine itself, by reason of the generality of its terms, is susceptible of extravagant constructions; and yet there is no principle in the support of which, when properly applied, the American people are more united. The vital principle of the Monroe Doctrine is the limitation of European influence and control in the Western Hemisphere. If a situation similar to that now prevailing in Santo Domingo existed in a European country, it would be dealt with by a combination of European powers or by some one power acting alone as their delegate. In Santo Domingo, European powers have material interest similar to those of the United States; but in view of its settled policy, the United States would now be unwilling either to permit the measures necessary for the reestablishment of order and credit to be taken by European powers or to take them itself in conjunction with such powers. The situation in a nutshell, is that either the United States must take the necessary action or it must not be taken at all. According to the Roosevelt corollary, action must be taken, and it must be taken by the United States. A ready test of whether this position should be commended or condemned may be furnished by putting into concrete form the converse proposition, which would run substantially as follows: "Chronic wrong-doing, or impotence which results in a loosening of the ties of civilized society, though much to be deplored, must in America be permitted to continue unchecked, since it is not the policy of the United States either to interfere with such things itself or to permit any other power to do so."—From "San Domingo and the United States," by John Bassett Moore, in the American Monthly Review of Reviews for March.

It is generally this way, but we do not remember it ever having been so bad as at this session. The legislators have frittered away valuable time over local and nonsensical matters which should never have been brought before it, and the consequence is that important matters in regard to state affairs will suffer by reason of hasty action and poorly prepared bills.—Wilmington Messenger.

THE HIPPOPOTAMUS.

Unouth Antics of This Unwieldy Animal in African Waters.

"In the channels which traverse the marshes of certain districts in central Africa," writes a traveler, "hippopotami in incredible numbers are met with—sometimes in herds of sixty and seventy. Wherever the channel widens out into a reedy lake rows of grotesque looking heads with ears erect appear above the water surface, their owners studying the extraordinary apparition produced by the steamer. On approaching the spot these heads disappear, one after the other, under water, and a series of waves and large ripples indicate the passage of the monster forms below the surface. After a few minutes' time the same huge heads reappear, generally downstream of the boat. They have another stare and again disappear, with a snort and the expulsion of a small volume of water from the nostrils. Not infrequently a severe bump is felt in the steamer, making the whole hull quiver, as the back of a hippopotamus seeking to escape has touched it.

"If the water should happen to be shallow, the attempts of these animals to hide themselves are ludicrous, as their movements are clumsy and their anger and fear are evident. In such cases their heads and the fore parts of their bodies are under water, and nothing is seen but the huge pink hind quarters, struggling, kicking and churning up the water in the effort to get out of sight. Although their unouth antics may be safely watched from a steamer, it is a very different matter if the observer is in a canoe or a small boat. Then his position is one of considerable danger, as he stands a very good chance of being upset.

"As the water of all these channels swarms with crocodiles, such a contingency is not pleasant to contemplate. The natives are fully alive to this risk and never venture in their dugout canoes into the broad streams infested by hippopotami, but invariably keep to the shallow and narrow branches on either side of the main river."

The "Plimsoll Mark."

Many a person has looked at a British ship lying in low water and wondered what was meant by a circular mark with a straight line running through it which is to be seen on the side of the vessel. This is known as the "Plimsoll mark." Samuel Plimsoll, the friend of seafaring men, devoted the best years of his life to furthering the interests of sailors. He noticed that overloaded and unseaworthy vessels were often sent on voyages, with great danger to human life. He tried to induce the British parliament to alter matters; but, failing to do so, he himself entered the house of commons in 1868 and succeeded in getting the merchant shipping act passed. By this act the board of trade was empowered to detain any vessel deemed unsafe. Finally owners were ordered to have a load water mark painted upon their vessels' sides.

Very Dear at the Price.

Queen Caroline, the wife of George II., seriously thinking of closing St. James park, in London, and turning it into a garden for the palace, asked Sir Robert Walpole what it would cost to do so. "A trifle, madam; only a trifle," replied the minister. "A trifle?" rejoined her majesty. "I know it must be pretty expensive, but can't you tell me as nearly as you can guess?" To which Sir Robert answered, "Why, madam, I believe the whole thing will cost but three crowns." The queen had sense enough to see Walpole's allusion to the crowns of England, Scotland and Ireland and said at once that she would abandon the notion.

SIGHTSEERS' HEADACHE.

Caused by Strain on the Elevator Muscles of the Eye.

"Academy" or "sightseers'" headache is a not uncommon experience, and some observations of Simeon Snell appear to throw some light on its causation. Allowing that in certain instances astigmatism or other form of ametropia is a factor in its production, he yet argues that there are other influencing conditions. In support of this he quotes the experience of a lady who always suffered from severe headaches after visiting the theater when she had occupied a seat in the pit, but was free from such a disturbance when she sat in the dress circle. In the first position, it is pointed out, sustained action of the elevator muscles of the eyeballs is required in order to see the stage, and this is exactly the action which is required in studying a collection of pictures and more especially in looking at those which are hung "above the line."

The same experience has been noted by Mr. Snell in the case of cyclists, particularly of those who lean over the handle bars with the head lowered and who, therefore, in looking ahead keep the eyeballs upward. A further argument is found in the experience of miners' nystagmus, which, it is suggested, is due to weariness of the elevator muscles of the eyeballs, caused by the constrained position in which the miner works. There can be no doubt of the physiological fact that lateral movement of the eyeballs is much more easy and requires less muscular effort than movement in a vertical plane. All this goes to show that muscular strain is involved in sustained upward movement of the eyeballs, and this may well result in a sense of weariness or more pronounced discomfort.—London Hospital.

A Comprehensive Answer.

Diner—How comes this dead fly in my soup?
 Waiter—In fact, sir, I have no positive idea how the poor thing came by its death. Perhaps it had not taken any food for a long time, dashed upon the soup, ate too much of it and contracted an inflammation of the stomach that brought on death. The fly must have had a weak constitution, for when I served up the soup it was dancing merrily on the surface. Perhaps—and the idea presents itself only at this moment—it endeavored to swallow too large a piece of vegetable. This, remaining fast in the throat, caused a choking in the windpipe. These are the only reasons I can give for the death of that insect.

He directed her to use glycerin whenever affected by that peculiar dryness of the throat that attends bronchitis. Five drops of glycerin held as long as practicable in the mouth, with lips closed, proved indeed a wonderful aid. The doctor further said that equal parts of glycerin and water dropped into the mouth would relieve much suffering in illness where feverish conditions existed.—Harper's Bazar.
