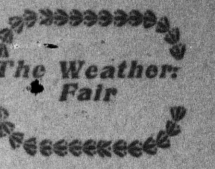

All cases reported are in east Kinston and they are being taken to the pest house where practicable.

The disease is in such a mild form that it has hindered locating it and in fact there isn't a doubt but that there has been some cases in the city that did not even stop the victim from work.

But while the situation is serious we reiterate that it is not alarming, and the authorities are taking the necessary steps to stamp it out. To do this it is the opinion that compulsory vaccination should be ordered and the sanitary board has been called to meet late this evening and consider advising the board of aldermen to pass an ordinance to that effect.—Kinston Free Press.

#### STATE NEWS.

The residence of R. C. Strong, in Raleigh, was destroyed by fire Tuesday morning.

Charlotte Observer says there is yet much unpicked cotton in the fields in Mecklenburg county.

A tobacco warehouse and a storage house were destroyed by fire in Lumberton Tuesday afternoon. Thirty-two bales of cotton and ten pianos and organs stored in one of the buildings were lost.

##### Preparation for Inauguration.

Washington, Feb. 28.—With the bulk of the arrangements for the inauguration of President Roosevelt on March 4th completed, the work today narrowed down to winding up the final details. The Governors of fourteen states are expected to participate in the parade. They are: Governors Ball, Vermont; Roberts, Connecticut; Cobb, Maine; McLaue, New Hampshire; Higgins, New York; Lea, Delaware; Cummins, Iowa; Wagner, Michigan; Blanchard, Louisiana; Pennypacker, Pennsylvania; Montague, Virginia; Glenn, North Carolina; Herrick, Ohio, and Warfield, Maryland.

The influx of inaugural visitors has begun and all the railroads entering Washington have made preparations to handle immense crowds from every quarter of the country. Some of the regular troops, including the Seventh United States cavalry, from Georgia and 300 troopers of the Ninth Cavalry from Missouri, have arrived. Capt. Seth Bullock, former sheriff of Deadwood county South Dakota, and a personal friend of President Roosevelt, who will command a detachment of cowboys in the parade, reached here ahead of his detachment in order to arrange for their reception.

##### Former Tar Heel Suicide.

Baltimore, Md., Feb. 28.—Among the papers of Capt. Wm. S. Winder, a Confederate veteran, aged 71 years, who shot and killed himself in his home here Saturday was found a clipping of the address by Wm. Osler, of the John Hopkins University, in which reference was made to the uselessness of men over 60 years of age. Capt. Winder, who was a bachelor, had led a retired lonely life for some years. His sight had practically failed, and recently he had suffered from insomnia. Capt. Winder was born in Smithville, N. C. (now Southport) He was a son of General John H. Winder, of the United States army, and descendant of General Winder who commanded a division of the American troops at the battle of Bladensburg.—Winston Journal.

##### Rockefeller Finds A Leak in Church.

Few York, Feb. 28.—John D. Rockefeller attended service at the Baptist church, at Lakewood, N. J., with his wife yesterday. When the collection box was passed around he dropped in \$35. At the conclusion of the service he told the pastor, the Rev. W. G. Wedemeyer, that he observed a leaky spot in the roof of the edifice.

"You have it fixed and send the bill to me," said Mr. Rockefeller. "The church grounds need cleaning up now that spring is near, and I'll be glad to pay for having that done also."

##### Train Detained.

The passenger train was detained about 30 minutes at the depot this morning in order that persons going to the inauguration would have sufficient time to obtain tickets.

It is evidently true that President Roosevelt intends to give the colored "gemmen" a "square deal" at the inauguration. We suppose Booker T. will do the cutting.

We understand that under the Wats law it was the duty of the county officials to help stamp out moonshine stills, yet if any effort has been made in this direction the news did not leak out.—Durham Herald.

The erection of a Hall of Records at this time, in our mind, is a mistake. The tax payers of North Carolina have already punched holes in the bottom of their pockets hunting for tax money.

Since the Ward bill has become a law there are some towns in the state that will have no further need for a charter. They can move back in the country and save town taxes when the distilleries close.

There are now fifty counties exempted from the operations of the anti-jug law. We cannot see for our lives why our law makers did not make it unanimous. Surely money and time could have been saved.

A Russian immigrant who has just finished a term on the chain gang in South Carolina for a petty offence, says he would like to stay there the remainder of his life. He says life as prisoner in America beats freedom in Russia.

It strikes us that the railroad should take a turn and make Durham do something. Durham kept hammering until the railroad was made to build the depot and now the railroad ought to hammer Durham into opening a way to get to it.

The others engaged in the business had as well begin to look at it like Williamston does—that distilleries are doomed enterprises in North Carolina. That man is not wise who invests his money in a distillery in preference to some legitimate business.

In South Carolina, a paper has taken the desperate chance of condemning the name of a woman's club. The name of the club is "Auf Wiedersehen," and the editor of that paper made the charge that the name was "somewhat foolish and meaningless." Poor fellow, he sowed the wind, never dreaming of reap-

ing a whirlwind. From last accounts he had business up the road.

Judge Cook has stirred up some thing of a sensation in Reidsville. #### Pass It, Gentlemen.

The General Assembly must certainly not forget the vagrancy law. Whatever chance there may have existed for this bill relating to an important law being forgotten has been dispelled by the remainder sent to both branches of the Legislature yesterday by the Governor. The necessity for such a law may not appeal with the same strength to the representatives and senators of the small places as it does to those from the cities; consequently the latter should impress the matter clearly and logically upon the former. The small places do not prove as fertile fields for the professional gamblers as do the cities nor do they know as many drink-loving husbands and dissipated sons, who delight in indulging in idleness while the mother and daughter provides not only the comforts of a home for them at the expense often of a great physical suffering, but many a time innocently supplies money for these human vultures to "throw away."

City ordinances generally reach the "nigger" who basks in the sun while his sweetheart takes enough from the pantry of her white employer to support him in slothfulness, but they do not go far enough to reach that class of people with hearts blacker by many shades than the face of the "nigger." That a man in the full possession of both faculties and health will live in laziness on the hard earnings of the wife, or daughter, who perhaps either toils with dim eyes until late at night with the needle, or labors from morn' until night amid the dangers of the mill, is inconceivable.

Yet that is precisely what is transpiring daily. In that direction the law do the most good and it will be good that will send sunshine into many darkened homes and that will prevent—by the knowledge of its existence—clouds from gathering around many firesides.

Then it will take a bull's-eye shot at the professional gambler. It will tear down the shade that masks him and others of his stripe from the public gaze and the just wrath of the law.

Gentlemen of the General Assembly, you may not pass this bill, but that will not efface the fact that you should have done so.—Wilmington Dispatch.

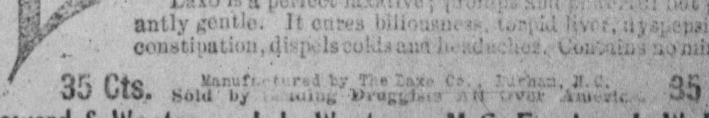
