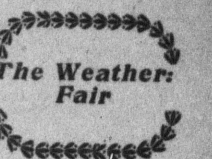

Double Tragedy in Wilmington.

Wilmington, N. C., March 4.—The house of ill fame in MacRae street, where a double tragedy took place last night must be closed. That is the gist of the ultimatum delivered personally by Mayor Springer today shortly after noon to the woman, Gussie Greer, who keeps the place. The body of H. Smith, a young man who formerly lived near Detroit, Mich., who shot and killed Stella Campbell and then sent two bullets crashing into his own brain, is being held here until relatives are heard from. Both of the victims died at the James Walker Memorial Hospital, where they were carried last night. It is generally conceded that Smith was partly crazed by drink when he committed the deed.—Raleigh Post.

Japanese Victory.

Berlin, March 4. —A dispatch to the Tageblatt from St. Petersburg says. "General Kuropatkin in a telegram which arrived here at 7 o'clock last evening, said 260,000 Japanese had broken through the Russian left wing, that it was cut off from the remainder of the army. "At 10 o'clock came another dispatch from General Kuropatkin which read: "The Japanese are marching on Mukden. My position is extremely dangerous." In government circles here today there is a conviction that General Kuropatkin has been fully beaten, that part of his army has been dispersed and that the railroad north of Mukden will probably be cut.

Smallpox From a Letter.

The Sanford Express quotes Dr. McLeod, county physician of Moore as saying that the smallpox was carried to Jonesboro in a letter. It says: "Dr. McLeod says the disease was carried to that section by a letter which a young man by the name of Gunter, who had the smallpox at McCall, S. C., wrote to his mother, Mrs. Gunter, who had been vaccinated years ago, read the letter and handed it to her daughter. The daughter contracted the disease while the mother escaped. It seems from that there must be some virtue in vaccine."

Mukden is Burning

St. Petersburg, March 4.—General Kuropatkin reports that the Russians are burning Mukden stations and their stores preparatory to a retreat. There are persistent reports that the Russian left has been successful, but that their right is panic stricken. One hundred Japanese cavalry arrived from the north this afternoon. They exchanged shots with Russian scouts in the outskirts of the town. Two hundred Cossacks are three miles east moving north. The Japanese are scouring the country side.

Unusually Late Easter.

Easter falls this year on April 23. It may be of interest to know that it will occur later than this only one time during the next 95 years or until 2000 A. D., and only twice will it occur as late as this during the same length of time. In 1943 it will fall on April 25, and in 1916 and 2000 on April 23, the same as this year.

The warmer weather has induced the baseball fans to organize a team and begin practicing for the coming season. They practiced a while this afternoon on the old diamond on Clark's field.

THE MEETING

"That Great Day Of The Feast."

Words fail us to describe adequately the three services conducted by Dr. Black Sunday last. We think of the words: "In the last day, that great day of the feast"—for Sunday was indeed a great day of the spiritual feast, and on this feast day Jesus stood in the midst and cried, saying, "If any man thirst, let him come unto me and drink." God's people have been made to hunger and thirst after God and righteousness and more of life eternal. The unsaved are made to see the value of a hope in God, for "what shall it profit, if a man gains the whole world, and lose his soul?"

The Presbyterian church was crowded Sunday morning and literally packed at night, with eager, expectant worshippers. None who came went away disappointed, we think. The blessed gospel of our Lord was faithfully preached by Dr. Black and tenderly and effectively sung by Mr. Burr and the choir who so efficiently support him.

The service at the opera house Sunday afternoon, for men only, was deeply impressive. Who among the 400 present can forget, or would like to forget, the singing and the sermon? We venture to say that not a man went to that meeting and came away without better hopes and desires being kindled. Perhaps 250 in that company of men, men who have not turned their faces toward God and their lives against sin, expressed a desire to escape God's wrath and be saved, without waiting for a judgment from Heaven.

Men, oh men, remember your God, yes, your "God stands waiting to be gracious." He is able and willing to save. Doubt no longer. God grant deliverance from sin to more men in Greenville. So much pressure was brought to bear upon Dr. Black at the last minute by men of the different churches in the city, that he consented to remain one day longer, although attended by much inconvenience to himself. It is needless to say that the people of Greenville deeply appreciate this generous act.

Crooked Congressman.

Washington, March 4.—Binger Hermann, member of congress from Oregon, and former commissioner of the General Land office, has been indicted by the Federal grand jury here on the charge of destroying public records. The substance of the charge is that Mr. Hermann just previous to his resignation as commissioner of the General Land office, which was on February 1, 1903, destroyed 35 letter press copybooks, containing copies of official communications written by him as Commissioner of the General Land Office and relating to the business of the bureau. Mr. Hermann's attorney appeared in court immediately after the indictment had been found, and on behalf of his client waived the exemption due a member of Congress, and bail was fixed at \$2,500. Mr. Hermann in a statement declared the charges untrue and without foundation.

Big Catch of Rabbits.

County Commissioner J. R. Barohill tells us of a big catch of rabbits over in his neighborhood. On Saturday O. E. and R. T. Whitehead, who live near Grindfield creek, burned off a straw field and the crowd that gathered captured 43 rabbits, four partridges and one mink. The whole neighborhood feasted on rabbit Sunday.

Mrs. Davis has written another letter about the Miles affair. More's the pity.

Sunday was a dry day in Greenville, not even a coca cola. That is right. Let it so continue with business confined to the six week days.

Representative J. B. Little, of Pitt, has good grounds for a pull on the Raleigh News and Observer. His picture in Sunday issue of that paper was just too bad.

The inauguration of the president with all its attendant pomp and pageantry took place Saturday. It was a big affair but largely overdone and accompanied by great extravagance. Such things come high.

The members of the state senate on Saturday presented a beautiful silver service to Lieut. Gov. F. D. Winston as a mark of their esteem. It was a splendid tribute to the manner in which he has presided over the deliberations of the body.

It does look at this distance that the Czar of Russia ought to be able to foresee the defeat of his army in this war with Japan and stop the bloody conflict. We verily believe the hand of the Lord is with Japan in this struggle, and if that is so their cause will triumph.

It is not often that such religious awakenings are witnessed as were manifest in Greenville Sunday. Besides the services at the usual morning hours in the churches, there was a gathering of nearly four hundred men in the Masonic temple opera house in the afternoon to hear a sermon by Dr. William Black. Men were present who had not attended a religious service in years and the scene was one that stirred all hearts. All were deeply moved at the earnestness of the speaker and when an invitation was given hundreds of hands were raised to express sorrow for lives that had been led at the night service in the Presbyterian church the evidence of changed lives was even more pronounced, a large number declaring that by God's help they will cease doing wrong and live for Jesus. Verily, Greenville seems to be coming to herself, and for this great awakening there is cause for thankfulness and praise.

The Effects Of Opium.

Whatever may be said of tobacco and alcohol, there is little to be said in favor of opium. Its use leads not merely to physical, but mortal degradation, it establishes a tyranny of habit over its victim that is stronger and more cruel than that of liquor; it ruins intellect, blights the future and shortens life.

And yet we meet people, day after day, who are fast becoming victims of this deadly drug. You can see it in the glare of their eyes. Brother man, sister woman, for Heaven's sake stop before it is too late, and you are ruined.—Durham Sun.

Again Vindicated.

Grover Cleveland has lived to see another of his public acts approved. His recommendation that captured Confederate flags be returned to the South has at last been carried out. It is only a matter of time until everything he ever did will be approved. The old man has been traveling some yards ahead all the time.—Carthage Blade.

Government Has Broken Down In Santo Domingo.

The essential fact before us is, that the United States has at length been brought face to face in Santo Domingo with a situation which calls for definite and special action, and which cannot be evaded. The simple truth is that government has broken down in Santo Domingo. In spite of the unsurpassed riches of its forests, fields and mines, the country has gradually descended from stage to stage of fratricidal contests and political and social disorders, till it has apparently become incapable of unassisted self-regeneration. With revenues which, if they are properly collected and administered, would be ample for all legitimate purposes, the government is obliged daily to borrow at ruinous rates the money required for its ordinary expenses, and the only creditor who is repaid is the daily lender. To the payment of principal and interest of the general debt, domestic and foreign, nothing is devoted.—From "Santo Domingo and the United States," by John Bassett Moore, in the American Monthly Review of Reviews for March.

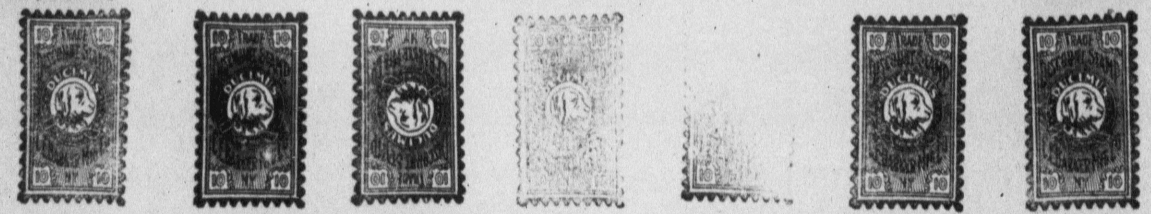
