#### Mrs. Chadwick Guilty.

Cleveland, O., March 11.—Mrs. Chadwick was at 8:30 tonight found guilty of conspiring to wreck a national bank, the jury convicting her on seven counts left in the indictment. She will soon become an inmate of the Ohio penitentiary. There she served years ago for forgery under the name of Madame Devere.

#### B. Y. P. U. Organized.

A Baptist Young People's Union was organized Sunday afternoon at the Memorial Baptist church with C. E. Lincoln president and Miss Pattie Colfield secretary. A committee was appointed to nominate the other officers at next meeting. The union begins with a large membership.

### Republicans Made a Trade With the Republicans Which Compelled Them to Seat Smoot.

Ex-Senator Frank C. Cannon, of Utah, has been expelled from the Mormon church because, in the course of his duty as editor of the Salt Lake Tribune, he has seen fit to criticize certain men high in Mormon councils, particularly the whitewashed Reed Smoot. Here we have another example of what is the real object of the Mormon organization. It shows it to be again what it has shown itself to be before and since the admission of Utah as a State of the Union—an irresponsible and tyrannical political machine that puts its own interests above the interests of Utah and the country, and pays not the slightest attention either to the terms upon which Utah was admitted to the Union or to the Federal Constitution and statutes.

A worse day's work was never done for the country than the senate perpetrated when it refused to see this patent fact and seated Smoot as a member of the upper branch of congress. That action was taken upon a mere technicality, and despite the abundant proof that Smoot was a representative of this outlaw organization masquerading as a national shame that the Mormon conspiracy, as represented by Smoot, was not promptly and sufficiently throttled.—Norfolk Virginian-Pilot.

#### Twixt Devil and Deep Sea.

Tokio, March 11.—The Japanese wedge driven through the Russian center on the Hun River continues to advance north. It has already arrived at Hampu, some distance northeast of Mukden.

It is reported that the Russians are retiring north along the railway, evidently very badly confused, being caught between the wedge and the extreme Japanese left, northwest of Mukden.

They have been heavily punished during their retreat along the described route, the Japanese shelling the disordered masses of the Russians.

Minister of war Teracutchi has telegraphed his congratulations to Field Marshal Oyama; the officers and men of his army on their victory.

Field Marshal Oyama in reply ascribes his success to the Emperor and the gallantry and bravery of his officers and men.

#### "Of Peace Not a Word."

Washington, March 11.—"After Laoyang there was talk of peace," Russia's answer was reinforcements. Like Liaoyang, Mukden is the scene of another retreat, and again Russia's answer will be large reinforcements. But of peace not a word."

This was the emphatic statement of Count Cassini, the Russian ambassador, today. The only official news he has received in the last few days from his government regarding the operations is contained in a brief cable message that came last night, saying that General Kuropatkin was retreating after days of fierce fighting.

St. Petersburg, March 11.—The foreign office has issued a denial of the statement that Russia has intimated to France that she is willing to negotiate for peace.

The next annual meeting of the North Carolina Press Association has been called for July 5th and 6th, at Kenilworth Inn, Asheville.

A bill intended to be local and make hunting except between Nov. 20th and Jan. 20th unlawful in one township in Anson county, passed in such a manner as to make it apply to the whole state.

City Ownership Wise.

Raleigh is agitating the question of city ownership of waterworks. We thought the question had been pretty well settled that it is best for a city to own such public utilities as street lighting and water supply. Our observation is that the majority of cities do own them and that they are conducted with much success. We know that Greensboro's experience has been satisfactory in this respect. Some years ago the city purchased from the water company here its entire plant and it has been a source of profit ever since. By all means own your water supply. If a corporation can make a profit out of it the city can also and save that much to the tax-payers.—Greensboro Telegram.

Would it not be a good idea for the various historical organizations of the State to get together in the effort to bring out a good history of North Carolina. This is something that has been needed for a long while and there should be enough interest in such a work to justify its being carried to completion, at an early date. It would be a good thing if an edition suitable for use in schools could be provided.—Winston Sentinel.

An Interesting Relic.

Lieutenant Governor Frances D. Winston has presented to the Hall of History a very interesting relic of the Civil War, this being the coat of his uncle, Lieutenant Colonel Francis W. Byrd, of the Eleventh North Carolina troops, who was a lieutenant in Company F, the color company of the First North Carolina volunteers, known as the Bethel regiment at the battle of Bethel. His old company went in at Gettysburg with eighty-seven men and came out with one officer and two men. His life was twice saved from bullet wounds, once by a silver watch of the heaviest kind and at another time by prayer book given him by his mother. A bullet smashed the watch and the other bullet penetrated half way through the prayer book. He was killed at the battle of Reams station.—Raleigh News and Observer.

Whether our weather bureau, when it gets on to this, will employ onions as assistants remains to be seen, but they can hardly make worse guesses than many of those promulgated as "indications."—Durham Sun.

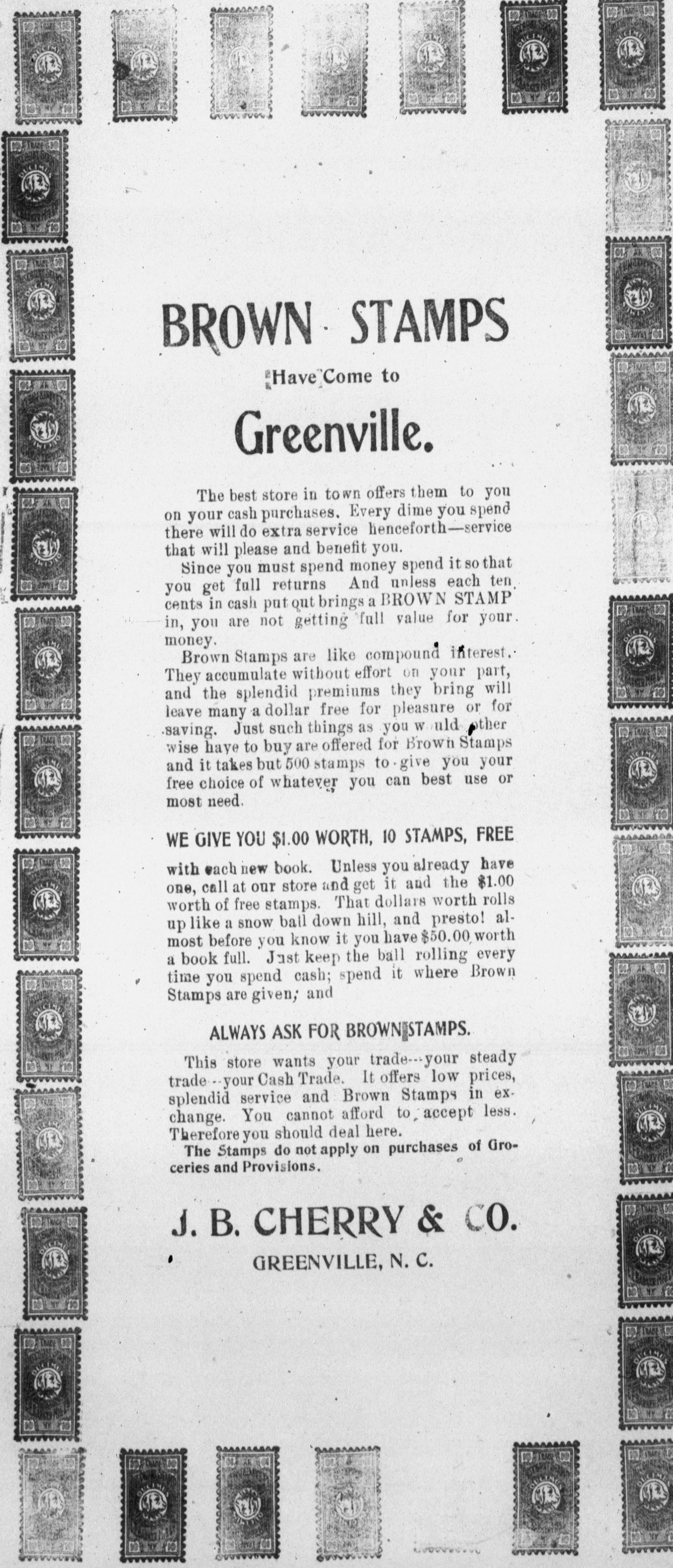
