FOUR DEATHS.

Work of The Grim Reaper.

Arthur Kennedy, aged 10 years, oldest son of Mr. and Mrs. A. F. Kennedy, died at 10 o'clock Saturday night after an illness of about two weeks with dysentery. He was their first born, and his death casts a dark shadow upon the home. Arthur was a bright, industrious boy. For sometime previous to his sickness he served as one of the carriers for THE REFLECTOR and always performed his duties faithfully and promptly.

The interment took place at 4 o'clock Sunday afternoon in Cherry Hill cemetery and was attended by a large number of sorrowing friends. Services were held at the home and grave, conducted by Rev. A. Cecil, the little 2-year-old son of Mr. and Mrs. B. R. Whitehurst, died Saturday of meningitis at their home in South Greenville. The remains were taken by train Sunday morning to Whichard, and the interment took place that afternoon in the Whitehurst burial ground, in Carolina township.

Mr. Japhet Tyson, aged about 81 years, died at 3 o'clock Saturday morning at his home four miles from town. He is survived by a wife and five grandchildren. He had two daughters but both of them are dead. One of his grandsons is Mr. J. F. Smith, of Greenville. The funeral took place Sunday afternoon.

Mr. Hazzard Kittrell, a prominent farmer of Farmville township, died Sunday afternoon of consumption. He had been in poor health for sometime, and taking a sudden change a few days before his death the end soon came. He was about 54 years old and leaves a wife and several children.

MAKE READY FOR THE TEACHERS.

Let The People do Their Part Well.

Mayor Wooten and the aldermen are doing their part toward getting the teachers of the county to hold their institute here the coming summer. But if the institute is to be secured for Greenville and made a creditable success there is something the citizens must do towards it. The most important thing is to open their doors and provide the teachers a place to board at a reasonable rate. The price agreed upon by the aldermen is \$10 for the four weeks and it is desired to find places for the teachers at this rate. The committee of aldermen and those appointed by them will make a canvas of the town this week to find places for the teachers to board and the citizens should help the work along with cheerful and prompt responses.

In the meantime let every citizen of the town make himself a committee of one to help along the work. And if you can board any of the teachers report to the fact to Mayor Wooten without waiting for the committee to call on you. Let everybody take an interest in this matter.

REPORT OF METHODIST SUNDAY SCHOOL.

Excellent Showing for the Past Quarter.

The report of the secretary of the Methodist Sunday school for the quarter ending March 26th, 1905, makes the following showing:

Additions to membership during quarter—officers and teachers 3, scholars 46, cradle roll 9, total 58. Membership at close of the quarter—officers and teachers 29, scholars 202, cradle roll 46, total 277.

Collections during quarter—orphans \$15, Sunday school supplies \$25.60, missions \$28.78, total \$69.38.

Attendance excellent. C. M. Jones' class won a star for every Sunday during the quarter. Two other classes missed only one Sunday and several others only two Sundays. No single class has been able to win the monthly attendance banner during the quarter, as several classes showed a monthly attendance of 100 percent.

Out of 53 additions to the church during the quarter, 33 have come from the Sunday school, showing more than half the growth of the church coming from that source.

THE CHRISTIAN CHURCH.

Will Soon Put in Electric Lights

The work of the Christian church is progressing finely in all of its departments and preparations are being made for still further improvements.

Plans are now in hand for a big revival meeting sometime next month, the only thing yet to be arranged will be the date for the meeting which has to conform to the schedule of the evangelist.

Electric lights will be placed in the church just as soon as the electrician can install them. The Ladies Aid society deserve credit for their foresight in raising funds for his purpose in advance. They have the amount in hand to pay over as soon as the work is completed.

The fixtures selected will no doubt give abundant light as well as ornament the interior of the church.

There will be one chandelier carrying nineteen lights three clusters with six lights each, two vestibule lights, one at the desk and two auxiliary to use when the choir platform is in use.

The desk lamp will be so arranged as to shade the light from the congregation, thus doing away with the annoyance of looking at a light near the preacher.

Barring the choir stand lights, which will only be used on special occasions, the vision will not be obstructed by the glare of a single light, all fixtures being well overhead. In the choir stand frosted globes will be used to soften the glare of all the lights there. There will be forty sixteen candle lamps making a total of six hundred and forty candle power, well distributed.

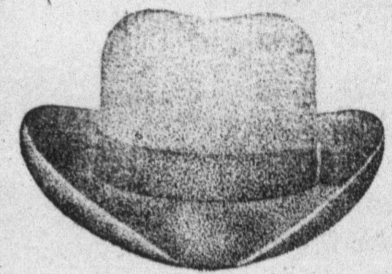

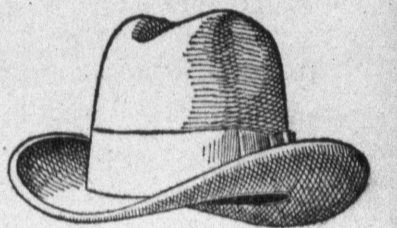

Between blind tigers, moonshine stills and moonshine railroads matters are kept quite lively at Durham.

Trying to take its Durham troubles into the Federal courts is following the old tricks with the Southern railway.

More peace talk is coming out of Russian quarters. It is late taking shape, but not too late to save the remnant of the czar's army.

The whole city of Durham is about to be declared in contempt of court for its action against the Southern railway. If all of them are going to be put in jail a fence might be built around the town and save expense in enlarging prisons.

Ten dollars per head is the price of admission of membership in the Tar Heel club, Spencer Blackburn's Republican organization at Greensboro. The faithful are coming down with the price, as the line of promotion to a government job runs through the club roll.

New York gamblers are endeavoring to work a slick ruse. Being debarred by the laws from carrying on their operations within the city they chartered a steamer to take them three miles out to sea, beyond the legal limits, where it was proposed to receive racing news by wireless telegraph. At last accounts the boat chartered for this floating pool room had not sailed.

Some Virginia camps of Confederate veterans have taken exception to the inscription for the monument to be erected by North Carolina at Appomattox, because it does credit to North Carolina, and have decided not to attend the unveiling. That is all right, let them stay at home if they want to. The Tar Heels may show that they are able to pull off the event without them.

Reward for Criminals.

Governor Glenn has written this letter to every solicitor:

"So many requests for rewards are being made, some of which do not seem to be in perfect good faith, that I deem it best to make a rule that no request for rewards will be granted until it receives the endorsement of a solicitor of the district. I therefore urge you, before endorsing any application for reward, to look carefully into the case and see whether in your judgment a proclamation should be issued.

"Sheriffs, deputies and constables should be able to apprehend any criminal in their own county, and should see to it that if the person is a fugitive in another county, a capias be issued to that county, and the arrest be made. Also if they can locate the fugitive in another state, they should ask the authorities of that state to apprehend and hold the criminal until I can make requisition. It is getting too common for them to take things quietly and ask for rewards, when by diligent search and inquiry, this cost to the state might be avoided.

"Having confidence as an officer of the state, I will be governed largely by your recommendation."

Republican Forehandedness.

A campaign for a nomination has never opened so early in this country as has that for the Republican nomination for the presidency in 1908. President Roosevelt having taken himself with emphasis out of the calculation, the friends of other national leaders are not slow in bringing them forward. It is not too much to say that Vice President Fairbanks is undisputedly a candidate, and undoubtedly one of the prime objects of the Greensboro banquet Wednesday night was to advance his fortunes. The well-informed Washington correspondent of The New York Evening Post is of the opinion that at this time the Vice President has the call of the board. After Mr. Fairbanks, the willingness of Secretary Shaw, of the Treasury, is perhaps most apparent. Secretaries Taft and Cortelyou are well understood to be in receptive mood, and it is thought that Speaker Cannon does not believe that he will be too old four years from now. There are and will be others, of course. It is too far in advance to make speculation worth while, but one cannot but be impressed by the fact that at the time of President Roosevelt's inauguration for a term of four years a campaign for the succession was in full swing, and by the other fact that the Republicans are conducting it as if there were no opposition to be reckoned with. Parties have entered upon campaigns before now under this delusion, and experienced an awakening.—Charlotte Observer.

TRIALS OF A COMPOSER.

How Leoncavallo Got a Hearing For His Opera "Pagliacci."

"How little those who go to a successful opera and see the smiling composer think of the mental, if not physical, suffering through which he has very likely gone before arriving at fame. For instance, Leoncavallo and the "Pagliacci" are taken as a matter of course, but the recognition of the opera was obtained only when despair was knocking at the door of the composer.

Several years ago Signora Lison Frandin had just made her first successes as a singer when one day a friend came to beg her good offices with the great Sonzogno, who is such a power in the musical world, for an unknown genius, whose opera, the "Pagliacci," was driving him mad because he could not get it accepted. The friend drew a touching picture of the young man, who had sent his opera to Ricordi, Sonzogno's great rival, who had pigeon-holed it and had forgotten it, while the young composer was eating out his heart.

Mme. Frandin required a great deal of persuasion, as Sonzogno was "difficult" and had just declared that he would not even hear any more new operas. However, she in the end gave way, was herself won over on hearing the music and spent a couple of fatiguing hours in arguing with Sonzogno. To get rid of her he consented to hear the score. The young composer came with a timid, almost supplicating, air before the terrible and taciturn one and was received with a coldness almost glacial.

Leoncavallo at once seated himself at the piano, while Sonzogno walked the floor, and those present waited anxiously for a sign of interest, which they knew would be a pause in the dreadful promenade. The first act was passed, and still the tramp, tramp went on, the composer scarcely being able to strike the notes. In the second act the longed for pause came, the promenade was over, never to be resumed where Leoncavallo is concerned. Thus the "Pagliacci" was born, and the composer took his first step toward "Roland" and Berlin.—Pall Mall Gazette.

Bank Runs.

A good many years ago in London an old woman fell in front of a bank and broke her leg. A crowd collected, and the report got about that there was a run on the bank. In a very brief space there really was one. A disastrous run on the Bank of England in the time of the pretender in the eighteenth century was prevented by an ingenious delay. When Prince Charles was marching on London depositors were in a frantic hurry to draw out all they had in the Bank of England. Every call was met, but in sixpences and shillings. So long did these coins take to count and so prodigious were the loads of bullion which had to be carried that public confidence was restored and, news of the retreat of the highlanders coming to town, the situation was saved.

Mayonnaise.

Many persons have difficulty in making a good mayonnaise, but there ought to be no reason for it if you know your oil is good before you start. Mix the yolk of a fresh egg with a little salt and dry mustard and stir continually with a fork while you add the oil, which at first should be only drop by drop. The best way is to cut a notch in the side of the cork of the bottle and let the oil flow through. This prevents the oil from coming faster than you want it. After a bit add a few drops of vinegar, and it will expedite matters in bringing the salad to the desired smoothness and consistency. After this you can add oil almost ad libitum without danger of its separating. It is needless to add that during this process the dressing must be continually stirred.
