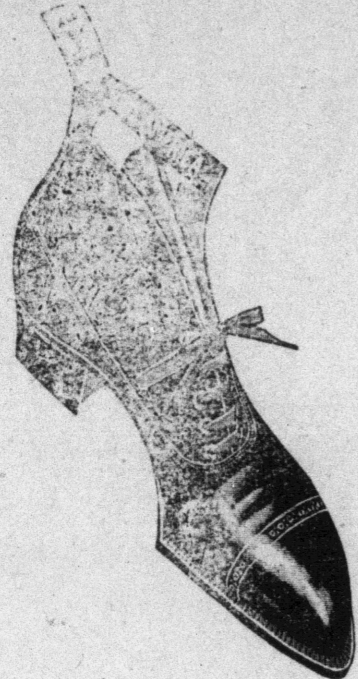

MIDNIGHT FIRE AT HIGH POINT.

Several People Escape From the Flames With Difficulty.

High Point, N. C., May 25.—Fire broke out in the third story of the J. J. Cox building this morning at 1:25 o'clock. In this building was located C. M. Case & Co., china ware dealers, and the second and third stories were occupied by families. There were narrow escapes of life so quickly did the fire spread, owing to terrific explosions caused by inflammable matter. The fire was in the heart of the city, and in one of the most substantial buildings, but at this hour, one o'clock, the fire is practically under the control of the firemen. The loss is quite heavy from fire and water.

Colored Lad Killed by a Train at Sanford.

Sanford, May 25.—This morning about 7 o'clock the 11-year-old boy of Moses Alston, colored attempted to cross the railroad by crawling underneath some freight cars on a siding near the Sanford Sash & Blind Company's plant, when a Southern railway engine moved the cars a few feet. One wheel passed over the lower part of the boy's neck and one arm, but neither head nor arm were severed from the body. No one, it seems, knew of the accident until a short while after, when the boy was found beneath the trucks of the car, his limbs in a position as if in the act of crawling when his life was suddenly ended.

Mr. Willis P. Collins Dead.

Morehead City, May 25. Mr. Willis P. Collins, proprietor of the Atlantic Hotel, died here this morning about 4 o'clock of Bright's disease. Mr. Collins had retired at his usual hour feeling much better than he had for the past few days. He was about 62 years old, was born in Albany, N. Y., and was a prominent member of the following orders: Masons, Knights of Pythias, Knights of Honor, Red Men and Royal Arcanum. He has been living in Asheville for the past five years. His brother and son will arrive tomorrow. His remains will be sent to New York for interment.

Sues For Breach of Promise.

New York, May 25.—Damages aggregating a quarter of a million dollars as compensation for alleged breach of promise of marriage are asked by Mrs. Catharine Pollion in a suit against W. Gould Brokaw, the millionaire club man, which was begun in the Supreme court here today. Eminent counsel, scores of witnesses, many of them people of prominence from distant parts of the country, and a packet containing more than 20 letters alleged by the plaintiff to have been written by Brokaw, will figure in the case. The authenticity of the letters, upon which the suit is largely based, is denied by Brokaw's counsel.

That the case has attracted unusual attention was apparent from the appearance of the court room at the opening session of the trial. Not a seat was vacant and among the spectators were many obviously not accustomed to court room scenes.

Former Governor Black and former Judge Elliott appeared for the plaintiff in the suit, while Mr. Brokaw's counsel was former Assistant District Attorney McIntyre. Both the plaintiff and the defendant were in court, Mrs. Pollion accompanied by her sister and Mr. Brokaw by four friends who arrived with him in a big touring automobile.

"My Dear Wife to be:"
Mrs. Pollion came here from Troy, N. Y., a few years ago after being divorced from her first husband, Joseph P. Smith, to whom she was married in 1897, while she was still a student in a seminary.

Exceptional care was exercised by the attorneys in examining talesmen regarding their qualifications to serve on the jury. When the court adjourned until tomorrow, only the juror had been selected.

To Meet in October.

Washington, May 25.—After adopting resolutions on subjects of vital interest to the South, the Southern Industrial Parliament adjourned today to meet in some Southern city at a date in October to be designated later by Governor Glenn, of North Carolina, chair man of the executive committee.

GRAND TRIBUTE TO AYCOCK.

Dr. J. B. Carlyle, of the Wake Forest faculty in closing his able address at the Goldsboro commencement exercises paid a grand and deserved tribute to our ex-Governor, Chas. B. Aycock. He said in part:

"Some months ago, entering Raleigh on a belated train, I paused in the Capital Square before the statue of the immortal Vance, just as the first faint rays of the rising sun rested on his massive brow. With his imperious gesture, the great tribune of the people seemed to be welcoming the coming of a new day. Under the spell of that mighty presence I looked into the future fifty years, when my children, children now, grown to hoary years then, shall stand at the South entrance of that same capital square, when this good State shall be the home of more than five millions of happy, contented, intelligent, prosperous and patriotic people, when knowledge shall cover the State as the waters cover the sea, when the rights of all shall be the regard of all and the weal of all shall be the will of all, my children standing then there at the South entrance shall see another statue facing, not the faint rays of a sunrise to come, but the richer radiance of a noon-day splendor of fruition, built of Carolina marble, fashioned by Carolina skill, born of Carolina loyalty and gratitude, bearing on its broad base the words: 'Charles Brantley Aycock, the great educational governor.'"

TURN ON THE LIGHT.

The United States senate is in session investigating the question of railroad rates and discriminations. Many of the witnesses appearing before the investigating committee to give evidence in behalf of the railroads are charged of riding on free passes. A Premium on Crime.

Arrested for Theft.

Durham, N. C., May 25.—For several weeks there have been reported several robberies from East Durham, and today the matter was brought to a head by the arrest of William Barbee, a prominent and well to do young white man, and Robert Evans, also white, charged with robbing the store of L. J. Kirkland and the store of Mathes-Kirkland Company. They were both sent up to the grand jury, Justice of the peace D. C. Gunter and J. T. Morton hearing the case, which came to an end this afternoon at 2:30 o'clock. They both gave bond.

When Evans was arrested this morning he confessed to the entire transaction and said that implicated with him was William Barbee and Richard Thompson, the last named being now a fugitive from justice. Evans said that in these robberies he was left on guard duty and that Barbee and Thompson did the robbing. After getting the goods from the store he assisted in moving them away.

Barbee denied the entire charge and made an effort to establish an alibi, but this was only partially done. After hearing all of the evidence the two men were sent up to the higher court and an effort is being made to locate Thompson, who skipped when he found that the robberies had been discovered. It is claimed that first and last fully one hundred and fifty dollars worth of goods have been stolen from the stores.

Opened an Artery.

Lenoir, N. C., May 25.—L. D. Whittemore, a traveling lock inspector of Stamford, Conn., committed suicide at the Commercial Hotel last night.

After an unsuccessful attempt from eating mercury from the back of a mirror, strangulation with a towel was attempted. Failing in this, an artery at the wrist was opened and death ensued from bleeding.

It was a coldly calculated affair. The condition of the room showed a severe struggle.

No motive is known for the deed. Whittemore had inspected locks at the local banks and seemed in good spirits. His firm has been informed. The body will be sent to Connecticut tomorrow.

T. P. Wilcox Under Bond.

Elizabeth City, N. C., May 24.—Following indictments and a trial on the charge of selling intoxicating liquor without license, former sheriff Thomas P. Wilcox, is now under \$200 bond and Martin Hinton, a negro, is confined in jail awaiting the September term of the Superior court.

The ex-sheriff is the father of Jim Wilcox, who is doing service in the penitentiary for the murder of Miss Nellie Cropsey.

Mexican War Veterans Meet Next in Washington.

Dallas, Tex., May 24.—The thirty-second annual reunion of the National Association of veterans of the Mexican war was held here today. While the attendance from outside the state was limited, it was regarded as very representative.

Washington, D. C., was chosen as the next place of meeting and the time was set for May 8 and 9, 1906.
