#### E. F. Young Arrested for Forgery.

E. F. Young, who, at one time was the most prominent business man of Harnett county, supposed to be worth a great deal of money, was arrested in Dunn yesterday, upon a warrant issued by E. Lee, a justice of the peace, upon the oaths of three of the town commissioners, charging forgery of the town's treasury account on the books of the Merchants and Farmers bank, of Dunn, of which he was formerly president.

The case was removed to Justice J. R. Godwin, and upon a plea for a continuance by counsel for the defendant, a justified bond in the sum of \$3,800 was required for the appearance of the defendant next Monday, when the case will be heard. —Fayetteville Observer, 2nd.

#### TWO TOBACCO KINGS.

##### North Carolina Has the Two Biggest in the World.

"I live in a town which is the greatest seat of the plug tobacco industry in the world, the town of Winston-Salem, N. C.," said Hon. J. C. Buxton, one of the most prominent lawyers of the Old North State, at the Raleigh.

"Last year, as the records will show, there was a production of 22,000,000 pounds of plug tobacco in the factories of Winston-Salem. Doesn't look as if that much plug could be chewed up in a decade, eh? But somebody must get away with it, for the output is constantly increasing. Winston and Salem are two separate and independent municipalities, and yet are practically but one town. Salem is by long odds the older, as it was founded by Moravians from Pennsylvania in 1753, while its partner is a giddy, young thing, whose record goes back only half a century. These Moravians were a fine race of people, thrifty, pious and orderly, and the same good traits are exemplified in their descendants.

"The most striking personality in our community is that of R. J. Reynolds, the tobacco magnet and head of a company which has 400 traveling salesmen and 6,000 people in its employ. Mr. Reynolds came to Winston-Salem about thirty years ago from Patrick county, Virginia. He had a little capital, and embarked in the manufacture of tobacco in a very modest way. Today he is several times a millionaire, and so strongly entrenched that the tobacco trust, instead of absorbing his business, as it tried, had to be content with taking stock in his company.

North Carolina can boast of the two greatest tobacco kings of the world—R. J. Reynolds and J. B. Duke." —Washington Post

#### Fire at Scotland Neck

Scotland Neck, N. C., Aug. 2.—The second big fire this year occurred here last night entailing a loss of \$10,000 with only \$1,400 insurance. Soon after midnight the alarm was sounded and quickly the people of the town were aroused to find that a destructive fire was raging near Main street in the business part of the town.

The fire started in a small out-building in the rear of the store of S. J. Stern and J. R. Askers. For half a block south from the corner of 12th and Main streets the buildings were entirely wood, and it was at once evident that they must all go. About half way the block is the brick store of Edwards & Co. and the only hope of checking the flames entered in that building. With anything like a strong wind from the east or southeast, the entire block would probably have been destroyed, including some handsome residences facing Church street, west of Main.

In an hour after the alarm was given the destruction of four grocery stores a sewing machine shop, shoe shop, barber shop, and cafe was complete, all being burned to Edwards & Co's store which staid the flames. —Raleigh News and Observer.

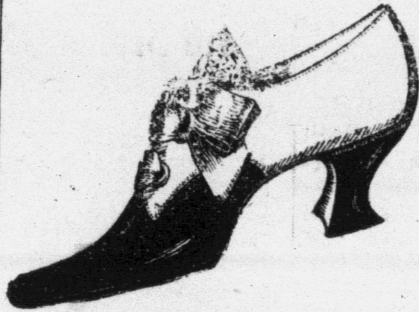

**TALL, THIN AND MUSCULAR.**

The American Type of Man Clearly Distinct From All Others.

There is as distinctive a type of American manhood as there is of any other country. True, the American people are a mixture. We combine several different races and bloods. But the intermixture has gone on so gradually, the original American type always prevalent, that the American man is a distinct representative of civilization, differing from the Englishman, the Frenchman and the German as much as these differ from each other.

Examination of the portraits of Revolutionary times and those of the present date show little if any difference between the men of the earlier times and those of the present day, save in the matter of attire. Dress the people of the present day as were the people of the Revolutionary epoch apparelled, and nothing could be found to establish a notable difference between the American of today and the American of the last quarter of the eighteenth century. Food, climatic conditions and occupations have all much to do with the physical peculiarities of a people. The races that have for centuries received no admixture of foreign blood retain peculiarities that seem unchangeable.

What people eat and drink, their dwelling places, the soil and climate they inhabit, their worship, amusements and work all determine looks. The American Indian when first met on this continent by adventurous Europeans lived almost exclusively on a meat and flesh diet, the product of chase and other adventure. He was tall, thin, muscular and daring. His eye was bright, his hearing acute. He looked the fearless being that he really was. He had to fight wild beasts and savage man. He feared neither. The early white settlers, obliged by the peculiar conditions of pioneer times to live in a measure like the Indians, became also tall, thin, muscular, daring. Their eyes flashed with the fearlessness that characterizes the American race of the present.

We have a more generous and varied diet than our ancestors. Diet affects personal appearance in a marked degree. We are becoming a larger and heavier race, but the distinctive features of a century or more ago are still in evidence. The American is easily recognized everywhere he goes in foreign lands. He will for a long time present the same type that today distinguishes him from men of all other races. - Louisville Herald.

"The coquette," according to one authority, "uses man as she does her dresses - she likes to be seen with a new one every day. She kills for the sake of killing. 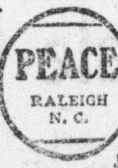
