## ALMOST A FIRE.

### Residence Has Narrow Escape.

A morning or two ago Mrs. J. D. Dupree, in South Greenville, while about her house work detected a strong odor of smoke as if something was burning. She began a search and in a closet of the sleeping room, on second floor, found a smothered fire among some clothing. She put the fire out before any damage was done except to the clothing. It is thought the fire was caused by one of the children throwing a pasteboard box in the closet that had been about the stove.

It is fortunate that Mrs. Dupree discovered the fire so soon, for a little later her home might have been in flames.

### Stock Food Swindle.

The Progressive Farmer sounds a note of warning to the farmers of the state about what it calls the stock food swindle. It says that one of the most outrageous frauds now being perpetrated upon the American farmer is that of prepared stock foods—common, meal bran, etc., with a little cheap sulphur, salt, Epsom salts, pepper, saltpeter, etc., added to change the taste, and the mixture (hardly more valuable than ordinary ship stuff) put up in flaming packages, advertised in big illustrated ads in farm papers, and sold to gullible farmers at from \$250 to \$2,250 a ton.

The Progressive Farmer says further that some time ago, the chief southern contributor in one of the farm papers most largely circulated in North Carolina and the adjoining States, wrote an exposure of the whole miserable fraud and sent it to his paper. The reply came back: "The Blank Stock Food Company pays us \$3,000 a year for advertising, and we should lose it if we were to print your letter. Please don't insist." It is quite proper that while the patent medicine nostrums are getting a drubbing, the stock food humbugs should be exposed, and this The Progressive Farmer proposes to do. If the frauds are of the nature complained of, we hope the exposure will be of a nature as to protect the farmers against them.—Charlotte Chronicle.

### Worth Remembering.

A gentleman whose little daughter was painfully burned and the injury quickly cured by the application of a simple home remedy, dropped in to tell us about it with the thought that it might be of interest to others and helpful in case of a similar accident. He says that lime and linseed oil were mixed to the consistency of paste and quickly applied to the burn, and in a short while it removed the inflammation and caused the injury to cure rapidly.

### A Fish With Lungs.

There is one rare fish which can boast of a pair of lungs in addition to the gills with which alone less favored fish are endowed. The necessity of these two sets of breathing apparatus is readily seen when the habits of the animal are known. In Africa, where the fish lives, it inhabits lakes and ponds, which are often completely dried up during the dry season. As long as the water remains the lung fish lives as do the other members of the finny tribe and breathes by means of his gills, but when the ponds dry up he burrows down into the mud and makes a round nest, where he lives in a semi torpid condition, breathing by means of his lungs until the rainy season releases him again.

### The Art of Resting.

Many are the suggestions offered as to resting, for, strange as it may seem, few people understand the art of resting properly. Thorough rest does not necessarily mean lying down or sitting. It means to relax the entire system, the mind and body. For a tired brain physical exercise is the best remedy rather than a resort to drugs. If a brisk walk in the fresh air can be taken, so much the better. A very good remedy for a weary brain is to rise slowly on the toes (lifting the heels from the floor) until the muscles at the calf of the leg ache and then to kick vigorously a few times. Repeat this simple exercise several times and excellent results will follow.

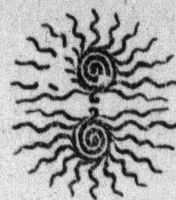

The price of cotton continues to be a puzzle.

Some people may be surprised that Tom Dixon's "Clansman" was so favorably received in New York, notwithstanding they expected the contrary.

Greensboro comes in for its share of publicity in everything that is going. The couple who recently committed suicide in Raleigh drank laudanum out of a bottle bearing the name of a Greensboro druggist. You just can't hide a hustling town.

When Greenville folks get a chance to pay for a house with the money now paid for rents, as we hope they will some day through a well managed building and loan association, you will see more of them becoming home owners with a deeper interest in the welfare of the town.

It looks like the President has some pets on the Panama Canal Commission that he wants provided for at the expense of the government. When by reason of a resolution of inquiry introduced by Senator Simmons, the office of "press agent," held by a fellow named Bishop, at a \$10,000 salary, was abolished, the President straightway appointed him to another job.

### Good in the World.

One of the magazines has taken a new tack which ought to be a winner. So many of the leading magazines, so many of the important newspapers, so many investigating committees, so many prosecuting officers have turned so much evil in public and financial life in this country in the last few years that we are beginning to think there is nothing but evil in the world, or at least that good is the rare exception.

We have talked about graft and grafting, political and private plunderers, frenzied financiers, insurance looters, bank wreckers and the like until we have got into the habit of thinking that all things and all men are bad and wicked, and that only evil is done. But after all, if we calmly think it over, we will come to a realization that the good is the very foundation and essence of our public and private existence; that unless this were so the nation and the people must perish. Only the evil is aggressive always; the good is unusually passive. Some reflection along this line has led the publishers of this magazine to undertake a series of articles on the white side of life, to show the forces for good in our good in our country and what they are accomplishing, quietly, steadily, surely.—Buffalo Express.

### Unbusinesslike Farming.

The layman can hardly realize the lack of system that prevails on the average farm. Drainage is little thought of on the lowlands, crops are rotated only as chance determines, and probably not one farmer in a hundred can tell what enterprise on his farm and under his conditions is the most profitable. In no other business it is likely that men can be found with \$10,000, \$20,000 or \$50,000 investments who never pretend to keep books of the business. Farmers' books are too often kept in this manner,—gain, money in the bank; loss, money borrowed. The writer once argued this question of keeping books with a well-to-do American farmer, who finally concluded his argument by saying, "Farming ain't all keeping books, by a long shot." Truth lies in the argument, but keeping books is not all there is to manufacturing furniture or transporting freight, and yet it must be a valuable accessory or it would have been discarded years ago.

There are still thousands of farmers in the middle West who do not follow the markets, who rarely, if ever stop to consider the relation between prices of feeds and prices of beef and pork. Hogs are fed because "there is money in hogs," and many an operation on the farm is done according to some preconceived notion. The writer knows a German farmer in western Minnesota who has a beautiful, clean farm, and is evidently prosperous. While watching him feed his hogs one day, this conversation took place: "How old are those pigs?" "Sixteen months." "Why don't you sell them?" "Well, I don't like to sell a hog until he weighs up good and heavy." Further conversation revealed the facts that corn was worth forty-two cents per bushel and pork four dollars per hundred weight, live weight. When asked if the pigs he was feeding were gaining enough to equal or exceed the value of the corn, and pay him for his labor, he realized that each bushel of corn had got to produce about twelve pounds of pork to yield him any profit. Knowing that his pigs were not gaining the half of that amount, he decided to sell both pigs and corn.—From "Farming as a Business Enterprise," by Edward C. Parker, in the American Monthly Review of Reviews for January.

### Heroes.

When a soldier is shot down on the field of battle, when a police officer is murdered in the discharge of his duty, there are words of praise and resolutions and monuments, and rightly so, but when a railway engineer is done to death while protecting those on his train, there are passing words of sympathy and regret, and soon he is forgotten. He takes his life in his hand day and night. He is not serving the government, but he is serving the people and he belongs to a brave and faithful set. It invariably happens that when there is a disaster on the rail he is the first among the victims and hundreds and hundreds of cases have been found where he could have deserted his post and saved himself, yet when that meant the slaughter of others whose lives were in his keeping he stuck like a soldier and was sacrificed. He may lack the polish of a professional man or the dandy. He may be rough in manner and speech and other men may pass him by without a word or nod, but under his shirt there is a heart. He does not expect reward for his bravery, and expecting none he is not disappointed.—Raleigh Times.

### It Means Much.

From the published report of the moneys in the hands of the clerk of the Superior Court of Wake county, the reader will note that every dollar of trust funds is deposited in a savings bank and is drawing interest. Mr. W. M. Russ, the efficient and careful clerk, takes deep interest in the trust fund in his hands, and not only watches it as carefully as a hen does her young chickens, but is certain to see that the fund grows every year by being promptly deposited in a savings bank.

What Clerk of the Court Russ does in this respect in Wake should be, not a matter of official discretion, but a requirement by statute, so that in every county the trust funds should steadily increase. Most of these funds belong to those to whom a dollar means much and the semi-annual accretions of interest add considerably and steadily to the fund.—Raleigh News and Observer.



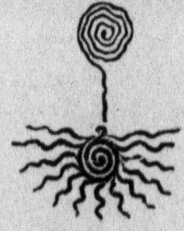

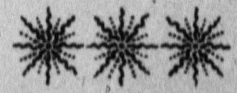
