SUPERIOR COURT.

Beginning of January Term.

The January Term of Pitt Superior Court convened this morning with Judge B. F. Long, of Statesville, presiding and Solicitor L. I. Moore representing the State.

In the call of the jurors for the term every man summoned answered to his name and while some excuses were asked for they were only for business reasons and were not granted.

The grand jury is composed of the following: C. D. Rountree, foreman, A. G. Cox, H. E. Ellis, J. W. Brooks, W. E. Hooker, J. J. Buck, J. E. Mumford, Peter Fleming, J. S. Tunstall, C. B. Hardy, C. H. Langston, J. T. Hart, J. H. Edwards, J. F. Harrington, Mc G. Vainwright, R. W. Smith, J. B. Nelson, W. E. Proctor.

W. H. Smith is officer of the grand jury and L. W. Lawrence court crier.

In his charge to the grand jury Judge Long occupied about an hour and a half. It was different from most charges heard in the court, not dealing so much with the catalogue of crimes on which jurors are already more or less informed, but as the judge himself expressed it, moralizing, and his charge was an intellectual feast and contained a fund of sound logic.

Judge Long began his charge with a historical narrative of the grand jury first having its prototype in the reign of King Henry VII in England, eight hundred years ago, and how from it our present system had devolved and because embodied in first American constitution. From this he referred to the duties of the grand jurors, this absolute independence in authority and how their every act should be guarded with secrecy.

There were many good things said by Judge Long to which space does not permit reference today, but more will be said of them later.

The court begins with about 140 cases on the docket, and with the new cases that will be passed on by the grand jury the outlook is for a very busy term.

SMALL FIRE.

Blaze Starts But Quickly Put Out.

Persons up early in the jail this morning, in looking out the window saw one of the buildings of the Pitt County Buggy Company, just north of the jail, on fire. It was burning on the outside beneath one of the windows on the first floor. The prisoners gave the alarm and the fire was put out before any damage of consequence was done.

Near the window where the fire was discovered in located one of the forges and is thought that cinders thrown from this through the waste hole held some live coals among them and after smouldering for some time had set fire to the weatherboarding. It was fortunate that the fire was discovered and put out so promptly.

FIRE IN AYDEN SUNDAY MORNING

FIVE STORES AND LARGE QUANTITY OF GOODS DESTROYED.

LOSS REACHES \$25,000 ONLY ABOUT ONE-THIRD INSURED

A Handsome Brick Block Will Take Place of The Burned Buildings.

Ayden, N. C. Jan. 15th, 1906.

Saturday night, or rather early Sunday morning, between the hours of 4 and 5 o'clock fire was discovered issuing from the store of S. W. Tyson on Main street. The alarm was promptly given and our citizens were as equally prompt to respond to the call. Heroic efforts were made to subdue the flames, but not until the stores of W. C. Jackson & Co., S. W. Tyson, P. S. Cannon, col., J. H. Tripp & Bro. and Horton & McLawhorn with the restaurant of A. Horton, W. H. Dew barber shop and a pressing establishment were entirely consumed.

The large stores on South side of street occupied by Quinerly Bros. and J. J. Edwards & Son barely escaped. The handsome residence of J. J. Edwards on Lee street was at all times in imminent danger, and it was by only the most strenuous efforts that these and other buildings were saved. Everybody worked, and worked faithfully. We do not think too much credit can be given C. A. Fair and Bob Morton, colored. They were in the thickest of the fight, and where the fire was hottest there they could be found and were the last to leave the scene triumphant in a duty nobly performed and a victory magnificently achieved.

Without any means at command with which to fight our people

have cause for congratulation. All seemed to vie with the other, white and colored, alike, in their efforts to do their duty. This is indeed a magnanimous people and we are glad our home is among them, and the manly courage displayed Sunday morning proves them equally brave as magnanimous.

The origin of the fire is unknown but supposed to be from fire left in a stove the previous night.

Mrs. Smith's store, \$500.

There were other damages in moving stock &c, which we cannot obtain.

The burned district will be at once replaced with a handsome brick block.

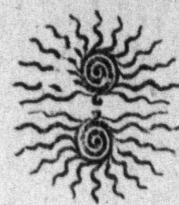

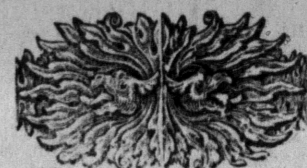

This is a great amount of money, and what it brought did nobody, any good but made only for evil. It put clothes on nobody's back and contributed nothing to the nourishment of any system. It is as if so much money had been destroyed—worse than that because it entailed misery and mischief. Certainly this Raleigh story is repeated, in exaggerated or modified form, somewhere every day, but these figures present to the mind the enormity of the liquor traffic with more than usual vividness.—Charlotte Observer.

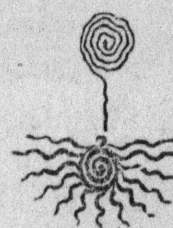

MILLIONS FOR DEFENSE.

Origin of the Legend That Was on the Old One Cent Piece.

A United States one cent piece bearing the motto, "Millions for defense, not a penny for tribute," was extensively circulated early in the last century.

One of the principal incidents that led to the adoption of this legend—which seems singularly out of place on an American coin, especially after the United States had just achieved its independence of Great Britain—occurred when the United States merchant ship Dauphin of Philadelphia was seized near the strait of Gibraltar by a warship of Algiers and her crew and passengers were thrown into Mussulman bondage to await an exorbitant ransom.

About the same time the American trading vessels Maria of Boston and Minerva of New York also were seized in the Mediterranean, and their people met a similar fate, making a total of 112 American citizens in danger of being sold into the slave markets of the east. At that time the United States was without a single ship of war or naval officers or navy yards.

The cause of this unprotected condition of the country was the strong opposition to a permanent navy as well as to a standing army, and congress resorted to the plan of paying an annual tribute to the semibarbarous powers of north Africa, so there would be no further molestation of our commerce in the Mediterranean.

Twenty-two of the prisoners were ransomed by the government for about \$60,000, while the others died in captivity or were ransomed by their friends. In a short time the annual tribute from the United States amounted to over \$1,000,000, when the "economists" in congress realized that the tribute was far exceeding the cost of maintaining a navy.

Then the cry of "Millions for defense, not a penny for tribute," was raised and did not a little toward securing the appropriation for the first group of war vessels that made the United States navy famous. These were the Constitution, United States, President, Constellation, Congress and Chesapeake.

Feeling in His Art.

The singing teacher was visiting the school, and, as this was an important event in the district, the pupils had been instructed to memorize a verse or two to recite for the entertainment of the visitor.

During the delivery of his lines one small boy was especially noticeable for the action with which he accompanied his words, so much so that the teacher, surprised at his efforts, commended him highly on the ease with which he spoke and the apparent practice which he must have put on the piece.

"It was fine," she exclaimed in closing, "and shows a large amount of rehearsal. But, Johnny, where did you get the gestures?"

"Tain't the gestures," replied the young genius, with a twist; "tain't the gestures; it's the hives." —Youth's Companion.

All the News.

A country exchange has this to say about printing all the news:

"A man stopped us on the street the other day and said we did not publish all the news. We should say not. In the first place, there's somebody else depending on us for a living. If we published all that happened we would be with the angels. In order to please the people we must print only the nice things said of them and leave the rest to gossip. Yes, it's a fact, we don't print all the news. If we did, wouldn't it be spicy reading? But it would be for one week only. The next week you would read our obituary, and there would be a new face in heaven. All the news is all right when it is about the other fellow."

The Term "Boss."

"Boss" is merely another spelling for the Dutch "baas," and Bartlett's "Dictionary of Americanisms" records that the proper pronunciation of the "o" in "boss" is like that of the "a" in "all." Originally in Dutch "baas" seems to have meant uncle, cousin or kinsman in general. Then, because the master of a house might be regarded as the principal kinsman of its inmates, the word came to be used of him. "De vrouw is de baas" is a Dutch domestic proverb—"the wife is the boss."

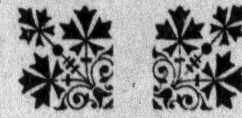

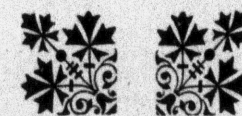
